

MEMORANDUM FOR THE DIRECTOR.

Agent in Charge Connelley called from Indianapolis and requested advice relative to interviewing the father of Dillinger. Mr. Connelley was of the opinion that this should not be done as he is of the opinion that it will result in publicity. He was instructed not to conduct this interview.

Mr. Connelley stated there was no doubt but what Dillinger was at his father's home on Sunday April 8, and that he will return. Mr. Connelley stated that he did not believe he had a sufficient number of Agents. He advised that he has ten Agents at Indianapolis, one at Muncie, two at Lebanon, one at Columbus, three at Dayton and l at Cincinnati. He said that they had located another place at Indianapolis which has to be covered and that he is of the opinion that he does not have enough Agents there and requested that he be assigned at least six additional Agents. He also requested three more machine guns and three shot guns for the use of the Agents now assigned to him and stated that in the event six more Agents were assigned to him he would desire three additional machine gums and three shot guns.

O. was not the same woman who was in the Garage with two men on April 10, 1934, saying that the woman who was there was small and would not weigh over one hundred pounds.

Stanley of the Vauxhall Apartments, 9th and Brodde way Sta, She advised that no one by the name of Osgood, Butther or Jeanings had rented any furnished rooms from her. Other apartment buildings, comprising all apartments in Nashville were checked, with negative results.

At Murfreesboro, Tenh., Free F. D. Ebernathy, Deputy Court Class Rather erford County, advised after viewing I, O. #1821 of Mary Evelyn Freehatte, with aliases, that she looked very much like the woman who on April 9, 1954 purchased 1954 Tennessee license tag #176-003 in the name of Harmon L. Osgood, which application she signed as Mrs. Harmon L. Osgood. She advised that the woman who purchased this tag had short hair that she noticed it was not a natural red as she could see in the back that she had black hair which had been dyed red, and said that the woman answered the general description of Mary Evelyn Frechette, but she did not notice a mole on the right cheek or pit scars on face, also saying she had on a short veil. Meanwhile, the man had walked to the postoffice where he was trailed by officer Cannon, who did not enter the building but observed him through the plate glass, Cannon was not able to ascertain what the man was doing, but id did not appear that he was mailing a letter. Cannon then returned to the bus station, which is only a few doors away. Shortly the reafter, the man left the postoffice and came back down the street, passing within a few feet

of Cannon who made no attempt to stoy him. Officer Cannon then telephoned headquarters and a squad was sent out to patrol the vicinity.

Henry Morris, white waiter at the cafe in the Vaion Bus Station, advised that this man came into the station about 4:50 i.M. Monley, The company has recently installed an automatic base-ball machine and the many with two or three of the bus drivers, played several games. While he was opticating this machine, it was noticed that two fingers had been amputated from his right hand. Remembering that Hamilton was similarly disfigured, they got the Identification Order from the deak and Made a bareful comparison. Morris stated that the stranger resembled Hamilton in every respect, although he was unable to verify the scar in the center of the forehead. The man was standing in from of the station when officer Cannon passed, Cannon was called in and advised of the striking similarity to Hamilton. When closely questioned as to the amputated fingers, Morris educated that he could not say positively whether they were on the right or left hand, but that he believes they were on the right.

Special Agent in Charge Werner Henni, and Assistant Director Harold Nathan, witnessed the following statement obtained from MRS. A. SALT, slice MRS. GURNIATH LADRILE:

St.Paul, Minnesota;
April 17,1934.

My name is Mrs. ASULT. I reside at 1835 Park Avenue, Minneapolis, Kinnesota. I cm a proctical nurse.

At 11:15 on the morning of March 31,1934, Dr.Clayton May same in and said he was bringing a man in. He didn't say he was wounded or anything. Then he asked me if I would get some water, elechol, and ectton to take sare of the wound. Dr.May came in the back way. I didn't see anybody watil he rapped at the door. He came in, went cut, and returned with a man, whom I afterwards learned to be JOHN DILLINGER, and a dark haired girl. They came in a dark car. I put this man in the second room, and brought water and alcohol and a pillow. The doctor took care of him. I assisted with wrapping the packs. Then I left the room and continued my dinner.

when the black haired girl, mentioned above, same to my apartment with the man now known to me as DILLINGER, she also brought a black leather bag in. They drove the ear in the garage when they arrived. As far as I know, they all came together, that is, DR.MAY, DILLINGER, and the woman, and they all entered at the rear entrance of my house. She came in (the black haired momen) then she went back and got her black bag.

We dressed the sore, and washed the blood off his lg. I didn't see anything until they got his underwear off and then I saw the wound. Bt. Me wrapped packs and put a little alcohol on it. He didn't have the wound dressed when he arrived and there was nothing on it. I guess maybe they had a towel around it but they had that off when I came in. I was present when Dr. May dressed the wound. Dr. May went away shout 11:45 or B:00 o'clock. He was there only about ten or fifteenminutes. The doctor just said, "I'll be back later" and went out the front way. He called a cab and sent away. It was a yellow cap and it took him away from the house. The doctor had his medicine hit with him at the time.

The man, now known to me as DILLINGER, remained in that room until the following Sunday when I moved him in the back room. That was on Sunday after noon.

On Satuday, the day this man arrived at my house, I took him a tray about 1:15 and then she (the black haired woman who came with him) asked if she could wash some clothing out; which she did in the bathroom; also, she did some pressing. This girl hung the man's trousers up in the closet. She wiped them off and put a damp cloth ever them and ironed them out. His trunks had blood on. She asked for some gray thread with which she darmed a couple of holes in his overcost.

I left for town, called on my dentist, and got a few groceries. Then, when I returned, I made him a tray for super. Dr.May came back on Saturday night, about 8:00 or 8:50. I do not know how he come but later on a red haired lady some in and gave me a bunch of keys. The Dr.Called her "Beth". Dr.May had returned alone in the evening and it was about ten or fifteen minutes later that the girl come (the red halfel) girl and handed me the keys. She came in, then went out and came back with the keys and told me to give them to the doctor. This girl was a tall, alim girl with suburn hair. She didn't have glasses on theme: The girl with auburn hair (who is the girl referred to above as having red hair and who handed me the keys) came to my door and reng my door bell and said, "Is there a dark baired girl here by the name of "FRID IE", and I said, there is a dark haired girl here but I don't know her name. The girl with black hair called, "Come on in, Buth". About ten minutes later a fellow come in. This fellow said, "I am a friend of Doc's, I'm Green". I went out and was gone for about an hour and then came home and went to bed. DR.KAY came about 8:00 or 8:50 Sunday night. He one else seme. There were no calls during the day. They never used the telephone.

On Monday night about 7:45 o'clock I received \$100.00, all in \$5.00 bills, which were damp, from Mr.Dillinger. I didn't know who he was then. He said, "This is for your services".

On Tuesday marning, at 1:50 my son come home and told me that men resembled Mr.Dillinger. He said, "Nother, that men resembles Mr.Dillinger, is that him?" I said, "No, I don't think me. I don't know".

Dr. May same about 8:30 and stayed until 10:00 Tuesday night. Them the Doctor same in on Tuesday night, I said, "That's Kr. Dillinger" and he said, "Sure, did't you know", and I said, "No",

About 10:30 Tuesday night I heard a report over the radio that Mr. Grean was shot over in St.Paul. I didn't get the street until the morning paper eams out. Nothing was said in my apartment about that. The radio said. "One of the Dillinger gangsters". The next morning I got a paper and read that he had been shot over in St.Paul and I saw the pictures and was positive then that the man in my apartment was Dillinger.

Dillinger didn't tell me until about 11:00 o'clock Tuesday night that he was leaving. About 11:00 o'clock the dark baired girl asked if she could have some hot water and I light the tank and she had some hot water and then he said. "We are leaving temperow". Then he shaved and had his dinner """ and he left around 6:00 o'clock Wednesday evening, April 4,1934. When he left, he gave me \$10,00. He dressed and went out and she drove the car and they went off. They drove the ear out andwant up to Portland Avenue, driving away in the some car in which they arrived. She carried a black gladstone bag out and he sarried some kind of a paper in his hand; it was round and pink. It was about 🖃 two inches thick and about as large authat (demonstrating, which is about the size of a small plate). That's all I saw, He carried that in his right hand and he had his left hand on his left hip. The man, whom I now believe to be DILLINGER, was suffering from a gunshot wound in the upper left limb, Dillinger went out in the same clothes he same in, which was a gray suit. He had a light steel gray overcoat, mixed. It was a hard finish material. So had a light gray hat with a gray band; it was a soft felt hat, and black exfords, the hand

The fark haired girl had a blue dress and a blue hat and a blue coat.

It was a long coat. She was dark, with high sheek bones, mellow complexion, and she had gold fillings in her teeth and her hair was very coarse. She had a permanent wave but the wave was not set well. Her hair was black, not real black, but dark, I thought there was some Indian in her because of the high check bones. She was about 5'4", or 5' tall. She was perhaps a little taller than I am, and I am 5'4". I believe she was about 5'2" in her stocking feet.

Doctor May was not there on Wednesday. There was nobody there on Wednesday. They never used the phone at all. Since Wednesday, I continued on with my work and made a few professional calls. People called me asking if I would come out and take care of them. These patients were Dr. Kay's. I didn't hear from the Doctor. The girl at the office called several times. I went

with Dr.May on Thursday. I didn't see him watil Saturday. Dr.May called me down to the office about 11:30. Dr.May brought a girl in and taked me if I knew her and he wanted to know if I would assist in taking care of her and I said I would. This was a girl different from these parties. She lived ever Northeast. This was on Saturday, April 7,1934. The doctor them told me to get an apartment and I remted an apartment at about 1:30 and me moved in there about 5:50 Saturday afternoom. I saked this girl if she had a place to stay and she said, "No". I asked her if she had some friends to stay with and against and she could stay there, at 131 East 14th Street.

Dr. May said that maybe the girl, who had been taken into sustody, the meaning the auburn haired girl referred to previously, will say momething and we better move for a while. This was the girl whom he called Both. I said, alright, and I went and got the other apartment.

Dr. May called on the telephone about moon, Wednesday, April 4,1934, and asked how the patient was and I told him that he was leaving.

I have worked off and on for Dr. May for the last three years. I have also worked for Dr. Line and Dr. Olson. I haven't had many cases. I went on several calls but I dilt have many people at the house because I had my teeth pulled. Since January 1,1934, I took care of about ten or fifteen abortion cases. At the present time, I have a girl at 131 East 14th Street for the same purpose. She came last night. She is a patient of Dr. Glinton May. The girl gave me her name as a last lath Street.

I have made the above statement and I have read same and find that it is sorrect and true and that they are my own statements made of my own free will and accord without threats, or promises, of any sort having bee made, and having been made to, and in the presence of, Werner Hanni, whom I know to be a special Agent of the Division of Investigation, U.S.Departmentof Justice.

She btated that she had left her home in Shelty, North Carelina, about three years ago and had come to Minneapolis and had studied in a school to equip herself as a laboratory assistant, and after graduation the refused to obey her mother's instructions that she proceed to her home town, the she meantime, her sweatheart in Shelby had got married to someone else and as a matter of pride, she refused to go home. She felt that with her training she would be able to obtain and hold a position with DR. MAY, and she did secure this position, working for only a few hours each day at a salary of \$15.08 Week. Her apartment resual is \$27.50 per month, which is shared by her room mate.

MAY'S office on a few obtasions but she had always entered the back floor and conferred exclusively with DR. MAY. "It must be a voteren who has be drinking". Dr. Ney did not show my unusual indication of fright or alon over this incident. To my knowledge, this is the only incident in the past thirty days which could in any way be interpreted as a threat again Dr. May.

For about the past twelve days preceding this date, April 18, 1934, Dr. Clayton X. May has not been at his effice and it had been his quaton, during the course of my employment with Dr. May, for him to call daily at his office except for considerably shorter intervals; and furing his recent absence from the effice, I have received from him telephone calls inquiring as to who had called at the office for him. Agent in Charge Purvis telephoned and advised that he had just received a call from Agent Meekins in Detroit to the effect that the Sheriff at Saulte St. Marie, Michigan, advised him that Dillinger and Hamilton visited the sister of Hamilton at 11:45 night before last at Saulte St. Marie; that the Sheriff's information is that Hamilton has a brother and sister living there; that the Sheriff is of the opinion that theinformation is reliable; that the Sheriff stated that a boy came to the door of the Sheriff's informant and told him to come to a certain address; that the man went to the address and came back and stated that Hamilton looked very bad; that he has some sort of a bullet wound in his chest which causes him to make a noise when he breathes. The Sheriff is of the opinion that Dillinger and Hamilton are there now. Mr. Purvis stated that he could charter a plane for a cost of \$200.00 to send five Agents there; that the plane will wait 24 hours to bring them back at this price, and that he would immediately send five Agents there on this plane, which arrives there at noon tomorrow. Mr. Purvis stated that he did not believe that seven men. including the five Agents, the Sheriff and one Deputy, could take care of surrounding the house and entering same. He was instructed to send his five Agents there and have them contact the Sheriff and his Deputy. look over the situation to see if they could handle it without more assistance and to advise him. He will do this and advise the Division as soon as he hears from the Agents.

16, 1934 had rented Apartment #106 in the Senate Apartment Detterbeds stated that the day this apartment was rented she, and Dotterbeak, was sick in bed having broken her leg about Thankagivi 1933 and that her mother, Mrs. Dolly Detterbeck, had arranged for the rental of the apartment. Miss Detterbeck stated that Mrs. Makeley had introduced herself stating that she wanted to rembia furnished apartment for approximately one month; that she and in Makeley expected to be connected with the Jones-O'Neal Shoe Store in Topeka, Kansas but were not sure that they would make a connection at that place. Miss Detterbeck stated that her mother brought Mrs. Makeley to the bedroom and introduced her; that Mrs. Makeley paid \$65.00 each for one month's rent in advance. Miss Detterbeck stated that this is the only time she saw Mrs. Makeley and that she never, saw Mr. Makeley at all. The Dolly Detterbook stated that upon taking Mrs. Makeley to Apartment #106 Mr. Makeley immediately brought the bags in from a car and that this is the only time that she bay Mr. Makeley. Both Miss and Mrs. Dolly Detterbeck described Mrs. Makeley as being about thirty five to forty years of age, dails hair, rather stout, medium height and fairly well dressed. They stated that they paid no particular attention to the color of her hair or eyes or any marks or scars and that there was nothing about the appearance of Mrs. Makeley that aroused their suspicion. Mrs. Detterbeck stated that Mr. Makeley was a man of medium height, rather stocky and had a round face and had dark hair. She stated she pald no particular attention to Mr. Makeley at the time and saw him just on the one occasion. Miss Detterbeck informed igent that 13 is her belief that Mr. and Mrs. Makeley stayed in the apartment between two and three weeks, however, due to the fact that she was ill at the time she would not be positive. She further stated that one door key and the mail box key had been taken by Mr. and Mrs. Makeley. By referring to her record of keys, Mas Detterbeck informed that the door key 14 a Yale key bearing #70088 or the letters T C S and that the mail box. key is a flat Eagle Lock Company key bearing #76DR68. His Detterbed referred Agent to Henry Warden, colored janitor, in the Senate Apartmen

Henry Warden was interviewed by Agent without Agent revealing his identity, Agent marely stating that Miss Detterbeck had referred.

Agent to him. Henry Warden stated that he recalls Mr. and Mrs. Makeley having moved in Apartment \$106 and that at the time they moved in the kitchen sink was stopped up. He stated that he went to the apartment to repair the sink a day or two after they had moved in and that at the time he noticed that the windows were very dirty, informing Mrs. Makeley he would return in the afternoon and wash the windows to which she replied "you had better come back tomorrow".

warden stated that upon his return to the apartment the following gay to glean the windows he discovered that the apartment was vacan noticing that there were no clothes in any of the ipoms. Warden stated that he had seen a Buick 1932 or 1933 model, Early green is color, with a large trunk in back, license plates not noticed, and had seen Mr. Makeley driving this car. He further stated that he had seen two couples enter the apartment, one couple being recognize as Mr. and Mrs. Makeley, this being in the evening at which time. the hallways were rather dark. Warden stated that he doubts very much that he could identify any photographs as he did not see the people very close. When questioned concerning the apartment after its vacancy, Warden stated that the only thing left in the apartment was some food and a few newspapers from other cities. . Parden distinctly recalled that there were newspapers from Chicago and Denver, the ether cities not being remembered. Henry Warden further informed Agent that about a week after the Makeleys had moved he obtained a key to the mail box and opened it finding a letter addressed to Mr. and Mrs. J. S. Makeley and that having no forwarding address, had returned the letter to the carrier.

At the Topeka, Kanses Post Office, Mr. Hook, Assistant Superintendent of Mails, caused a search to be made of the dead latters and general delivery, which search failed to locate this letter. Mr. Hook informed that if a letter has a return address it is returned to the sander and if not, is placed in the general delivery for a period of thirty days and if uncelled for at that time is placed in the dead letter files and later opened. If a letter contains nothing of value it is destroyed and if it contains valuables, is forwarded to the dead letter office at Washington. The Post Office Department records do not indicate that any letter was forwarded to

During the course of conversation with Miss Detterbeck she stated that she had not called the Jones-O'Neel Shoe Store to check up as she was ill and that this is the only reference given by Mr. and Mrs. Makeley. During the course of conversation Miss Detterbeck inquired of Agent whether Mr. and Mrs. Makeley were in any way connected with Dillinger. When asked why she had asked this question, Miss Detterbeck stated that she had read in the newspapers various accounts of how criminals had rented apartments in the best localities and due to the fact Mr. and Mrs. Makeley had left without giving any notice to any one, she had wondered if they were criminals. Agent replied that he did not know but had been merely requested to ascertain all of the facts about the occupants. Miss Detterbeck requested Agent not to interview the various tenants in apartments adjacent to #106 as she is afraid that if information regarding in-

quiries made by the Department of Justice would sirculate among per tenants some would move. Miss Destarbeek was assured that he information would be given out regarding this interview and the likewise requested to keep the interview confidential to which the replied "I certainly will".

He stated that in addition to himself there were only two employees, here Jones and a Mr. Burger.

In view of the fact that the photograph of subject trees contained in the Kansas City file is a photograph taken approximately ten years ago, same was not taken to Topeka to display to parties interviewed.

In conference with a representative of the Coroner's office, Mr. Nathan observed that in addition to some police officers who were not present on the occasion of the shooting of Eddie Green by Special Agents of the Division, there were also included on the list the names of Mrs. A. W. Copley, 780 Rondo Street, and Mr. F. G. Stroth, 785 Rondo Street, St. Paul, who had been subpoensed to appear before the Coroner's Jury at the inquest.

Re:

In company with Special Agent in Charge Werner Hanni, I interviewed Mrs. A. W. Copley, a white woman, at 780 Rondo Street. She stated that just before the shooting occurred, she was sitting on a couch in her dining room, looking out the window. She lives directly across Avon Street from the residence of Leonia Goodman at 778 Rondo Street. She stated that her attention was first invited to a nice looking automobile which drove up along side of her house and stopped. She saw a man get out of this car, leaving a woman seated in the car. This man started to cross the street rather hurriedly, and although she would not state that he was running, he at least was walking fast. He proceeded directly to the home of the Negroes at 778 Rondo and placed his hand on the door knob of the enclosed porch. She stated that she was disgusted to see a white man go into a Negro's home and she recalls distinctly that she dropped her eyes and saw nothing further of this man at the time after he placed his hand on the door knob on the outside door. Before looking out the window again, she heard a shot fired. She believed that there were four shots fired, all told. first looked up and saw the woman in the automobile and the woman was evidently quite nervous and first looked back through the back window of the sutomobile, then fidgeted around in the car momentarily, and then got out of the car and started to cross the street. Mrs. Copley then looked across the street and saw that a man had fallen on the boulevard and she saw his hat rolling. She did not see him from the time he first touched the door knob on the outside of the Negro's house until she again saw the man lying on the boulevard. She heard some shots COPIES DESTROYED

windows were closed and she heard no outside noises except the shots, she believes four in number. She could not state whether the man who was shot had entered the house or whether he had turned around after touching the door knob. She did not see anyone do any actual firing, although she recalls seeing one man on the corner with a gun in his hand. She stated that her two daughters and her husband did not see the shooting, although a younger daughter, ? or 8 years old, saw a man on the outside with a gun, and she was frightened.

On April 18, 1934, Inspector W. A. Rorer interviewed Mr. and Mrs. F. G. Stroth at their home, 785 Rondo Street, St. Paul, Minnesota, Mrs. Stroth stated that she knew nothing concerning the shooting of Edward Green and that she was in the rear of her home and was called to the window by her husband after the shooting; that she did not leave the house but merely looked out of the window, which was a minute or two after the shooting occurred.

F. G. Stroth stated that at about 6:00 p.m., on April 5, 1934, he was sitting in his home, near the window, listening to a radio program, when he looked out the window and saw a closed automobile stop on Rondo Street on the opposite side of the street from the house occupied by Leonia Goodman, colored. He stated that he saw a man get out of this car and start walking across the street in the direction of the Goodman home, but that he took his eyes off this man when the man was about half way across the street and paid no more attention to him but began listening to his radio. He stated that a few minutes later, he heard a noise which he thought was the back fire of an automobile; that he immediately looked out the window again and the first thing he saw was a man coming out of the Goodman house with what looked like a rifle, and the thought occurred to him that perhaps the man was a police officer who had been called to shoot a dog which he had known to be vicious, and in that neighborhood. He stated that he then saw a woman get out of the car across the street, from which car he had previously seen the above mentioned man get out, and that he watched her cross the street in the direction of the Goodman house, and when she reached the sidewalk beside the Goodman house, he noticed that a man was lying on the ground and the woman knelt down and took his head in her lap; that by this time, several men had reached the man on the ground but that he did not see from where they came.

Mr. Stroth further stated that the windows and doors of his house were closed at the time and he was very interested in his radio, which was fairly loud, and consequently he could not have heard any voices outside of his house at that time. He stated that he heard only one or two shots,

which sounded like the back fire of an automobile or a rifle, and that the sound did not appear to him to be that of a shot gun.

With reference to the Ford Coupe attomobile and Hudson Sedan automobile involved in the JOHN DILLINGER escapade at St. Paul, Minnesota, please be advised that copy of the petitions, affidavits and order of Federal Sudge Wilkerson in connection with the Ford at Chicago, which, through an order by Judge Wilkerson, was turned over to the Division, have been furnished this office, examined and discussed with the United States Attorney at St. Paul, Minnesota.

It will be noted that that order merely orders the Department of Justice to turn said car over to the Division of Investigation for official purposes. It would appear therefrom that said car was in the custody of the United States Marshal and on court order was released to the Division of Investigation at Chicago.

In the two cars involved here in St. Paul, please be advised that there does not appear to exist any legal means making it possible for this Division to acquire and obtain title for these cars for official use. About the only possibility remaining is that the cars be placed in storage, this Division paying the storage until the rightful owners appear therefor to claim these cars, at which time storage charges can be collected prior to release. After having been placed in storage for a period of thirty days or more, the cars could be advertised for sale.

You will understand that these cars were purchased and licensed in the State of Minnesota under fictitious names, therefore, no owner with names as licensed could claim these cars. I have in mind to overcome all these difficulties by merely proceeding to obtain tax exempt licenses for these cars and operate them

as ownership cars of the Division of Investigation for official purposes

and if the Division approves, this step will be undertaken. For that purpose, I enclose application blanks prepared by me for your examination. If these cars are so licensed and operated, the only recourse the owner would have would be to come into court and claim these cars, at which time it could be shown that the owners of said cars, as far as the records of registration are concerned, are non-existing individuals and the person representing to be such owner would be compelled to appear in court and show that he purchased and licensed the vehicle under assumed name. This, of course, would require the personal appearance of two fugitives from justice. Possibly these alleged owners could transfer and claim ownership of the cars by introducing depositions in court that they are the owners of said cars and that they used fictitious names in purchasing and operating the vehicle and whoever then would bring such deposition, of course, would be then liable to inquiry for a possible charge of harboring a fugitive from justice.

These two automobiles are presently in storage at the St. Paul Police garage where they are being held for this Division. It is not probable that the present owners of these cars will ever make appearance for claiming that property, but of course, there is a possibility that they may assign title to some legal representative who then would have an action to recover.

I do not believe in any attempt on the part of any of the owners of these two cars to reclaim them, and I doubt very much if any legal representative will undertake to gain possession of these cars, and I believe that if the enclosed application for tax exempt licenses are approved by the Division and approved by the Minnesota Highway Department, the cars may be put in operation on official business by Agents of the Division of Investigation, and little difficulty, if any, may be expected to be encountered thereafter.

As far as acquiring these automobiles for the Division by any legal machinery, there does not appear to exist a provision in the law.

Please return the enclosed forms with whatever recommendation to be made in this matter.

RE: CONFISCATION OF AUTOMOBILES BELONGING TO GANGSTERS.

Reference is made to my telephone conversation with Mr. Tolson, wherein I advised that Mr. Hanni had conferred with the United States Attorney, who advised that there was no legality to the order of the judge in Chicago giving title to an automobile formerly belonging to VERNEMILIER to the Division.

The action was taken, it appears, to clear the records, as the car had been seized by the United States Marshal, and the judge's order authorizing delivery of this automobile to the Division of Investigation, was authorization for the United States Marshal to turn the car over to the Chicago office of this Divisiona

As to the cars in St.Paul, they have never been in the custody of the United States Marshal, therefore the court would be without jurisdiction to order an agency of the Department of Justice to turn them over to another agency of the same department.

. It is my understanding, from my conversation with Mr. Hammi during the course of my telephonic conversation with Mr. Calley and later with Mr. Tolson, that some sort of written declaration would have to be prepared for the Division to acquire these cars. My subsequent conversation with Mr. Henni, however, failed to verify the requirement for a formal notice to be filed either in the Federal Court or with the State Automobile Registration authorities.

Mr. Hami is explaining the procedure whereby the Division might, at least until its title is contested, acquir

possession of these cars. Of course, there is now a claim against these automobiles, which has been filed by MRSA COFFEY, owner of the apartment on Lexington Avenue, due to damages resulting in a gun fight in that apartment. It will be necessary to liquidate this claim in order for the Division to get uncontested possession. Of course there will always arise the possibility of someone contesting the title, but the probabilities of this seem quite remote, as explained in the enclosed letter of Mr. Hami.





MEMORANDUM FOR THE DIRECTOR

MR. NATHAN.. MR. TOLSON .. MR. CLEGG....

I talked with Mr. Clegg this morning at St. Paul concerning the advisability of having the Coroner's inquest in the Green shooting case as soon as possible. He stated that there was no adverse publicity being given to the postponement; that as a matter of fact publicity of all kinds was quietening down considerably and that about the only comment that had been made concerning the same was made by an attorney in an address before a lawyers! club the other day in which he stated that he had noted in the newspapers that there was some concern over the fact that a gangster was shot down, probably from the back. He stated "The citizens of St. Paul never complain when a mad dog is shot down, and after all a criminal and a mad dog are in the same category". Mr. Clegg stated that he thought if the inquest was not held until May 2, the date at which it is now set it would be given very little consideration and it would probably be a mere formality; that there was a possibility that there would not even be one. He stated that in connection with the bewspaper reporter named Thompson, who seemed to be sponsoring the inquest, they had considerable information concerning him which connected him with the underworld of St. Paul and that he owed a number of them money; that he believed, if necessary, they could bring pressure to bear to prevent any adverse publicity on his part.

Concerning the prepared statement of Mr. Hanni, Mr. Clegg stated that a revised statement had been prepared which would be much more satisfactory and would be sent to the Division immediately; that in his opinion a prepared statement should be made rather than to testify extemporaneously. Mr. Clegg was of the opinion that the names of the Agents who participated in the raid should not be disclosed for the reason that if their names were disclosed they would undoubtedly be subpoenaed; that if they are subpoenaed it would be a simple matter for the inquest to determine who actually shot Green and that he believed this would be undesirable and probably have some affect on Agents' activities in the future, in that many of them would not care for such publicity. which would follow. Mr. Clegg stated that the United States Attorney in St. Paul, who was formerly a County Attorney, is in favor of a prepared statement and has also stated that in his opinion the Division cannot be forced to submit the names of Agents participating in the raid; that the sole purpose of such an inquiry is to determine the cause of death and that such purpose will be fully served by Mr. Hanni's presentment of the prepared statement.
