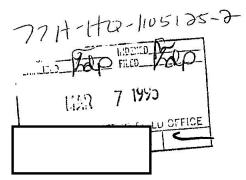

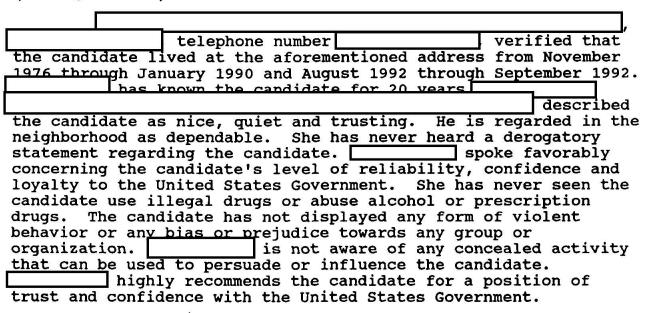

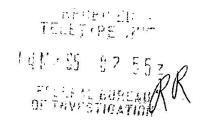

Candidate's response to each question should cover entire adult life (SINCE AGE 18); FD-302 SHOULD INCLUDE A STATEMENT TO THAT EFFECT. If candidate is young (under 21), responses should cover a logical period of time (e.g. past five years). It is also pointed out that Question 23 on the SF-86 pertaining to "Police Record" covers activities since the 16th birthday. Obtain full details of positive responses and set appropriate leads via teletype.

During candidate interview, determine name and address of candidate's therapist. Set appropriate lead.

NEW YORK: Verify candidate's date/place of birth through BVS records.

<u>ALL OFFICES</u>: Check DMV records for residences of past five years.

Check U. S. Attorney's Office records to cover all areas of residence, education and employments.

<u>BALTIMORE/WMFO/DETROIT</u>: Verify state bar membership to include date of admission, current status, and complaint/grievance information.

WMFO: Check appropriate Security/IG records. Verify candidate's OPF.
