
EXPLANATION OF EXEMPTIONS

S&C believes that someone was trying to intercept the misdirected E-Mails, about the mergers and acquisitions, in an attempt to get insider information on Wall Street activity. were removed, by GoDaddy.com, around 08/08/2008.
