## **EXPLANATION OF EXEMPTIONS**

### **SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552**

- (b)(1) (A) specifically authorized under criteria established by an Executive order to be kept secret in the interest of national defense or foreign policy and (B) are in fact properly classified to such Executive order;
- (b)(2) related solely to the internal personnel rules and practices of an agency;
- (b)(3) specifically exempted from disclosure by statute (other than section 552b of this title), provided that such statute (A) requires that the matters be withheld from the public in such a manner as to leave no discretion on issue, or (B) establishes particular criteria for withholding or refers to particular types of matters to be withheld;
- (b)(4) trade secrets and commercial or financial information obtained from a person and privileged or confidential;
- (b)(5) inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency;

- (b)(7) records or information compiled for law enforcement purposes, but only to the extent that the production of such law enforcement records or information ( A ) could reasonably be expected to interfere with enforcement proceedings, ( B ) would deprive a person of a right to a fair trial or an impartial adjudication, ( C ) could reasonably be expected to constitute an unwarranted invasion of personal privacy, ( D ) could reasonably be expected to disclose the identity of confidential source, including a State, local, or foreign agency or authority or any private institution which furnished information on a confidential basis, and, in the case of record or information compiled by a criminal law enforcement authority in the course of a criminal investigation, or by an agency conducting a lawful national security intelligence investigation, information furnished by a confidential source, ( E ) would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions if such disclosure could reasonably be expected to risk circumvention of the law, or ( F ) could reasonably be expected to endanger the life or physical safety of any individual;
- (b)(8) contained in or related to examination, operating, or condition reports prepared by, on behalf of, or for the use of an agency responsible for the regulation or supervision of financial institutions; or
- (b)(9) geological and geophysical information and data, including maps, concerning wells.

- (d)(5) information compiled in reasonable anticipation of a civil action proceeding;

- (k)(2) investigatory material compiled for law enforcement purposes, other than criminal, which did not result in loss of a right, benefit or privilege under Federal programs, or which would identify a source who furnished information pursuant to a promise that his/her identity would be held in confidence;
- (k)(3) material maintained in connection with providing protective services to the President of the United States or any other individual pursuant to the authority of Title 18, United States Code, Section 3056;
- (k)(4) required by statute to be maintained and used solely as statistical records;
- (k)(5) investigatory material compiled solely for the purpose of determining suitability, eligibility, or qualifications for Federal civilian employment or for access to classified information, the disclosure of which would reveal the identity of the person who furnished information pursuant to a promise that his/her identity would be held in confidence;
- (k)(6) testing or examination material used to determine individual qualifications for appointment or promotion in Federal Government service the release of which would compromise the testing or examination process;
- (k)(7) material used to determine potential for promotion in the armed services, the disclosure of which would reveal the identity of the person who furnished the material pursuant to a promise that his/her identity would be held in confidence.

Mr. James L. Browning has furnished to the FBI, San Francisco, two threatening communications, copies of which follow, from apparently the same individual in Belgium. Mr. Browning received two previous communications prior to the following communications, which vehemently attacked Browning for his role in the prosecution of Patricia Campbell Hearst for bank robbery.

Mr. Browning's concern became more serious upon receipt of the August 31, 1976, communication, wherein the writer threatens to "come to San Francisco to knife you down in front of your dear family."

More recently, on December 17, 1976, United States Attorney Browning received a post card from apparently the same individual, again criticizing Browning vehemently and pointing out to Browning that the judge who presided over the prosecution of Patricia Hearst was now dead.

The following are Xerox copies of the communications received by United States Attorney Browning.

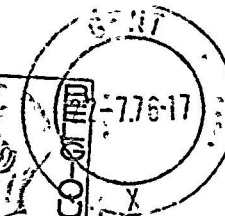

We are greater enemies of terrorists and terrorism than you are Mr. James. We despise the SLA, the kidnappers of the school-bus with the 26 schoolchildren, the kidnappers of the Belgian girl Miss Chantal, the kidnappers of Entebbe, etc. but we are no enemies of P. Hearst because she was no terrorist but only a victim of terrorism, an act of terrorism that you allowed to happen as well as the paying out of the 2 million dollar ransom (though here you made reservations). We know, in your Prosecutor's eyes, and in the eyes of the FBI (=criminal actions of the CIA), Patty, the happy daughter of a millionaire, was kidnapped by her own free will. Not to know that it wasn't by her own free will was the reason why P. Hearst's trial did not start at the beginning but fully astoundingly right in the middle. Yes, indeed, the trial about Patty's bankrobbery was not only the trial of the falsely interpreted facts, it was also the trial of the missed-out facts, the facts which clearly spoke in favour, without any doubt in favour of P. Hearst. Not only did you miss out the beginning but also the other facts such as the use of the wig and the heavy coat (to make her unrecognizable) which stood quite in contrast to the aim of the other SLA robbers), the tea-cups used to mix the drugs, etc. Misinterpreted facts: the monkey was a trophy won over her enemies, the shot-gun was a means to keep the kidnappers away from her, etc. Yes, P. Hearst wasn't kidnapped once, but twice and even three times: once by the SLA (you say out of her own free will), once by the FBI and once by the magistrates of your famous Court. In the same way she was not only brainwashed once, but several times, and not only brainwashed but - in the form of that harsh sentence - deathwashed. She was deathwashed by you, by the 12 stupid and dishonest members of the jury, and by Judge Oliver Carter, now himself deathwashed (a clear punishment by the Super-Judge, ah, ah.) A perfect maximum of 35 years was not only a sort of death penalty but it was also a kind of unicum, a unicum just as Nadia Comaneci's performance at the asymetric bars was a unicum (10 marks out of 10, a result never achieved before - and so it was with that P. verdict) Mercenaries in Angola, dissidents in Russia, etc. are and were protected by your lawyers (freely), your official declarations, your government press, etc. but your own Patricia Hearst had to be massacred in front of the whole world, 70% of whom judge her innocent. Well, if you want Patricia to be massacred, we, the western world, want the rest of America to be massacred. Signed a group of people including Peter Are, Gerald Aischap, Paul Boon (noble prizewinning candida

Enclosed for the Bureau are six copies of an LHM suitable for dissemination through Legat, Paris.

The Bureau is requested to direct Legat, Paris, to ascertain through appropriate channels the identity of the sender of the threatening communications, which have been made part of the enclosed LHM. Originals of these communications have been submitted by separate communication to the laboratory to be searched through the anonymous letter file. No request for latent fingerprint analysis is being made at this time but will be made at such time as any suspect is developed.

Mr. BROWNING has indicated that prosecution of the Subject in the United States is unlikely due to the apparent emotional instability evident in the letter. However, Mr. BROWNING fears for his personal safety, arising from threats made in the communications, which have led him to request that some border alert or stop be placed so that he could be notified if and when UNSUB enters the United States.

In view of this, San Francisco is no longer considering [redacted] as a suspect.

On 5/16/77, investigation regarding [redacted] was orally discussed with AUSA [redacted] San Francisco. [redacted] advised that letter apparently written by [redacted] did not contain a threat; and, therefore, no interview of [redacted] should be undertaken. This phase of this investigation is being discontinued.

AUSA [redacted] did express USA BROWNING's continuing concern regarding the author of the other letters in this matter and desires continued effort to identify the UNSUB.

Dr. WOLFE has never heard of a group claiming to be members of the Eastern Region Emmaus, Symbionese Liberation Army. Dr. WOLFE stated that he has never been contacted by anyone from the Symbionese Liberation Army voicing support for the Symbionese Liberation Army or his son, WILLIE.

Dr. WOLFE advised that in the summer of 1974, while appearing on the Long John Silver radio show in New York City, he received a telephone call on the air from a male indicating that he was a member of the Symbionese Liberation Army. Dr. WOLFE does not believe there is any connection between this telephone call and the letters. Approximately two years ago, Dr. WOLFE received a postcard saying "You are not alone".
