On 6/24/91, at approximately 6:00 AM, and after being advised of the identity of the interviewing Agent and the purpose of the interview, Maryland State Police (MSP) Trooper [redacted] Glen Burnie Barracks, 6800 Aviation Boulevard, Glen Burnie, Maryland 21061, (301) 761-5130, home address [redacted] was interviewed at the Baltimore FBI Office.

Trooper [redacted] stated that on 2/1/91, at approximately 11:30 PM, she responded to the northbound lanes of I-295, near the I-195 Exit, to investigate an accident. [redacted] advised that several other MSP Troopers and a fire truck were attending to a vehicle fire that was in close proximity and a contributing factor to the accident she had been dispatched to handle.

An individual that [redacted] believed was an off-duty Anne Arundel County Police Officer approached her and identified one of the drivers involved in the accident as being an armed FBI Special Agent. Trooper [redacted] stated that she believed the police officer told her this as a matter of safety, not in an effort to exert any influence over her assessment of which driver was at fault in the accident. [redacted] identified the FBI Special Agent as JOHN PATRICK O'NEILL, and the driver of the other involved vehicle as [redacted]. There was a female passenger in [redacted] vehicle who was not interviewed by Trooper [redacted] as [redacted] stated she was not injured. [redacted] stated that during the entire time that [redacted] O'NEILL and she were together, O'NEILL never mentioned to her that he was an FBI Special Agent. To the best of [redacted] recollection, [redacted] was never told, nor did he mention on the scene, that he was aware of O'NEILL's official position.

According to Trooper [redacted] she conducted her investigation of the accident, issuing a citation to [redacted] for unsafe lane change, causing an accident. This charge, according to [redacted] was based on the physical evidence at the scene, as well as O'NEILL's statement and admissions provided to her by [redacted].

The next contact [redacted] had with O'NEILL was on 6/5/91 in Glen Burnie District Court, when the case was presented to Judge [redacted]

MARTHA RAISEN. [REDACTED] stated that no States Attorney was on hand to present the case for the State of Maryland, but that [REDACTED] had a private defense attorney. Trooper [REDACTED] advised that without a States Attorney to protect the State's interest, [REDACTED] attorney, through objection and guile, prevented her from clearly presenting her case, resulting in a Not Guilty verdict for [REDACTED]. [REDACTED] also noted that the female passenger in [REDACTED] vehicle was in court on that date and was now claiming a neck injury.

Trooper [REDACTED] could provide no other pertinent information.

I have been advised that the interview pertains to
an allegation of the misuse of official position during the
course of an automobile accident investigation.

I have been provided an FD-645, "Warning And
Assurance To Employee Required To Provide Information" form. I
have read this form and I understand my rights as indicated on
this form.

I entered on duty with the FBI in a support position
on 6/22/70 and as a Special Agent on 7/6/76. I am currently the
Unit Chief of the Government Fraud Unit of the Criminal
Investigative Division at FBIHQ.

Approximately 11:15 p.m. on 2/1/91, I was traveling
northbound on Interstate 295 in Maryland in a personally owned
automobile. I was driving in the outside lane and was about to
pass an automobile that was in the inside lane, when the same
vehicle pulled into my lane, striking my vehicle in the right
front side of my automobile. As I pulled over after being struck
by this automobile, I noticed that another automobile was in the
southbound lanes of I-295 and was on fire. This automobile fire
was unrelated to this automobile accident. *no*

I decided to park my vehicle away from the automobile that was on fire because of a concern that it might explode. I parked my vehicle approximately 75 to 100 yards away from the burning vehicle and walked back to the location where the car that had struck my vehicle was stopped. I asked the driver of the vehicle that struck me if he was o.k. and I determined his name to be

[redacted] He did not indicate he had any injuries. There was some damage to his left rear wheel area.

A short time later, I observed an Anne Arundel County, Maryland police officer who I believed to be a canine officer. This officer was white male in his late 20s or early 30s. The officer advised he would not be conducting an investigation of the accident in view of the fact it was the responsibility of the Maryland State Police and he advised that a Maryland State Police trooper was enroute to the accident.

When I was assigned to the Baltimore Division, I lectured a number of years at the Anne Arundel County police academy and as a result, had an opportunity to meet a large percentage of the Anne Arundel County police trainees. While having casual conversation prior to the arrival of the Maryland State Trooper, I asked the Anne Arundel County police officer when he had graduated from the police academy. The officer was curious about my question and I told him that I was an FBI agent and that I formerly lectured at the police academy. I do not recall showing this officer my official identification. [redacted]

[redacted] was within hearing distance during the course of my [redacted]

conversation with the Anne Arundel County police officer and [redacted] made some comment about my being an FBI agent which I do not recall exactly what he said. My brief discussion with the Anne Arundel police officer was casual and in no way was it an effort to influence an investigation. Furthermore, I would like to reiterate that this police officer was not even involved in conducting an accident investigation.

Subsequently, a Maryland State Police Trooper by the name of [redacted] arrived at the scene to conduct an investigation. I believe the vehicle was still on fire at the time of her arrival but another Maryland State Trooper was involved in dealing with the vehicle fire. I can't recall for sure if Trooper [redacted] looked at the damage on my vehicle. I do recall getting into the front seat of her automobile while [redacted] sat in the back seat of her automobile. [redacted] and I exchanged information concerning insurance companies.

At the time, I was wearing a weapon in an ankle holster and it's possible that I may have identified myself to Trooper [redacted] as an FBI agent but I do not specifically recall making the statement. In view of the fact that I was armed and sitting in the front seat of her vehicle and in view of the possibility my weapon could have been seen, it is possible that I advised her that I was an FBI agent. Trooper [redacted] gave me a business card with information written on the back concerning

[redacted] I do recall that [redacted] at one point, became rather belligerent with Trooper [redacted] and she assured him that she knew [redacted]

How to conduct accident investigations. She subsequently cited [redacted] with Section 21 sub 309 par b.

I responded to Trooper [redacted] questions and I did not say or do anything which would influence the outcome of the accident investigation.

I have read this statement consisting of this and three (3) other pages and it is true and correct.

Re conversation of writer and ASAC RIVERA on 2/4/91.

On 2/3/91, while serving as Weekend Duty Agent on the 8:00 AM to 4:00 PM shift, writer received a telephone call from [redacted] telephone number [redacted] (Beeper/Pager Number [redacted]) advised that he [redacted]

[redacted] began his conversation by inquiring as to whether an individual named JOHN PATRICK O'NEILL is "really" an FBI Agent. Writer did not acknowledge any correlation between one JOHN PATRICK O'NEILL and the FBI for security reasons, but instead asked [redacted] for the nature of his complaint. [redacted] advised as follows:

[redacted] said that on Friday, 2/1/91, at approximately 11:30 PM, he was accompanied by a female friend in his Chevy Van while driving northbound in the right (slow) lane on the Baltimore-Washington Parkway (295) between Washington, D. C. and Baltimore, when he observed ahead of him a red Anne Arundel County police truck stopped along the right shoulder of 295 northbound. [redacted] further noticed an Anne Arundel County police officer exit this truck and begin to walk across 295 toward the far side of the southbound lane, in order to apparently investigate a car that was on fire. Anticipating a safety concern for the Anne Arundel County police officer, [redacted] said that he checked his rear view mirror for possible traffic approaching from his rear; he turned on his left signal blinker; and upon seeing the left (fast lane) clear, he turned into the fast lane in order to avoid hitting the police officer. [redacted] advised that within two or three seconds of entering the fast lane, a faster-moving car slammed directly into his rear bumper, causing the car that hit him to come to rest on the far side of the southbound lane. [redacted] described the impact as forceful enough to push his rear bumper into the rear wheel and blow out one of his rear tires.

[] said that a female Maryland State Police Trooper, [] Badge No. [] was soon at the scene interviewing both [] and the other driver. [] observed and heard the other driver to continually flash a badge at Trooper [] also identifying himself as JOHN PATRICK O'NEILL, Special Agent, FBI, as he also argued to Trooper [] that his driving was totally lawful and safe, and that [] was at fault. [] added that in her interview of him, Trooper [] found no reason to interview his witness (his female companion), and after dispelling [] contention that the other driver had grossly exceeded the speed limit in colliding into [] rear, Trooper [] countered by telling [] that speed was not a factor in this matter. Trooper [] then issued [] a citation and allowed the other driver to depart with no citation.

[] said that (JOHN PATRICK O'NEILL) is insured by USAA.

[] advised that he previously had attempted to determine if a JOHN PATRICK O'NEILL was an FBI Agent by calling FBIHQ, but [] found no one at FBIHQ who would acknowledge that an Agent by that name was on their rolls.

It is [] opinion that the other driver (JOHN PATRICK O'NEILL) was unethical in exerting his professional influence on a local officer, and that he was not at fault, despite being given a citation.

[] said that he is studying Case Law on his own and plans to argue his case in the courts. In asking for the identity of writer, [] said that he was documenting all issues of this particular situation in his personal computer. Writer did not reveal his identity to [] contending that it was irrelevant, but advised [] that his complaint seemed logical and appropriate.

Again, writer did not compromise the identity of JOHN PATRICK O'NEILL for security reasons, but writer considered [] to be totally rational in his conversation and justified in his account, if his account is unbiased and legitimate.

Writer submits this complaint to SAC, Baltimore, for appropriate disposition.

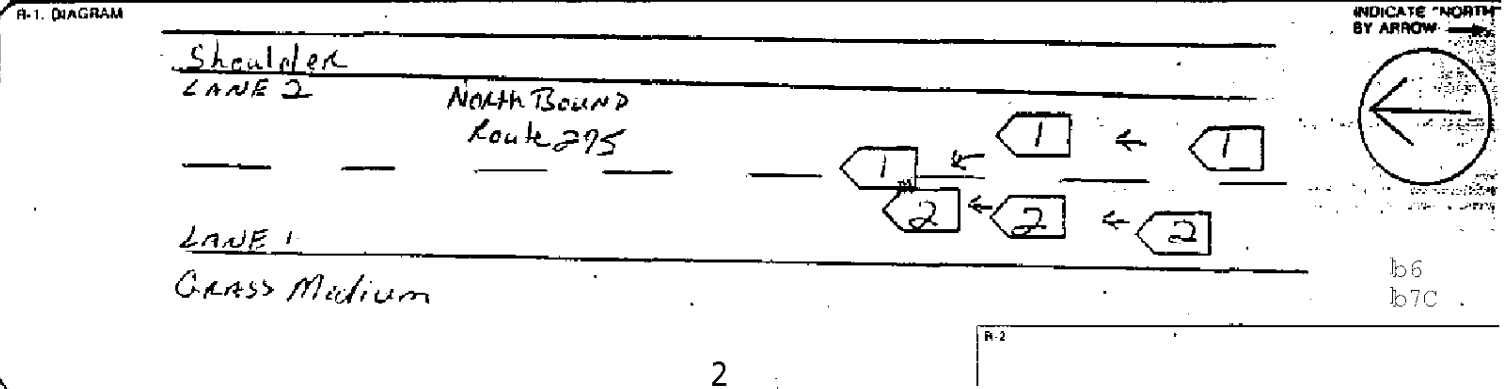

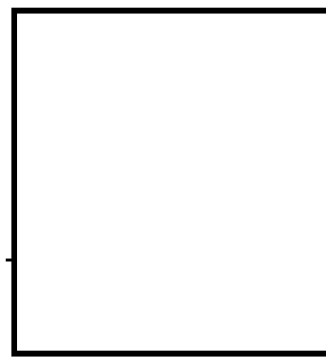

On Monday morning, 2/4/91, SSA O'Neill advised Assistant Section Chief (ASC) John Paul O'Connor, WCCS, CID, of his contact with a Maryland State Trooper during the evening of Friday 2/1/91, as a result of his involvement in a traffic accident while in an off duty status and operating his personal vehicle. SSA O'Neill provided a copy of State of Maryland Motor Vehicle Accident Report number 5204991 relating to the accident. The copy of this report has been maintained in SSA O'Neill's personnel folder. A copy of the accident report provided by SSA O'Neill is attached hereto for information and reference. SSA O'Neill advised at that time that the driver of the other vehicle had been issued a citation by the Maryland State Trooper who investigated the accident.

SSA O'Neill advised that he did identify himself only once to the State Trooper as he (SSA O'Neill) was armed with his service revolver. It should be noted that, within the last year, a Maryland State Trooper was shot and killed after a routine traffic stop between Washington and Baltimore.

CID COMMENTS: SSA O'Neill is an excellent employee and has not been a disciplinary problem in the FBI. He was driving his personally owned vehicle when he became involved in a traffic accident while enroute home from Washington, D.C. SSA O'Neill resides near the city of Baltimore. The Maryland State Police Officer responded to the accident scene and a citation was issued to the other driver, who entered SSA O'Neill's lane of traffic and struck SSA O'Neill's vehicle. SSA O'Neill was armed with his service revolver and identified himself to the responding State Trooper. The next working day, SSA O'Neill reported the incident to his Supervisor, ASC O'Connor, and furnished a copy of the Maryland State Police Report of the incident. Further, the insurance company of the other driver has assumed liability for the accident and has settled all claims with SSA O'Neill relating to the accident.

Based on the above, CID does not believe that FBI policies or procedures were violated and recommends that no further action be taken with regard to this incident.

INFORMATION CONCERNING JOHN O'NEILL

On 4/5/91, [redacted] appeared at the Baltimore Office of the FBI requesting FBI assistance in locating and investigating JOHN O'NEILL. [redacted] advised he was involved in an accident with JOHN O'NEILL on 2/2/91 while traveling on Route 295 in Anne Arundel County, Maryland. [redacted] stated he believed JOHN O'NEILL was at fault in the accident, but "flashed his badge" to the Maryland State Police Officer, advised he was an FBI agent, and was released from the scene. [redacted] advised his vehicle was struck in the rear by O'NEILL's vehicle, but he [redacted] was ticketed and determined to be responsible for the accident. [redacted] advised he has a court date set for 5/1/91 in Anne Arundel County, Maryland.

In addition to the above, [redacted] advised he has been unable to obtain an accident report from the Maryland State Police or locate JOHN O'NEILL. [redacted] has contacted the Baltimore and Washington offices of the FBI, but has been unable to locate anyone familiar with O'NEILL. Through [redacted] investigation he has determined that JOHN O'NEILL is a DEA agent in Baltimore. [redacted] stated the Baltimore FBI should be aware that there is an individual or a DEA agent posing as an FBI agent.

In conclusion, [redacted] stated that if he does not get assistance from the FBI in handling his complaint, he was going to forward his information to President GEORGE BUSH. Accompanying [redacted] to the Baltimore FBI Office was an individual introduced as [redacted] stated she was in the vehicle with [redacted] at the time of the accident, but declined to be interviewed regarding the incident. [redacted] would not provide an address or telephone number or any other identifying data to the writer.

A review of Baltimore indices revealed that [redacted] has been in contact with the Baltimore Office since 12/30/87 regarding various complaints. The serials indicate that in addition to contacting the Baltimore FBI Office, [redacted] has contacted the White House and FBI Headquarters concerning the activities of corruption in the various court systems and police departments in the State of Maryland, the Governor's Office, the State Comptroller's Office, and the misplacing of his income tax refund.

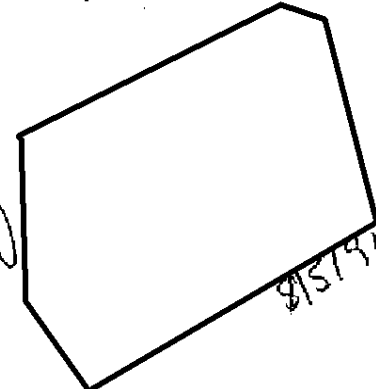

DETAILS: An OPR investigation was opened concerning SSA John Patrick O'Neill which is based on an allegation provided by [REDACTED] alleging that SSA O'Neill displayed unprofessional behavior in exerting his influence by identifying himself as an FBI agent to a Maryland State Trooper who was investigating a traffic accident on 2/1/91 which involved vehicles driven by SSA O'Neill and [REDACTED]. The accident took place at approximately 11:30 p.m. on 2/1/91 and is reported in State of Maryland motor vehicle report number 5204991.

On 6/24/91, the investigating Maryland State Trooper, [REDACTED] was interviewed by Baltimore Division. Trooper [REDACTED] conducted an accident investigation and subsequently charged [REDACTED] with the accident. Officer [REDACTED] stated that during the entire time that [REDACTED] SSA O'Neill and she were together, SSA O'Neill never mentioned to her that he was an FBI agent. Trooper [REDACTED] advised that the accident case was subsequently heard on 6/5/91 and no State's Attorney was on hand to present the case for the State of Maryland. Trooper [REDACTED] advised that without a State's Attorney to protect the State's interest, [REDACTED] attorney through objection and guile prevented her from clearly presenting her case resulting in a not guilty verdict for [REDACTED].

In a signed, sworn statement, dated 7/16/91, SSA O'Neill recalled that he spoke to an Anne Arundel County (AAC), Maryland, police officer prior to meeting Trooper [REDACTED] at the accident scene. The AAC police officer was not tasked with conducting the accident investigation in view of the fact that the I-295 location is the territory handled by the Maryland State Police. In passing time with casual conversation prior to the arrival of Trooper [REDACTED] SSA O'Neill recalls a brief conversation he had with the unidentified AAC police officer. Noting the fact that SSA O'Neill was formerly assigned to the Baltimore Division and had given extensive lectures at the AAC Police Academy, SSA O'Neill asked the AAC police officer when he had graduated from the police academy. SSA O'Neill subsequently told the police officer that he was an FBI agent and had previously lectured at the police academy. SSA O'Neill did not recall showing this officer his official identification. [REDACTED] was within hearing distance during the course of SSA O'Neill's conversation with the AAC police officer and [REDACTED] made some comment about being an FBI agent. SSA O'Neill did not recall the exact comment. At the time of this discussion, it was known that the AAC police officer was not going to be conducting the accident investigation.

The following information was obtained by SA [redacted]

On 4/23/91, [redacted]

[redacted]

[redacted] appeared at the Baltimore Office of the FBI.

[redacted] said he was on a highway traveling south at a speed of 45 MPH when he was struck in a rear wheel well by an FBI Agent who was traveling at 72 MPH. The incident occurred on 2/2/91, and the Agent was JOHN O'NEILL. [redacted] claimed he was deliberately struck in an effort to "take me out," which means he tried to kill him.

In an effort to confirm the employment of O'NEILL, [redacted] called DEA, who said there is no DEA Agent called O'NEILL employed by DEA. However, there is an O'NEILL employed by the FBI. [redacted] called FBIHQ and spoke to a woman called [redacted] who said there is no one called O'NEILL employed by the FBI, but he left a message anyway. About one-half hour after speaking with [redacted] someone who said she works for the FBI called [redacted] and said O'NEILL will be out of town for about one week. [redacted] said I know where he was and what he was doing. He (O'NEILL) had just left his girlfriend's house, a "whore in Linthicum," and he was on his way home.





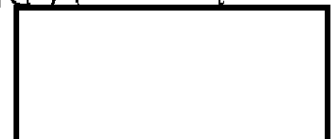

parked on the right shoulder. For safety reasons, [] decided to change his lane of travel from the lane closest to the police vehicle to the innermost lane of the Baltimore-Washington Parkway. As [] was changing lanes, a vehicle operated by ASAC O'Neill hit [] rear bumper. [] described the impact as sufficient to push his rear bumper into one of his rear tires, causing it to blowout. Both vehicles then pulled to the side of the parkway to determine the amount of damages and injuries, if any, and to await the arrival of a Maryland State Trooper to investigate the accident. Trooper [] soon arrived at the scene and interviewed [] and ASAC O'Neill.

During the interview of ASAC O'Neill by Trooper [] [] observed ASAC O'Neill display his credentials to Trooper [] and identify himself as an FBI Agent. Trooper [] also interviewed [] regarding the incident, and then issued [] a citation. [] believed that by ASAC O'Neill identifying himself as an FBI Agent, Trooper [] disregarded the true circumstances surrounding the accident, and wrongfully issued him a citation.

On 6/24/91, Trooper [] provided the following information:

Trooper [] conducted an accident investigation on 2/1/91 involving [] and ASAC O'Neill. Trooper [] ultimately issued a citation to [] indicating that his operation of his vehicle caused the accident. Trooper [] could not recall ASAC O'Neill mentioning to her that he was an FBI Agent. Trooper [] advised that [] was found not guilty of the traffic offense following a trial in the Maryland State Court on 6/5/91.

On 7/16/91, ASAC O'Neill provided a signed, sworn statement containing the following information:

On 2/1/91, ASAC O'Neill was travelling northbound on the Baltimore-Washington Parkway in his personal vehicle. As ASAC O'Neill was attempting to change lanes, a vehicle driven by [] pulled into his lane and struck the right front side of his automobile. Both vehicles pulled to the side of the Parkway, and ASAC O'Neill determined that the other driver was not injured, but had sustained damage to the left rear wheel area of his vehicle.

An Anne Arundel County (AAC) police officer arrived on the scene shortly after the accident. The AAC police officer advised ASAC O'Neill that the investigation of the incident was within the jurisdiction of the Maryland State Police, and that a trooper was en route to the site. During a casual conversation with the AAC police officer, ASAC O'Neill mentioned that he was an FBI Agent, and had lectured at the Anne Arundel County Police Academy. [redacted] apparently overheard this conversation between ASAC O'Neill and the AAC police officer because he made a comment about ASAC O'Neill being an FBI Agent. The conversation between ASAC O'Neill and the AAC police officer was casual in nature, and ASAC O'Neill did not intend it to influence the outcome of the investigation, especially since the AAC police officer would not be conducting it.

A short time later, Trooper [redacted] arrived at the scene to conduct the investigation. ASAC O'Neill did not remember identifying himself to Trooper [redacted] as an FBI Agent. ASAC O'Neill believed that it was possible that he identified himself as an FBI Agent to Trooper [redacted] because he was wearing an ankle holster at the time, and might have been concerned about the possibility of it being observed. ASAC O'Neill and [redacted] were both interviewed by Trooper [redacted] and [redacted] was issued a citation. ASAC O'Neill denied making any attempt to influence Trooper [redacted] in her investigation of the accident.

CRIMINAL INVESTIGATIVE DIVISION (CID) RECOMMENDATION

Based upon the finding that ASAC O'Neill conducted himself in a proper and professional manner, CID recommended no administrative action be taken against ASAC O'Neill.

ASD ANALYSIS AND RECOMMENDATION

ASD concurs with the recommendation of CID.

Based upon a review of the information developed during the administrative inquiry there does not appear to be any credible or substantial evidence that ASAC O'Neill attempted to use his position as an FBI Agent to influence the investigation of the accident. ASD recommends no action be taken against ASAC O'Neill.

On 5/6/92, [redacted] appeared at the field office in Baltimore and spoke with PLA [redacted]. His purpose in coming to the office was to find out how to make an administrative claim against the FBI in connection with the auto accident between him and ASAC JOHN P. O'NEILL on 2/1/91. As FBIHQ is aware, [redacted] filed a lawsuit in U.S. District Court in Maryland against the FBI in January, 1992, regarding the matter. That suit was recently dismissed for the reason that [redacted] failed to first file an administrative claim. [redacted] was given a claim form and it is expected that he will file a claim shortly. Obviously, the claim will be denied since ASAC O'NEILL was not within the scope of his employment when the accident occurred.

With regard to the lawsuit, in paragraph 1 of the complaint, [redacted] alleges that ASAC O'NEILL testified in traffic court (in connection with the ticket [redacted] received as a result of the accident) that he "had been drinking before he left his job." Baltimore PLA [redacted] has obtained and reviewed a taped transcript of the proceedings from the District Court of Maryland, Anne Arundel County, on 6/5/91 in the matter of State v. [redacted].

On the tape, ASAC O'NEILL testified that he had one drink after he left work. There is no mention of alcohol consumption at work or that ASAC O'NEILL had more than one drink. The Maryland State Police (MSP) trooper who investigated the accident made no remarks regarding alcohol consumption nor did the judge.

It should also be noted that counsel for [] in his final argument, alleged that ASAC O'NEILL had improperly flashed his badge in an effort to influence the investigating trooper. The judge asked counsel if he really believed the record reflected that or whether counsel was simply taking advantage of the fact that ASAC O'NEILL identified himself. At that point, counsel conceded he was taking advantage of that fact. The judge responded, "Just wanted to know."

Therefore, a review of the taped proceedings does not support [] allegation in paragraph 1 of the complaint, i.e. that ASAC O'NEILL testified that he "had been drinking before he left his job."
