## **EXPLANATION OF EXEMPTIONS**

### **SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552**

- (b)(1) (A) specifically authorized under criteria established by an Executive order to be kept secret in the interest of national defense or foreign policy and (B) are in fact properly classified to such Executive order;

- (b)(7) records or information compiled for law enforcement purposes, but only to the extent that the production of such law enforcement records or information ( A ) could reasonably be expected to interfere with enforcement proceedings, ( B ) would deprive a person of a right to a fair trial or an impartial adjudication, ( C ) could reasonably be expected to constitute an unwarranted invasion of personal privacy, ( D ) could reasonably be expected to disclose the identity of confidential source, including a State, local, or foreign agency or authority or any private institution which furnished information on a confidential basis, and, in the case of record or information compiled by a criminal law enforcement authority in the course of a criminal investigation, or by an agency conducting a lawful national security intelligence investigation, information furnished by a confidential source, ( E ) would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions if such disclosure could reasonably be expected to risk circumvention of the law, or ( F ) could reasonably be expected to endanger the life or physical safety of any individual;
- (b)(8) contained in or related to examination, operating, or condition reports prepared by, on behalf of, or for the use of an agency responsible for the regulation or supervision of financial institutions; or
- (b)(9) geological and geophysical information and data, including maps, concerning wells.

- (k)(5) investigatory material compiled solely for the purpose of determining suitability, eligibility, or qualifications for Federal civilian employment or for access to classified information, the disclosure of which would reveal the identity of the person who furnished information pursuant to a promise that his/her identity would be held in confidence;
- (k)(6) testing or examination material used to determine individual qualifications for appointment or promotion in Federal Government service the release of which would compromise the testing or examination process;
- (k)(7) material used to determine potential for promotion in the armed services, the disclosure of which would reveal the identity of the person who furnished the material pursuant to a promise that his/her identity would be held in confidence.

Mr. [ ] furnished a letter and envelope which was postmarked September 30, 1992, at SCF Southern, Maryland, and bearing a return address of INFINITY BOOKS, LTD., 8907 56th Avenue, Berwyn Heights, Maryland, 20740, and addressed to Schering-Plough Healthcare Products, P. O. Box 377, Memphis, Tennessee 38151.

Mr. [ ] advised that this letter had recently been received at the Schering-Plough offices and had been handled by numerous employees at the company prior to his receiving the letter.

It was further noted that the envelop contained three type-written pages front and back. The top of the first page contained the heading, "INFINITY BOOKS, LTD., P. O. Box 272, Huntington, West Virginia 25707". The next line contained telephone number (301) 345-2071. The heading further states, "Intellectual Newsletter number one, September 22, 1992, by D. G. Glavasic".

Mr. [ ] advised that he has read the letter and noted that the letter contains mostly non-sensible ramblings containing much vulgarity in references to various sex acts. However, Mr. [ ] advised that the last page of the letter contains a threat to murder ABC-TV newsmen [ ] and PETER JENNINGS.

Mr. [ ] advised that because of these threats against [ ] and JENNINGS that he is referring the matter to the FBI. Mr. [ ] advised that he did not note any threats contained in the letter against the Schering-Plough Company nor any of its officers or employees.

He has been living at the above address for many years and utilizes the basement of his house as an apartment to earn some extra money. He recollects renting the basement to an individual by the name of [redacted] who was born and raised in [redacted]. He rented his apartment to this individual in August, 1992 and he left sometime in September of the same year because of the lack of payment of rent. Mr. [redacted] continued by saying that biographical data that he has of Mr. [redacted] indicates that his date of birth is [redacted] place of birth is [redacted]. He is [redacted]. His father is [redacted] and is presently living in [redacted] and his mother is presently living in [redacted]. He has a telephone number for his mother's residence as [redacted]. [redacted] continued by saying that [redacted] attempted to get a job at the University of Maryland as a math teacher but was turned down. He previously was employed at the University of West Virginia and had a previous address as [redacted] Huntington, West Virginia. [redacted] described [redacted] as an eccentric and associated himself with an organization called Infinity Books Limited. [redacted] feels that Infinity Books was just the name utilized by [redacted] and has no further importance. [redacted] advised that when [redacted] left his house he headed to New York and is presently attempting to get back to Yugoslavia. [redacted] advised that [redacted] did not drive and therefore had no vehicle. He did all of his commuting by bus.

Although the letter did not contain any threats against employees of the above company, it did contain threats of harm to AMERICAN BROADCASTING COMPANY (ABC) Newscasters [redacted] and PETER JENNINGS. [redacted] in his letter, states that his intentions are to locate, torture and murder all scum working for ABC Television. In his letters, [redacted] also stated, "In particular, I will find and execute [redacted] and PETER JENNINGS for their sins and crimes against our realm."

Efforts to find [redacted] College Park, Maryland met with negative results. [redacted] who owns the single family dwelling at the above address, indicated that [redacted] lived in his basement for approximately one month and was put out because of the nonpayment of rent. [redacted] advised that [redacted] is a Yugoslav national and was born in [redacted] advised [redacted] went to New York and was to make his way back to [redacted]

After being informed of the above, AUSA [redacted] declined prosecution.

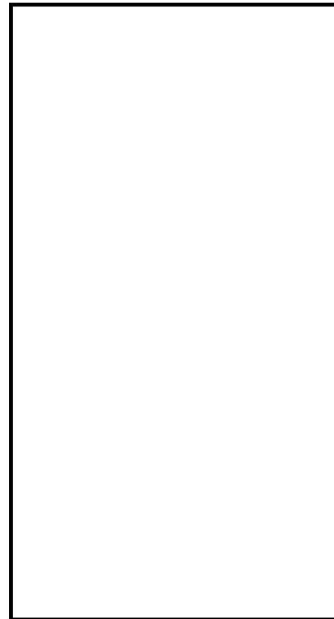

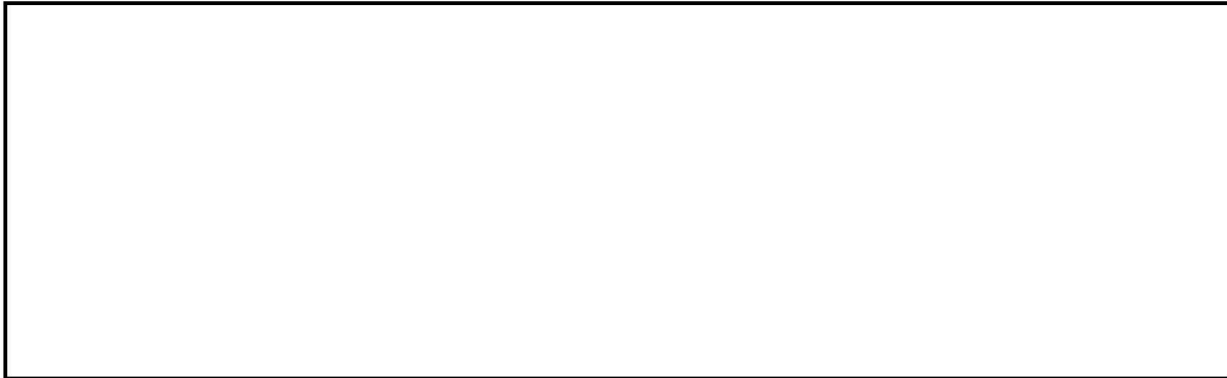

#### Chronology

[redacted] began coming to our church in early February 2000. He attended planning meetings for an event we were going to host called "Serb Fest 2000." It is an annual picnic hosted by our church at Freedom Hill Park in Sterling Heights, Michigan. He also began attending church most Sundays during the same timeframe.

As the event drew near, he sent the event flyer to Peter Jennings and invited him to attend. According to [redacted] at ABC News Security in New York City, shortly after that the emails started getting strange.

Near the end of June-2000 he brought flowers and gifts for me and left them in the church office.

He then looked up my parents' phone number and proceeded to call them almost every night between 4-July and 16-September, 2000.

I didn't hear from him for some time, when in December of 2000 he called me at home and wanted to talk. I told him I wasn't interested and that he should leave me alone. Around mid-January-2001 he called again at my home and also at work. I had to change both my home and work numbers twice. After the second call to my office I told him I would be contacting the Police.

On 31-January-2001 he stopped at the church's catering hall and made the following statement to the Hall Manager, Mr. [redacted]

"I've been out all day killing bats; and I want to kill a lot of cunts. I'm looking for that cunt [redacted] because I want a blowjob. I don't care if I'm scaring her, I will find her in church on Sunday and make her give me a blow-job."

After I heard that he had made those comments, I immediately resigned my position as Treasurer on the church board.

I then filed for a "Personal Protection Order" with the Wayne County Third Judicial Circuit Court. The order was granted on 27-February-2001, and was to be valid for one year from that date.

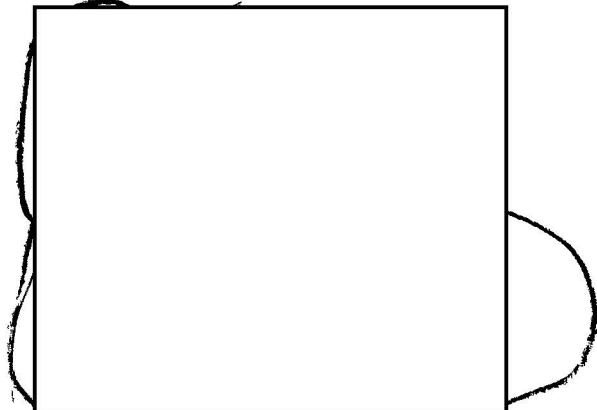

Upon the advice of two Dearborn Police Detectives, I never served him with the papers because he stopped contacting me. They felt that if he stopped bothering me that I should not put my name in front of him again. I have not seen, nor heard from him since, because I have not been back to my church since all of this happened.

In November 2001, [redacted] from ABC News contacted me by email asking me if I had any other address for [redacted] they tried to serve him with a restraining order, the papers got returned. I told him I had no other information.

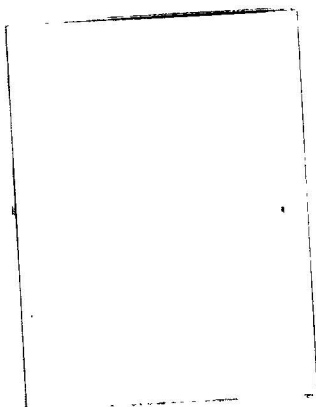

Thank you very much for your efforts to locate [redacted] also known as [redacted]. As you may recall, [redacted] has been sending approximately 500-600 email messages a month to Peter Jennings, a news correspondent with ABC News in New York. The emails have become increasingly more and deranged, violent, and threatening in nature.

The FBI New York Office recently learned that [redacted] called a former employer and advised that he is currently living in [redacted] and can be reached at telephone number [redacted] and that his new email address is [redacted]. The FBI Office has advised that an arrest warrant has been obtained for [redacted] in the Southern District of New York. However, there are no current plans to request his extradition from [redacted] in the event he is located by your service.

Because of the increasing number of his threatening email submissions, the New York Office is requesting that if [redacted] is located in [redacted] he be contacted by your service and warned and admonished to cease and desist in his email submissions to ABC News. The New York Office has requested that [redacted] NOT/NOT be advised that an arrest warrant has been issued for him as their concern is that may cause him to increase his correspondence to ABC News.

Good Morning [redacted] At some point in the past, I don't recall w/out checking the case file, I did pass on to the [redacted] the information regarding [redacted] and his possible location in [redacted] I just called my contact at the [redacted] to see if any action had been taken on my request. He is not in but will call me back later today. In the interim though, a bit of insight for you. There is no extradition treaty in effect between the U.S. and [redacted] I have no recollection or knowledge of a [redacted] citizen ever being extradited or rendered back to the U.S. [redacted] to the United States. On one hand my opinion and that of the Embassy's is that the Government of [redacted] would never turn over one of their citizens that we indict on terrorism charges as the political fall out for them would be very severe. However, my own opinion with no historical action in the past to support it it that they may consider turning over someone insignificant like a cyber crime guy to us as it he is insignificant in the overall diplomatic relationship picture. The [redacted] could use that to show that they do honor legal obligation process. You need to obtain a commitment from your AUSA that he/she is willing to proceed with the extradition request and package. It is a very involved and time consuming process. And the question then is if [redacted] will recognize that even absent a extradition treaty if the crime is even a crime within their own country and/or severe enough to warrant the extradition. OR do I ask the [redacted] to do me a personal favor and go to the guy's house and ask them to tell the guy to knock that shit off as he is pissing off the Americans? Your choice. Let me know. 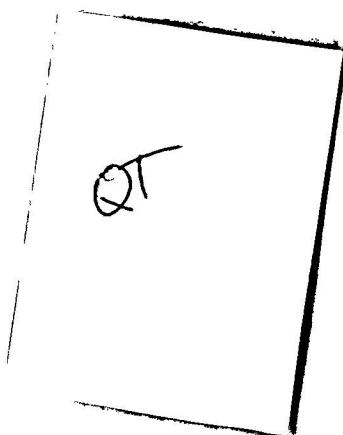

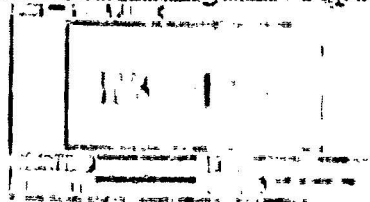

Details: On May 24, 2002, an arrest warrant was obtained for [REDACTED] in the Southern District of New York (SDNY) as he was identified as the subject in numerous deranged/threatening e-mails sent to ABC News, and directed towards celebrity anchor Peter Jennings. At the time this warrant was obtained, it was known at the NYO that [REDACTED] was living outside of the United States, most likely in his native [REDACTED]. The purpose for obtaining the warrant for [REDACTED] as agreed to by the SDNY, was to best enable the NYO to learn of an attempted re-entry by [REDACTED] into the United States and prevent any harm to Jennings. Also during this time, it was clear from this investigation that [REDACTED] was unstable, and had the authority/capability to re-enter the United States.

In March of 2003, captioned case was re-classified to Pending/Inactive status as no investigative leads or interests existed for the NYO. Furthermore, no positive results were received from Legat Singapore, or [REDACTED] regarding

any success in locating and admonishing [redacted] Additionally, ABC News advised that all communications from [redacted] had stopped.

In 2005, the victim in captioned investigation, Peter Jennings, passed away of lung cancer.

On October 3, 2005, SA [redacted] contacted the assigned SDNY AUSA, [redacted] to request the dismissal of the complaint and arrest warrant for [redacted] as a result of Jennings' passing. AUSA [redacted] returned this call, indicating that she agreed and would consult with her supervisors.

On November 28, 2005, SA [redacted] contacted AUSA [redacted] to again check on the status regarding the dismissal. AUSA [redacted] agreed regarding the dismissal, and again stated that she would call SA [redacted] back, which she failed to do.

On June 26, 2006, SA [redacted] again contacted AUSA [redacted] regarding captioned matter, left a message and did not hear back.

In July of 2006, SA [redacted] was contacted by CJIS, [redacted] who advised that they had received [redacted]

On August 8, 2006, at 5:40pm, SA [redacted] contacted AUSA [redacted] to inquire as to the status of the dismissal and advise of [redacted] likely application for residency in Canada and New Zealand. As of the date of this communication, this phone call has not been returned.

Inasmuch as no action appears to be in motion at the SDNY to dismiss the charges against [redacted] captioned case will remain in Pending/Inactive status, and the active arrest warrant and NCIC entry for BOGHA will remain in place.
