Dear Mr. Greenewald:

This is in response to your Freedom of Information Act (FOIA) request filed with the Bureau of Prisons (BOP). Specifically, you seek an electronic copy of all records pertaining to Timothy McVeigh maintained by the BOP. In addition, you seek an electronic copy of FOIA case logs from 2008-2012.

In response to your request, three-thousand one-hundred and fifty-nine (3159) pages of responsive records were located. These records were forwarded to this office for a release determination. After careful review, we have determined that two-thousand three-hundred and twenty-five (2325) can be released in full, five-hundred thirteen (513) pages can be released with certain information redacted, and three-hundred and thirteen (313) pages were withheld in their entirety. The releasable records, two-thousand eight-hundred and thirty-four (2834) pages, are located on the enclosed one (1) CD disk. Additionally, eight (8) pages of the records belong to the Federal Bureau of Investigation (FBI) office and are under their control. Pursuant to Title 28, Code of Federal Regulations, Section 16.4(f), we are notifying you of this referral. You should receive a response from that agency in the near future.

Pursuant to the Freedom of Information Act, 5 U.S.C. §552, records are exempt in part or in full from disclosure to you under the following exemptions:

(b)(5) - inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency

(b)(6) - personnel and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy

(b)(7)(C) - records or information compiled for law enforcement purposes which could reasonably be expected to constitute an unwarranted invasion of personal privacy

(b)(7)(E) - records or information compiled for law enforcement purposes which would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions

(b)(7)(F) - records or information compiled for law enforcement purposes which could reasonably be expected to endanger the life or physical safety of any individual

Pursuant to Title 28 Code of Federal Regulations, Section 16.9 or 16.45, the material herewith denied may be appealed to the Assistant Attorney General. This written appeal must be received by the Office of Information Policy (OIP) within 60 days from the date of this letter. Both the appeal letter and face of the envelope should be marked "Freedom of Information Act Appeal," and should be addressed to the Office of Information Policy, U.S. Department of Justice, 1425 New York Ave., Suite 11050, Washington, D.C. 20530-0001.
