

EXPLANATION OF EXEMPTIONS

SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552

- (b)(1) (A) specifically authorized under criteria established by an Executive order to be kept secret in the interest of national defense or foreign policy and (B) are in fact properly classified to such Executive order;
- (b)(2) related solely to the internal personnel rules and practices of an agency;
- (b)(3) specifically exempted from disclosure by statute (other than section 552b of this title), provided that such statute (A) requires that the matters be withheld from the public in such a manner as to leave no discretion on issue, or (B) establishes particular criteria for withholding or refers to particular types of matters to be withheld;
- (b)(4) trade secrets and commercial or financial information obtained from a person and privileged or confidential;
- (b)(5) inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency;

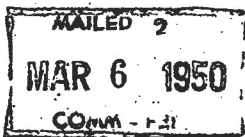
Dear Mr. Tyler:

What I initially started to write you about, before being carried away by enthusiasm, as above, was that last night over radio station WQR, Frank Edwards, news commentator for the A.F. of L. program, after describing a hold-up and later participation of the FBI in the resultant investigation, practically recommended that all "Stuck-ups" hereafter claim that they saw a submachine gun in the holdup men's hands, which would result in your Department taking a part in the investigation. If you obtain a copy of his script, I think you will understand why the writer, and probably everyone else who heard Edwards, got the impression that he was recommending such action through his "Tip," whether or not the persons held-up saw such weapon.

To us, it just did not sound like good reporting or good advice, and we thought the matter should be brought to your notice.

Hoover and FBI Win Public Vote of Confidence

Survey Answers Wire Tapping Critics

By **GEORGE GALLUP**,

Public Opinion.

J. Edgar Hoover, under fire from left wing critics for FBI activities in wire tapping and loyalty investigation cases, is given a remarkable vote of confidence by the general public in a coast-to-coast survey by the American Institute of Public Opinion.

More than eight in every ten persons questioned in this cross-section study say that the head of the FBI has done a good job.

Crime Work Hailed.

Although recent headlines about the FBI have dealt heavily with

its antispy activities, the public singles out Mr. Hoover's work against criminals and racketeers for special praise rather than the spy work. For every voter who lauds his efforts in tracking down Communists and spies, five praise his skill in tracking down criminals.

Here is how the public's attitudes shape up in the survey:

"Do you think J. Edgar Hoover has done a good job or a poor job as head of the FBI?"

Good job _____ 79%
Poor job _____ 2
No opinion _____ 19

The small proportion of persons voicing a critical opinion of Mr. Hoover—only one in every 50—is virtually without parallel in surveys that have dealt with men in public life.

On other occasions the public has tossed bouquets to government officials but rarely has the

attitude been as favorable as that expressed in today's vote.

No Partisan Difference.

Although FBI activities have been widely discussed, with some newspapers critical of the use of wire taps in certain cases, there is little evidence that the FBI is a political issue. In today's survey, for example, Republican and Democratic voters have virtually the same attitude toward the FBI director.

Here is the vote by political preference:

Increased Budget Favored.

The FBI would likely have little difficulty enlisting public support if it comes to a question of en-

larging the bureau to carry on investigation of Communist or subversive groups.

Last summer a survey by the institute found a 3-to-1 vote in favor of increasing the amount of money given to the FBI. The bureau has about 4000 agents.

In 1948 President Truman gave the bureau one of its most difficult assignments—checking on the loyalty of some two million federal employees. Charges of FBI "snooping" and of attempting to act as "thought police" grew out of this assignment.

But the work of the bureau itself is approved by virtually as large a vote as the job done by its director. Last August an institute survey found only one person in every 25 expressing disapproval of the FBI itself.

By letter dated February 24, 1950, Mr. Ralph L. Tyler, 309 Front Street, Riverton, New Jersey, wrote to the Bureau expressing his high regard for the FBI's activities. In his communication he made reference to a radio broadcast over Station WOR of the Mutual Broadcasting System in which Frank Edwards, News Commentator, had referred to the FBI's investigation in holdups in which a sub-machine gun is used.

By letter dated March 22, 1950, from SAC, New York, Bureau was furnished that portion of the program which was broadcast February 23, under the sponsorship of the American Federation of Labor out of Washington, D. C.

His review of the script reflected Edwards in referring to the robbery of William Mather, Millionaire steel maker of Cleveland, Ohio, had advised that the FBI had been called into the case. Edwards made this statement in this connection: "Remember this, if you get robbed, be sure to say that you saw a sub-machine gun in one of the bandit's hands. And then, the F.B.I. will enter the case. It's a nice little angle to know."

RECOMMENDATION: It is suggested that the attached letter be transmitted to Mr. Frank Edwards pointing out the status of the FBI with reference to this investigation and particularly to sub-machine guns and the relation of this weapon to our investigative jurisdiction.

I did want to write this note to comment with reference to your broadcast on February 28, over the facilities of the Mutual Broadcasting System.

In this regard it is to be noted that the FBI is not conducting an investigation of the robbery involving Mr. William Mather of Cleveland, Ohio, particularly wanted to point out that the jurisdiction of our organization in cases of this type is not affected by the weapons which may be carried by holders.

Your remarks with reference to the FBI's investigating cases in which a sub-machine gun is used were erroneous and I thought you might like to be furnished this information for your future guidance.

Rebulet to RALPH L. TYLER, 309 Front Street, Riverton, New Jersey, dated March 3, 1950, and Newark letter to the Director dated March 9, 1950, copies of which were designated for this office.

Mr. DAVE DRISCOLL, Director of News and Special Features for Station WOR of the Mutual Broadcasting System, advised that the radio program referred to in Mr. TYLER'S letter is sponsored by the American Federation of Labor out of Washington, D.C., Monday through Friday at 10:00 P.M. over the Mutual Broadcasting System. The commentator is FRANK EDWARDS.

The portion of the program of February 23rd last of interest to the Bureau is as follows:

"Six hooded bandits filed into the home of millionaire steel maker - William Mather of Cleveland today and made off with about half a million dollars worth of jewelry. Mather, 93 years old, slept through the entire episode. His wife, 60, was forced at gunpoint to reveal the whereabouts of the knickknacks, and the bandits scooped up a nice little sackful of diamonds, sapphires, rubies and pearls, little trinkets which the steel magnate had managed to save for his old age, since the steel industry is opposed to pensions. The hooded men slipped into the house and out of it undetected through the servants' entrance. And here's a tip for you, the F.B.I. has been called into this case. Remember this, if you get robbed, be sure to say that you saw a sub-machine gun in one of the bandit's hands. And then, the F.B.I. will enter the case. It's a nice little angle to know."

The following is set forth for the information of the Bureau and WFO concerning FRANK EDWARDS, Newscaster sponsored by the American Federation of Labor who broadcasts from Washington DC at 10:00 P. M. over the Mutual Broadcasting System.

On his broadcast of 7/27/53, EDWARDS played a transcript of the voice of YONGJEUNG KIM, President of the Korean Affairs Institute, in which KIM commented for three or four minutes on the Korean truce situation. KIM expressed the opinion that in the future there should be no interference in settling Korea's internal problems, specifically referring to the United States in this regard.

Report of SA GEORGE C. MOORE, 2/27/53 at Washington DC entitled "KOREAN AFFAIRS INSTITUTE" (Bufile 100-24115) (WFO 100-14614) set forth that according to an informant the Korean Affairs Institute is a "one man show" run by YONGJEUNG KIM who is bitterly opposed to SYNGMAN RHEE and publishes a magazine, "The Voice of Korea" which, under the parade of fairness, contrasts South Korea with North Korea to the advantage of the latter. Another informant stated in 1951 that KIM has used the Korean Affairs Institute and its magazine to discredit SYNGMAN RHEE, General MacARTHUR, and CHIANG KAI-SHEK by making false reports about them. This informant was of the opinion that KIM is not a Communist, but has worked with "fellow travelers" in Korea and been used by Communists in the US to discredit RHEE and, knowingly or not, has followed the "Communist Line".

Dear Sir:

This is to advise the Bureau that Mr. FRANK EDWARDS, who is a news commentator on Station WIBC, Indianapolis, Indiana, made a broadcast over that station in which he made a remark to the effect that during the investigation of a Hollywood comedian the FBI made use of a device on this person's telephone which enabled the FBI not only to know the conversation which transpired over the telephone, but also even after the telephone receiver was replaced all of the conversation in the room could be heard.

I discussed this matter with EDWARDS and inquired of him as to the source of his information for this broadcast and also discussed with him the advisability of making such a broadcast regardless of whether his information might or might not be true. EDWARDS indicated that after considering the matter he felt that he had probably acted without enough forethought in the matter and, considering it now, he realized that this could possibly cause some embarrassment to the Bureau regardless of whether or not his facts were well founded.

Upon inquiring as to the source of the information, EDWARDS stated that he did not wish to give me the identity of this person who gave him the story, but he did say that his source was a former FBI agent who was an accountant and who worked on the case involving the comedian CHARLIE CHAPLIN, who was under investigation by the Los Angeles Office some time ago. He stated that he had formerly been well acquainted with this Agent and on a recent trip to Los Angeles he met this person, who related to him some of the interesting experiences which he had had while in the Bureau. According to EDWARDS this Agent had worked on the Chaplin case and had told him of some of the interesting highlights which were developed as a result of this technical surveillance.

EDWARDS stated that this source is no longer in the Bureau and that he is now working with some national organization which builds pre-fabricated houses. His work has to do with the study of the building codes which are in effect in the various states.

In regard to his conversation with this former agent, EDWARDS said he felt certain that when these stories were being told him that the former agent had no idea that he might broadcast them.

EDWARDS stated that he felt rather bad over the whole incident since he realized the possible embarrassment that such a statement might cause and, the further fact, that he also felt that he had possibly committed a breach of confidence insofar as his conversation with the former agent was concerned. He indicated that he was very proud of the FBI and its accomplishments and that when he made the broadcast it was more or less in the spirit of lauding the ingenuity of the FBI. He stated that hereafter whenever he got any "bright ideas" for broadcasts he would contact the office and would be very happy to be guided by the office's suggestions.

A copy of this letter is being furnished to the Los Angeles Office for its information, and this incident is being brought to the Bureau's attention with the thought in mind that when agents resign it could again be impressed upon them, either through a statement in the letter accepting their resignation or through a document which they would sign, that all information which came to their attention while they were in the service of the FBI must continue to remain confidential.

Reference is made to a letter from the Director dated September 13, 1946, which revealed Mr. FRANK EDWARDS, a news commentator on Station WIBG, Indianapolis, had disclosed information in connection with one of his broadcasts relative to the operation of technical equipment in the investigation of CHARLIE CHAPLIN, which was of a highly confidential nature, presumably by some Agent who had been assigned to this investigation. The Director's letter requested that former Special Agent JAMES B. BUSHYHEAD, who presently resides in Saint Louis, be contacted concerning this matter in view of the fact that he had been engaged in this investigation. It is to be noted that Mr. JAMES B. BUSHYHEAD is now employed as Sales Promotional Manager for the Moog Piston Ring Company, 6650 Easton Avenue, Saint Louis, Missouri, which company is engaged in the manufacture of motor vehicle piston rings and springs, and he has been so employed since his resignation from the Bureau.

Mr. BUSHYHEAD advised that he worked on the CHARLIE CHAPLIN case with former Special Agent FRANK ANGELL, and that jointly they had interviewed many individuals. He advised that he did not know Mr. FRANK EDWARDS and further he did not know any Agent disclosing information of this, or any other type, to anyone not authorized by the Bureau.

SAC Dalton stated that a copy of his letter had been furnished the Los Angeles Office for its information and that the incident was being brought to the Bureau's attention with the thought in mind that when agents resign it could again be impressed upon them, either through a statement in the letter accepting their resignation or through a document which they would sign, that all information which came to their attention while they were in the service of the FBI must remain confidential.

RECOMMENDATION

There is attached for transmittal to the Los Angeles Office a letter requesting that an effort be made by that office to determine the identity of the former agent involved.

Regarding SAC Dalton's suggestion, it is felt it perhaps would be advisable to notify all SACs that when agents resign, among other things, it should again be impressed upon them that all information which came to their attention while they were in the service of the FBI must continue to remain confidential. It is felt that no additional purpose would be served by requesting that they sign a document to this effect or including such a statement in the letter accepting their resignation.

On 2/16/61 Mr. LESTER FISHHAUT, a program director of WTTV, Channel 4, 3490 Bluff Road, Indianapolis, telephonically contacted me requesting I appear on the FRANK EDWARDS Newscast Show to be introduced by Mr. EDWARDS as the new Special Agent in Charge of the Indianapolis Office. The program would be taped, and Mr. FISHHAUT requested that if at all possible I accept for the evening of February 16 for a taping at 7:00 PM, to be broadcast the same evening at 10:30 PM. In view of this opportunity and Indianapolis indices reflecting no information of a derogatory nature re EDWARDS, his sportscaster NOAH MILLER, or the station, I accepted.

The program was taped as planned on 2/16/61 at 7:00 PM, and following his news broadcast of international and local news, FRANK EDWARDS introduced me and asked me previously prepared questions concerning the general rise in crime in the United States, the role of the FBI in the correlation of arrest data (Uniform Crime Reports), and I told two interesting items of unusual experiences of Special Agents.

In view of the appearance as one of an introduction by TV as the new SAC in Indianapolis and the fact it was taped with pre-arranged questions, I accepted; and according to Mr. EDWARDS, it was an excellent one and proceeded smoothly and with very good timing. WTTV is one of the four television channels in this area, and the FRANK EDWARDS show is reported to have an extensive news audience. I viewed the show at 10:30 PM, 2/16/61, and I am most satisfied with its results. The Bureau requested to credit one speaking appearance.
