## **EXPLANATION OF EXEMPTIONS**

### **SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552**

- (b)(1) (A) specifically authorized under criteria established by an Executive order to be kept secret in the interest of national defense or foreign policy and (B) are in fact properly classified to such Executive order;
- (b)(2) related solely to the internal personnel rules and practices of an agency;
- (b)(3) specifically exempted from disclosure by statute (other than section 552b of this title), provided that such statute (A) requires that the matters be withheld from the public in such a manner as to leave no discretion on issue, or (B) establishes particular criteria for withholding or refers to particular types of matters to be withheld;
- (b)(4) trade secrets and commercial or financial information obtained from a person and privileged or confidential;
- (b)(5) inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency;

- (b)(7) records or information compiled for law enforcement purposes, but only to the extent that the production of such law enforcement records or information ( A ) could reasonably be expected to interfere with enforcement proceedings, ( B ) would deprive a person of a right to a fair trial or an impartial adjudication, ( C ) could reasonably be expected to constitute an unwarranted invasion of personal privacy, ( D ) could reasonably be expected to disclose the identity of confidential source, including a State, local, or foreign agency or authority or any private institution which furnished information on a confidential basis, and, in the case of record or information compiled by a criminal law enforcement authority in the course of a criminal investigation, or by an agency conducting a lawful national security intelligence investigation, information furnished by a confidential source, ( E ) would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions if such disclosure could reasonably be expected to risk circumvention of the law, or ( F ) could reasonably be expected to endanger the life or physical safety of any individual;
- (b)(8) contained in or related to examination, operating, or condition reports prepared by, on behalf of, or for the use of an agency responsible for the regulation or supervision of financial institutions; or
- (b)(9) geological and geophysical information and data, including maps, concerning wells.

- (k)(3) material maintained in connection with providing protective services to the President of the United States or any other individual pursuant to the authority of Title 18, United States Code, Section 3056;
- (k)(4) required by statute to be maintained and used solely as statistical records;
- (k)(5) investigatory material compiled solely for the purpose of determining suitability, eligibility, or qualifications for Federal civilian employment or for access to classified information, the disclosure of which would reveal the identity of the person who furnished information pursuant to a promise that his/her identity would be held in confidence;
- (k)(6) testing or examination material used to determine individual qualifications for appointment or promotion in Federal Government service the release of which would compromise the testing or examination process;
- (k)(7) material used to determine potential for promotion in the armed services, the disclosure of which would reveal the identity of the person who furnished the material pursuant to a promise that his/her identity would be held in confidence.

On September 19, 1958, [ ] Radio Station WIP, Philadelphia, Pa., telephonically furnished the following information to the Philadelphia Office of the FBI.

[ ] states he has been conducting radio interviews pertaining to the subject of unidentified flying objects, and in the course of this program has become familiar with many individuals "on the lunatic fringe" involved in this subject. He stated a convention of people interested in this subject was held recently in New Jersey, and that one Otis P. Carr of Baltimore attended this affair and made a speech about an "inter-planetary vehicle" which he had developed and which he was readying for a trip to the moon. Carr reportedly stated also that he would pilot this craft and would have as his one passenger on its first flight one Major Wayne Aho. [ ] described Aho as one who has travelled all over the country accepting contributions "to help this campaign in Washington," and is connected with a Washington Saucer Society.

[ ] continued that he had received a telephone call from a Philadelphia city fireman who stated he had been told about a radio announcement that Otis P. Carr had announced a demonstration of his "free energy inter-planetary vehicle" for the week of September 20, 1958. This fireman stated he was glad to hear of some results inasmuch as he had invested \$150 in the stock of Carr's firm. He also informed [ ] on September 19, 1958, that he had received a letter from Carr announcing a meeting on September 20, 1958, at the "Chapel of Truth" in Philadelphia at which Carr and Aho would speak.

[ ] expressed the opinion that he expected Carr and Aho planned to ask those in attendance at this meeting to contribute money. He noted that no public announcement had been made of the meeting, and that it was probably limited in attendance to those on a list of Carr's possibly of stockholders in his company. [ ] stated he did not know the exact address of the Chapel of Truth but understands it is on Walnut Street in Philadelphia. He stated that he intended to contact the Philadelphia District Attorney regarding this matter.

Re Chicago teletype 10/3/58, and Washington Field teletype 10/4/58.

Bureau files reflect that in June, 1957, an unidentified individual was passing out leaflets captioned "A Citizen Speaks" outside of rooms where Atomic Energy hearings were being held in Washington, D. C. Writer of the leaflets is reflected as Wayne S. Aho, (Washington mailing address) 4811 Illinois Avenue, N. W., Washington 11, D. C. Leaflets indicated the writer is a volunteer in the civilian defense in the State of California and the writer displayed great concern about the dangers of nuclear testing and praised senators and congressmen for doing a magnificent job in the hearings.

Bureau files also reflect a letter from the Houston Division dated 6/13/58, captioned "General Research Company; First Capital Development Corp.; International Academy of Outer Space; Miscellaneous; Information Concerning," a copy of which was designated for Washington Field. This letter tells of meetings held in Houston dealing with outer space travel, building of flying saucers, and soliciting funds. Aho was said to be present at these meetings.

Bureau files also reflect a letter from the Newark Division dated 5/28/58, captioned "New York Saucer Information Bureau, etc., Internal Security - C," a copy of which was designated for the Chicago Division. This letter mentions Aho as a former major in the Air Force and as director of the Washington Saucer Intelligence, Washington, D. C. Aho is also described as being instrumental in establishing the New York Saucer Information Bureau in January, 1958. Washington Field, in referenced

For the information of the Bureau, PH and RA, OM advised by airtel dated 3/12/58 that [redacted] who, in November, 1957, claimed to have witnessed the landing of a balloon or saucer in Kearney, Nebraska, and who was later committed to a mental institution, was in Kearney, Nebraska, in March, 1958, according to information supplied by Deputy County Attorney [redacted] informed OM Division that he had been advised that [redacted] was accompanied by one Major WAYNE S. AHO who claimed to be director of Saucer Intelligence, R.O. Box 815, Washington 4, D. C. According to [redacted] was supposed to have photographs of flying saucers.

[redacted] further advised that handbills were being distributed in Kearney, Nebraska, advertising meetings which were to be held regarding flying saucers in March, 1958, at the National Guard Armory in Kearney. The handbills reflected [redacted] claimed to have seen a saucer at Kearney on 11/5/57 and again at Elm Creek, Nebraska, on 2/5/58. [redacted] had no information regarding AHO as to whether he claims to be with the U. S. Air Force or the U. S. Army on active or inactive duty. He did not know whether AHO was wearing a military uniform. 47-48339-5

Investigation by OM Division failed to establish whether WAYNE S. AHO was wearing a uniform or whether an individual by this name was on the active rolls of the Air Force.

On 3/17/58, IC [ ] WFO, advised that a check of the records of USAF, Pentagon, reflect no record of WAYNE S. AHO. IC [ ] ascertained that Army personnel records at the Pentagon reflect that personnel records of WAYNE S. AHO, SN G-1043845, were transferred to the Army Records Center, St. Louis, Mo., on 11/28/55.

On 3/18/58, SA [ ] determined that P.O. Box 815, located at the Franklin Station, 12th and Penna. Ave., N. W., was rented on 7/8/57 by WAYNE S. AHO, 4811 Illinois Ave., N. W., Washington, D. C. The firm name listed is "Washington Saucer Intelligence, New Age Science," for which AHO is a lobbyist.

WFO indices reflect that, during an investigation conducted in 1957, a [ ] were interviewed, at which time they advised they were members of the Cosmic Circle Club.

According to [ ] this club meets to study "space travel" and, in particular, "flying saucers." The [ ] stated that one WAYNE AHO, 4811 Illinois Ave., N. W., Washington, D. C., was the leader of the group. They described him as a former major in the ARMY who is now retired and devotes full time to the study of space travel.

For the information of OM, on 9/19/58, [ ] Radio Station WIP, Philadelphia, Pa., furnished the following information to the Philadelphia Division:

[ ] states he has been conducting radio interviews pertaining to the subject of unidentified flying objects, and in the course of this program has become familiar with many individuals "on the lunatic fringe" involved in this subject. He stated a convention of people interested in this subject was held recently in New Jersey, and that one OTIS P. CARR of Baltimore attended this affair and made a speech about an "inter-planetary vehicle" which he had developed and which he

was readying for a trip to the moon. CARR reportedly stated also that he would pilot this craft and would have as his one passenger on its first flight one Major WAYNE AHO.

[ ] described AHO as one who has traveled all over the country accepting contributions "to help this campaign in Washington," and is connected with a Washington Saucer Society.

[ ] continued that he had received a telephone call from a Philadelphia city fireman who stated he had been told about a radio announcement that OTIS P. CARR had announced a demonstration of his "free energy interplanetary vehicle" for the week of September 20, 1958. This fireman stated he was glad to hear of some results inasmuch as he had invested \$150 in the stock of CARR's firm. He also informed [ ] on September 19, 1958, that he had received a letter from CARR announcing a meeting on September 20, 1958, at the "Chapel of Truth" in Philadelphia at which CARR and AHO would speak.

[ ] expressed the opinion that he expected CARR and AHO planned to ask those in attendance at this meeting to contribute money. He noted that no public announcement had been made of the meeting, and that it was probably limited in attendance to those on a list of CARR's, possibly of stockholders in his company. [ ] stated he did not know the exact address of the Chapel of Truth, but understands it is on Walnut Street in Philadelphia. He stated that he intended to contact the Philadelphia District Attorney regarding this matter.

The above is being submitted for information, and no further action is being taken by WFO.

Carr Enterprises travel about the country giving lectures and attempting to obtain money to build a spaceship to go to the moon in December, 1959. She stated CARR is supposedly a scientist who is building the spaceship and who has met people from outer space. She stated CARR and subject are to lecture at 32 West Randolph Street, Chicago, on October 4, 1958, at 8:00 PM concerning their anticipated moon space trip.

[redacted] stated that a very good friend, [redacted] has been supporting them. She stated that subject, CARR and an unidentified man and woman have moved into [redacted] residence to save hotel bills on this lecture tour and the [redacted] have taken residence on [redacted] which is parked in [redacted] [redacted] stated she personally contacted the Chicago Better Business Bureau on October 2, 1958, concerning subject and CARR and was advised they had no record on subject but that CARR was a hotel room clerk until 1955.

with Army Intelligence and also brags about it. He stated AHO does not wear a uniform and has never stated to him that he is or was a Major in Army Intelligence. He stated he felt [ ] could furnish no additional information concerning AHO.

On October 3, 1958, [ ] [ ] advised he heard AHO was formerly with Army Intelligence but that no rank was mentioned. He stated AHO has never advised him that he is or was a Major in Army Intelligence.

On October 6, 1958, [ ] [ ] telephonically contacted the Chicago Office and advised SA [ ] that he had attended the lecture given by CARR and AHO on Saturday night, October 4, 1958. He stated that Major AHO advised that he was formerly a Major in the United States Air Force where he had been assigned to an Intelligence Unit. AHO claimed to be a friend of the inventor of the A/C Motor and claimed a great knowledge of electrical circuits. AHO indicated he would be the first passenger to the moon.

[ ] stated that both CARR and AHO indicated they would need 200 million dollars to prepare for their trip and that the audience would receive a letter in the near future wherein they would be advised as to how they could contribute to this venture.

[ ] described AHO as follows: White male, middle forties, six feet tall, 160 pounds, dark hair, slender, and wore civilian clothes.

St. Louis communication dated October 7, 1958, and captioned [ ] MAJOR WAYNE S. AHO [ ] INFORMATION CONCERNING" reflects one Major WAYNE SOLO AHO was inducted into active service in the United States Army on February 3, 1941, at Kelso, Washington, and honorably discharged on September 17, 1942, as a Pilot

Sergeant by reason of accepting an appointment as a Second Lieutenant. On September 18, 1942, he entered active duty as a Second Lieutenant and was honorably relieved from active duty on March 24, 1946, as a Major. He was a member of the Officers Reserve Corps from March 24, 1946, to November 19, 1952, and on November 19, 1952, he was given an indefinite appointment in the Officers Reserve Corps. There is no mention or notation regarding his being discharged from the Officers Reserve Corps. His Officers Serial Number was shown as O-1043845. This information obtained from the military records, Department of Defense, Military Personnel Records Center, St. Louis, Missouri.

She advised that the Nevada State Journal for Reno, Nevada, 9/18/60, carried an advertisement indicating that one Major WAYNE S. AHO (retired) of Washington Saucer Intelligence, would lecture on "Spaceships Visiting Earth - What It Portends," on 9/18/60. She advised that she attended this meeting which was sponsored by an organization known as "Understanding" of Reno. She said she knows very little about this latter organization, except that apparently they are sponsoring outside speakers such as Major AHO. She said that around seventy-five or eighty people attended the lecture and that apparently an attempt was being made by Major AHO to create a great deal of national interest in the problem of flying saucers. She said that while Major AHO said that he was against Communism that he was very critical of the United States Government and just some of the overtones in his comments lead her to believe that possibly this was some sort of a front group. She said that one thing she recalled he mentioned was critical comment of the Government regarding the handling of some former Naval officer because he had given out information to the public on flying saucers. She said that he was a very able speaker and held the audience more or less "spellbound" during the course of his talk. She said that she believes that portions of his talk were tape recorded by some of the members, and one of the members who is a friend of hers, she believes, has a tape recording of

Bureau files do not contain information indicating that Major Aho or the Washington Saucer Intelligence are known to have any connection with the Communist Party (CP).

Major Wayne S. Aho was the subject of an impersonation investigation in 1958. This was based on a complaint to the effect that Aho, who claimed to be a retired major in the United States Army, was traveling throughout the country with one Otis T. Carr attempting to obtain money to construct a spaceship in which they purported to go to the moon. Investigation did not bear out the facts of the complaint as relating to the impersonation statute. (47-28338) 48339

Bureau files contain other miscellaneous information concerning efforts on the part of Aho and Carr to sell stock in the company which purported to construct a flying saucer. A newspaper clipping from the Pittsburgh "Gazette and Sun Telegraph" dated 8-12-60 pointed out that the Attorney General of New York State was investigating the activities of Otis T. Carr in connection with the sale of \$50,000 of stock for the purported construction of a flying saucer. Bureau files show that Aho was associated with Carr in this enterprise. (62-105105)

Information was received 5-12-58 by the Newark Field Division that Wayne S. Aho, who was identified with Washington Saucer Intelligence, P.O. Box 815, Washington, D. C., was in January, 1958, instrumental in establishing the New York Saucer Information Bureau. This organization has alleged that the Government is too secretive about its operations and withholds information from the public.

No investigation of subject or the Washington Saucer Intelligence is presently being conducted by the Bureau.

Dear friends,

I will try to make this a newsy letter to bring you up with current events from this part of the globe and tell you what this segment of the civilization is doing about the New Age and challenges facing mankind. It is so easy to drift along, to say there is nothing going on. All I can say is .....GOD HELP AMERICA AND HER PEOPLE. I see many things in my travels and the desire is great to do more and more. About two weeks ago, I visited again with Judge Morrow in West Palm Beach, Florida. We had just a few brief minutes to visit and chat. Our parting words were like an Omen, we wondered where we would see each other next time and what changes would have been faced. Our ideas, although miles apart in distance, seemed to coincide almost word for word. He lectures about the threat to Freedom and is trying to wake Americans up. He is a Naval Reserve Officer and dedicated American. The consensus seemed to be that our nation will pay a high price for sleeping so long and carelessly. Yes America, the slumbering has gone on long enough....

It was wonderful to tour with Rev Milton Haar of Gettysburg, South Dakota. After a letter that is almost two years old, we finally got together. We first met at the Chicago Space Age Convention at the Hamilton Hotel two years ago. He asked me then if I would come to the Dakotas and talk to the groups he worked with in North and South Dakota. We traveled to the south, visiting with Fletch and Leola and the New Age Expositor in Salt Lake City. This is a devoted couple, working long and diligent hours, printing and writing and doing myriad tasks and work for the New Age and America. Salt Lake City and its environs is a beautiful place, a spot where one can look back and ahead and compare the historic trek of the pioneers to the new trek,.....a journey in consciousness to new vistas. We enjoyed our stay with Fletch and Leola. There was much to discuss and this couple have rich experiences to recount in the space interest and new age work.

While in Idaho, visiting with Dr. O. R. Bjornlie of Gooding, Idaho and lecturing to groups in Boise, Twin Falls, Idaho Falls, Fairfield and Gooding, we heard of a former mining site at Triumph, Idaho and went to look at it with Dr. Bjornlie and Florence and all the families, including Brother Mandery and his wife and son from Red Ore, Minn. It looked inviting and useful, 16 cottages and a large brick home with fireplaces with additional buildings for dormitories, storage etc. We agreed that if this was in the Divine Plan for the New Age.....it would come into the program. By the time we had returned to South Dakota, help was inspired and the necessary action has been taken to open the way and start a New Age project, recreation area and base camp at Triumph. Announcement to Edwin Ruson and Theodore Turley at a grand review of the Nauvoo legion on or about May 6, 1843.

We were talking about the persecutions of the Saints when he said:

"We shall see worse things than mobbings, drivings, and persecutions. Our persecutors will have all the mobbings they want. Don't wish them any harm, for when you see their sufferings you will shed bitter tears for them. I want to tell you something of the future. I shall speak in parables like unto John the Revelator.

In the West you will see the people of Israel and the true lovers of liberty and Constitutional government make a stand for truth and righteousness. They will stand for the laws of God and to preserve their heritage. I shall call this people the White Horse of Peace and Safety.

~~Your enemies will continue to follow you with persecutions and will make obnoxious laws against you, trying to destroy the White Horse but you will always have a friend or two to defend you. They will throw out the worst of the laws and you will not receive much harm. You must petition Congress continually but they will treat you as strangers and aliens. They will not give you your rights but will govern you with strangers and commissioners."~~

"You will see the Constitution of the United States almost destroyed. It will hang, as it were, by a thin silken thread of the finest fibre." The Prophets countenance became very sad, for, he said, "I love the Constitution; it was made by the inspiration of God. The White Horse and the Red Horse will combine in the defence of it, and it will be saved and preserved by their efforts."

"And an Ensign of peace and safety will be raised by the White Horse on the top of the mountains and all nations will flow unto it.

The mountains will be full of minerals and will become very rich. You will see cartloads of silver piled in the streets. Gold will be shoveled like sand, and will become commercially valueless, for the people of the world will be seeking salvation."

"The time will come when the banks in every nation will fail, and there will be only two places of safety where the people can deposit their treasure. The places will be with the White Horse and in the vaults of England. A terrible revolution will take place in the land of America, such as has never before been seen. The land will be left entirely without a supreme Government and every species of wickedness will prevail. So terrible will be the corruption that father will take arms against the son and son against father. Mother will be against daughter and daughter against mother. There will be seen the most terrible scenes of bloodshed and murder that have ever been looked upon. Peace and safety will be taken from the earth except in the West and the honest in heart from all nations of the earth will gather there for safety.....

Many will come with bundles under their arms, for there will be no escape except by fleeing to Zion."

"You will become so numerous that there will be danger of famine, not for want of seed time and harvest, but because of the numbers to be fed. The Turkish Empire in the Orient will be the first power as a nation to be disrupted, for, at that time, freedom to preach the gospel in the Holy Land must be given. The Lord planted in the earth for a thousand years. This power will remain with her that she might keep other nations from joining Russia to get power over all the world."

Although England and France are now bitter enemies, they will yet ally to keep Russia from conquering the world. The Catholic churches will yet be united. The Protestants

"do not know how much they are indebted to Henry VIII for throwing off the Pope's Bull and establishing the Protestant faith. He was the only monarch at the time who could have done it. He was able to do it because the nations rallied to him and sustained him. One of the remarkable features of England is that although they have adopted the redcoat uniform, making an excellent mark to shoot at, they have conquered wherever they have gone. The reason for this they will know some day. England's wisdom and statesmanship comes from the fact that there is so much of the blood of Israel in the nation. The lion and the unicorn are the ensigns of Israel.

While the terrible revolution of which mention has been made, in America, is going on, England will be neutral until it becomes too inhuman to be tolerated, then she will intervene to stop the shedding of blood. France will join her, not to subdue the nation, but to make peace. The Black Horse, knowing that England did not believe in slavery, will flee to the invaders, and armed with British bayonets, their doings will be terrible. This, they do by claiming power, but there will be no responsible government.

By this time, the White Horse will have grown strong; Elders will have gathered the honest in heart from among the Pale Horse, and they will defend the Constitution. And the Kingdom that God has set up will begin to flourish, and all other nations will come to it. Nations not permitting the Gospel to be preached will be humbled to submission. England, Germany, Denmark, Norway, Sweden, Switzerland, Holland and Belgium all have much of the Blood of Israel, and these must be gathered. All these nations will submit to the Kingdom of God.

The nobility of England know that the Gospel is true, but it has not enough grandeur and pomp and influence for them to embrace it. They are proud, and will not acknowledge the Kingdom of God or come unto it, until they shall see the power which it will have.....

Peace and safety in the west will be protected by the Guardians, the White and Red Horses. The coming of the Messiah among his people will be so natural that only those who see him will know that he has come, but he will come and give his laws unto Zion and minister unto his people. This will not be his coming in the clouds of Heaven to take vengeance on the wicked of the world.

The temple in Jackson county, Missouri, will be built in this generation. The Saints will think that there will not be time to build it, but with all the great help you can receive, you can put up a great temple quickly. You will have all the gold, silver and precious stones you need, for these things will only be for the beautifying of the temple. Also, all the skilled mechanics of Israel will help build it. When you see this land bound with iron, you may look forward to Jackson county."

~~At this point, he made a pause, and looking up as though the vision were still in~~ view, he said: "There is a land beyond the Rocky Mountains that will be invaded by the heathen Chinese unless great care and protection be given." Speaking of the heathen nations, he said: "Where there is no law, there is no condemnation. This will apply to them. Power will be given to the White Horse to rebuke the nations afar off, and you obey it, for the laws go forth from Zion.

The last great struggle Zion will ever have to contend with will be when the whole of America will be made the Zion of God. Those opposing will be called God and Magog. The nations of the earth will be led by the Russian dictator and his power will be great, but all opposition will be overcome and this land will be the Zion of our God.....AMEN!....

These words of the Prophet made a strange impression on me and I have never forgotten them. On one occasion about two weeks after I heard him speak thus, I was at a meeting when he preached a sermon, said by him to be the greatest of his life. At that time, he again related the matter which I have now written, and it became firmly rooted in my memory. I, then to be true, therefore testify these are inspired words, spoken by the Prophet Joseph Smith. As he stood looking up into Heaven, his countenance became very white and transparent, and he looked as though he has as much of the heavenly influence as he could bear and still stay with the Saints. His voice was powerful, and his words cut like a two-edged sword.....

#### A DIVINE REVELATION

Received by Wayne S. Aho, formerly a Major with U.S. Army Combat Intelligence, U.S. First Army in Europe.

Time: Early spring of 1956, followed by a meeting with advanced intelligences on the Mohave Desert, May 11, 1957, a confirmation.

While living and working in northern California, one night early in the spring of 1956, I saw a brilliant white flash in the sky. This was like a "double proof", verifying my own experience and indicating that it was not a figment of my own imagination. ### CIA's climate warning impresses Soviets

By JACK ANDERSON

THE SOVIET UNION has been spurred by a U.S. intelligence report to launch an urgent study of global climate changes.

The Central Intelligence Agency warned in a 1974 report of the possibility of "a detrimental global climatic change." Pointing out that "the stability of most nations is based on a dependable source of food," the report declares tersely: "This stability will not be possible under the new climatic era."

The CIA quoted even more alarming language from a University of Wisconsin forecast that "the earth's climate is returning to . . . an era of drought, famine and political unrest in the western world."

A CIA spokesman tried to downplay the doomsday report. "It's really a view of one author," he told us. "It's not really an official piece of finished CIA intelligence."

YET AMERICAN SCIENTISTS were astonished to learn during a visit to the Soviet Union earlier this year that the Soviets took the CIA report seriously. They ordered their own experts to investigate what is happening to the weather.

This came out during a bilateral Soviet-American discussion of environmental problems. One of the American scientists, Dr. Edward Epstein, kept careful notes. He summarized them last month in a memo to the Commerce Department.

"It appears that the CIA report on climate attracted a good bit of attention in the Soviet Union," reports Dr. Epstein's memo. "Upon reading the dire projections contained in the report, Soviet authorities asked what was happening climatologically. . . .

"It, therefore, appears that one result of the CIA study, undertaken in the first instance because the CIA felt the conventional agencies in the United States were not doing very much in studying and measuring climate fluctuations, . . . (was to increase) the Soviet effort in this area while the U.S. effort remains essentially unchanged."

The Soviet weather study was directed primarily by Dr. M.I. Budyko, who is described in the CIA report itself as "an eminent Soviet climatological theoretician." Epstein conferred

with Budyko in Russia and learned that the Soviet scientist is "firmly convinced that a rapid climatic warming is occurring."

His conclusion is that "drought conditions in the continental mid and high latitude will accompany the higher temperatures." This would mean dangerous droughts and crop failures in both America and Russia, as well as other food-producing nations.

Our associate Jim Grady questioned Epstein about his own views. "There has been disagreement on what's happening," he said, "let alone what will happen."

Many climate experts, including Budyko and Epstein, believe the increase in carbon dioxide in the earth's atmosphere is causing a change in climate. This increase can be attributed to man's growing use of fossil fuels.

Burning fossil fuels creates carbon dioxide, which acts as global insulation. This creates a greenhouse effect, warming the earth and causing drought conditions.

Although this C.I.A. report has been largely ignored in the United States, it has become prime research in the Soviet Union. Weather changes all over the earth as well as temperatures rising indicate authenticity. Temperature in Antarctica climbed to 56 degrees Fahrenheit a few years back, two years later to 54 degrees, almost unheard of in that part of the earth. We cannot have nor encourage the people of our planet to enter a Space Age by maintaining an attitude of refusal to accept that which is before us, evidence of other life forms and an inhabited universe. Indeed the great Creator would demonstrate limited intelligence and capability to place life on only one planet with so much to choose from. One gentleman in a question and answer series in a lecture said: "Major Aho, I believe if we upon the earth are the most intelligent or advanced in the creation, God Help Us!" Many would agree.

As the victims of the Big Thompson flash flood tragedy in Larimer County, Colorado gave their lives in a recent tragedy of our time, perhaps caused by man's refusal to see what is being done to weather and environment from wrongful use of earth's resources, so have many who have espoused reality and truth in UFOs given their lives in the serving of truth and humanity. Many died in the prime of life, suddenly and mysteriously. We must not take lightly or forget easily those who are giving up life in growing earth upheaval, nor forget those patriots of truth, who stood with truth and for truth, even as our founding fathers who formed this nation of freedom. One famous General made a statement which is most appropriate: "The price of freedom is eternal vigilance!"

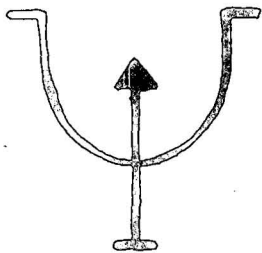

WAYNE SULO AHO, Founder and President of The New Age Foundation, Inc., with charters nationwide and abroad. Founder and Director since 1957 of Washington Saucer Intelligence, Inc., P. O. Box 815, Washington, D. C. 20044.

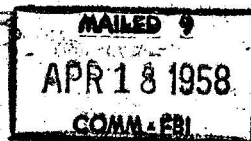

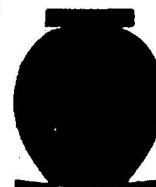

We have just reviewed your very interesting letter of June 21. We have been extremely busy here, so we have not had an opportunity until now to really get down to the specifics in your letter. We were interested to know that it was a relative of yours who produced the Tucker car, and we felt at the time that he probably had a correct idea which, unfortunately for him and the public, was somewhat ahead of its time. We wonder if he is still planning to market his product. It would seem that there might be opportunity to do so in this new Space Age.

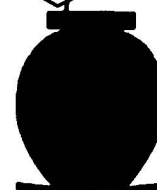

The date: 1960, Dec. 7. The place: Space Md., a community not yet on the map. The event: A 1.5 million dollar saucer shaped space ship is taking off with a three man crew for a seven day round trip to the moon.

That's the picture 300 Chicagoans meeting at 32 W. Randolph st. got Saturday night from Otis T. Carr, who described the yet-to-be-finished expedition as "the culmination of 50 years of research" by himself and his followers.

#### Good Timing

Carr, a Baltimore man who heads OTC Enterprises, a firm "pioneering in space travel," set the Dec. 7 date because of its historical link with "the last great world conflagration" (World War II) and because it also happens to fall on "our [his] birthday."

He will pilot and navigate his craft, the OTC-XI, and will take along Maj. Wayne S. Aho, whose pre-occupation the last few years has been tracking down flying saucers.

They will be using a model of the saucer and a model of the ship. Carr said that "once the ship reaches 300 r. p. m. it will repel itself from the earth's magnetic force."

This means that they will not blast off, but will sort of orbit away.

#### Model on Hand, Too

On display was a model of the craft, 8 feet in diameter, complete with removable top so the 300 who paid to hear Carr talk could see its inner workings. The model was a bit crude, but Carr assured his listeners that detailed plans are ready.

The whole thing still remains to be financed, tho. The government is interested but has committed itself to the

obsolete rocket idea, so no funds can come from that source, Carr's aids said, and maybe private contributions will be necessary. Besides 1.5 million dollars for the moon ship, the program to build the city at Space Md. would cost 20 millions.

One woman, much impressed, said, "Why, I'd really like to go, it all sounds so thrilling. If necessary, I'll beg money to help out."

On March 17, 1960, [redacted] Chamber of Commerce, Ann St., Homestead, Pa., made available an illustrated brochure published by OTC Enterprises and a business card showing that [redacted] representative of this organization. [redacted] advised that the Chamber of Commerce had received some inquiries concerning OTC Enterprises. According to [redacted] or some other representative of this organization caused a disturbance at the public library in Homestead by demanding that the library remove certain science books from the shelves and replace them with books supplied by OTC Enterprises. It was claimed that the library's books were inaccurate and did not contain the true facts concerning atomic science and space travel. [redacted] also advised that OTC Enterprises allegedly was promoting the sale of a "do-it-yourself space rocket" to be used for space travel. [redacted] also stated that she had learned through the Better Business Bureau of Pittsburgh that OTC Enterprises had been involved in court proceedings in Oklahoma.

The brochure furnished by [redacted] illustrated the theories of OTIS T. CARR and contained drawings of vehicles allegedly for space travel and a description of "The World's First Industrial Complex To Be Run by Universal Free Energy" to be constructed near Baltimore, Md. This brochure claimed that

"The efforts of OTC Enterprises, Inc., are directed toward the peaceful uses of atomic energy" and described "the Carrötto Gravity Motor," "the utilization of solar energy," "the Proton Gun," and "the Fourth Dimensional Space Vehicle - OTC-X1, a circular foil space craft." This brochure contained the following statements:

"In the face of incredulity, we are able to state with full authority and responsibility that we have tapped an universal supply of energy in the form of gravity, and we have been able to harness the pressure energy of this force to motion with the result that we have built and put into operation a machine that produces power continuously and absolutely free of dissipation."

"Beginning from the working pilot models, which we have achieved in prototype, our broad researches are aimed at commercial atomic-power applications to every conceivable device from hearing aids and portable television sets, to space cruisers that will without the slightest doubt be carrying parties of explorers to the moon within the next few years of our lifetime."

On March 18, 1960, [redacted] Financial Division, Better Business Bureau of Pittsburgh, Inc., 411 - 7th Avenue, Pittsburgh, Pa., advised that he had conducted considerable investigation of OTC Enterprises in the Pittsburgh area.

[redacted] stated that he learned that a meeting of this organization, whose main headquarters are at 2502 N. Calvert St., Baltimore 18, Md., was held on June 2, 1959, at the Penn-McKee Hotel in McKeesport, Pa., and that a [redacted] "noted author," attempted to explain the operations of OTC Enterprises.

[redacted] stated that [redacted] was unable to answer technical questions and that certain engineers who attended this meeting described the events which took place at this meeting as "electronic gobbledygook." J. Lefkowitz. The attorney general said the company sold \$50,000 worth of stock over the last two years for a saucer with a motor that was to have perpetual energy.

The company previously was restrained by a Federal Court in Oklahoma City from selling stock before it opened a branch office in June, 1959, on East Eighth Avenue in Homestead.

### Two Public Meetings

The Carr representative here, Norman E. Colton, held two public meetings, one in McKeesport and one at the Penn-Sheraton Hotel. They were attended by local scientists and engineers who left the meetings convinced the project would never get off the ground.

The New York attorney general set September 26 for questioning of the firm's officials. The company has its head-

quarters in Baltimore. Since Mr. Lefkowitz has no jurisdiction outside New York, it was questionable whether persons sought for questioning would appear.

His New York State Supreme Court order named Mr. Carr and a number of employees, including Margaret Storm, of Route 2, Fayetteville, Franklin County, who was not otherwise identified.

### Sold for \$5

Carr's office here sold packages of plans for the space ship for \$5. They were described as valuable also as wall decorations.

The space craft was to have made a one-week flight to the moon beginning last December 7.

The New York State Supreme Court has finally stepped in to protect gullible New Yorkers from the enticements of a "flying saucer" firm known as O. T. C. Enterprises, Incorporated. What will be done with the \$50,000 already collected for production of the OTC-XI, a "space ship capable of excursions to the moon," was not explained. All the Court did was order the firm's promoters to quit selling their stock in the State of New York. (The New York Times, 9/22/61, p. C-22)

Otis T. Carr, president and founder of O. T. C. enterprises, is presently serving a jail term in Oklahoma City for selling unregistered stock. Reportedly, he is working off a \$5,000 fine at the rate of \$1 a day. Bureau files reveal that, in 1939, an Otis T. Carr, of New York City, tried to interest the Bureau in a fingerprint device which he described as "most emphatically of scientific importance in the field of fingerprint work." Examination of the device by a Bureau representative showed that it was a simple piece of prismatic glass, through which a person's fingerprints could be viewed and/or photographed. The "highly developed chemical liquid" inside the prism was determined to be simple corn syrup. (62-105105; 32-15382-93, 96; The New York Times, 9/22/61, p. C-22)

O. T. C. Enterprises has been in business since at least 1958, and by 1959 its promoters had reportedly canvassed prospective investors in 39 states. The Securities and Exchange Commission claims that a number of the firm's practices are in violation of the Securities Act of 1933. O. T. C. representatives announced in 1959 that a six-foot prototype of the OTC-XI would be tested at Frontier City, Oklahoma, but the test was abruptly canceled when the firm charged that the Federal Government was planning to seize the prototype and classify all information about the project. (62-105105; The New York Times, 9/22/61, p. C-22)

Bureau Investigations

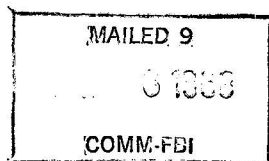


