On 12/5/91 writer contacted the U.S. Secret Service and SAC RICARDO RIVERA, Military Intelligence, regarding the captioned visit. Writer requested that any positive information be reported to the FBI and to the U.S. State Department, who has protective responsibility for Mr. SHARON. SSA [redacted] Squad 7 was also advised of the above.

On the same date writer contacted SA's [redacted] and [redacted]. They advised that SHARON will be arriving on December 9, 1991 for a "fund raising" banquet at the Condado Plaza Hotel. He will be staying at the Condado Plaza Hotel that night, and will depart Monday morning 12/10/91. SHARON will be accompanied by two armed Israeli security officers and approximately five State Department Diplomatic Security Agents.

SA [redacted] advised that one of their security concerns at the banquet is that the Jewish community here in Puerto Rico was simply notified by "flyer" which could be intercepted by anyone. To date, the organizers have not arranged for any security personnel to be at the door of the banquet, to turn away any unwelcome guests.

On 8/27/82, the writer made telephonic contact with Mike Tretolla, U.S. Dept. of State Security, 632-6173, regarding media reports concerning captioned visit. Although not received at WFO, Tretolla advised USDS has provided FBIHQ the details of this visit via teletype. Tretolla provided the following itinerary for Sharon's visit:

- 8/26/82 - arrive New York City, Sheraton Carlton Hotel.
- 8/27/82 - arrive a.m. to WDC for meeting at USDS.
  - 4:00 p.m. meeting at CIA with Dir. Casey.
  - 5:00 p.m. to 7:00 p.m. depart WDC for return to NYC.
- 8/28/82 - 7:30 p.m. return to WDC to attend Israeli War Bond fund raising event at Washington Hilton. Following will remain in WDC at Sheraton Washington Hotel.
- 8/29/82 - Return to NYC until 2:30p.m. departure for Israel via El Al.

CONTACT WITH AN UNKNOWN INDIVIDUAL AT THE PALESTINE LIBERATION ORGANIZATION INFORMATION OFFICE, WASHINGTON, D.C. DURING THIS CONTACT [ ] ADVISED THAT SHARON WAS COMING TO WASHINGTON TO THE HILTON FOR AN ISRAELI BOND DINNER AND THE NOVEMBER 29TH COALITION WOULD CONDUCT A DEMONSTRATION, A PICKET LINE, AT 7:30 P.M. ON CONNECTICUT AVENUE NEAR FLORIDA AVENUE. IT SHOULD BE NOTED THAT THE NOVEMBER 29TH COALITION IS PLANNING A MAJOR DEMONSTRATION FOR WASHINGTON, D.C. ON SEPTEMBER 11TH TO PROTEST THE ISRAELI/U.S. SUPPORTED INVASION OF LEBANON. THE PLOIO WILL PARTICIPATE IN THIS DEMONSTRATION AND PLACARDS HAVE BEEN PLACED THROUGHOUT WASHINGTON ADVISING OF THIS DEMONSTRATION. (S) (U)

AT 12:15 P.M. THIS DATE, MIKE TRETOLLA OF USDS, CONTACTED WFO AND ADVISED THAT A THREATENING PHONE CALL HAD JUST BEEN RECEIVED AT USDS. AT THE ENTRANCE OF THE DIPLOMATIC RECEPTION LOBBY AT USDS, WHEREIN A UNIDENTIFIED MALE CALLER (WITH UNSPECIFIED FOREIGN ACCENT) ASKED: "WERE YOU INVOLVED IN THE MIDDLE EAST NEGOTIATION?". THE RECEPTIONIST

THIS INFORMATION IS BEING PROVIDED TO FBIHQ AS WFO HAS NOT BEEN IN RECEIPT OF ANY INFORMATION INDICATING FBIHQ IS AWARE OF THIS VISIT. NEW YORK IS BEING ADVISED DUE TO SHARON'S PRESENCE IN NEW YORK CITY DURING PART OF THIS VISIT. (U)
