Bureau authority denied to interview captioned individual as review of relet and Bufiles indicate such action is not warranted.

Review of Bufiles indicates that subject's former connection with Tex McCrary Incorporated, New York City, and its involvement in several Registration Act investigations should have been evaluated and your observations included in relet. Details of this association are set out in report of Special Agent Thomas J. Dowling dated 8/21/61 at New York and captioned "Inter-American Public Relations, Limited," your file 97-2261, Bufile 97-4605. Similar information appears in your files concerning [redacted] NYfile 97-2203, and [redacted] NYfile 97-2234.

For your information the 7/12/58 issue of "Editor and Publisher" alleges that subject a vice-president of the McCrary Office was involved in exposing the use of microphones in a Washington, D. C. hotel by reporter Jack Anderson, associate of [redacted] and others. This was a well publicized side issue to the appearance of Bernard Goldfine, Boston textile millionaire, before the Special House Subcommittee on Legislative Oversight. According to the article subject's assignment was to track down and catch committee investigators suspected of "bugging" the hotel rooms of Goldfine and McCrary.
