Dear Mr. Greenwald,

I write in further response to your March 30, 2014 Freedom of Information Act (FOIA) request for records in the custody of the National Archives and Records Administration (NARA). Your request was received in this office on March 31, 2014 and assigned FOIA case number **42922**.

We have completed a line-by-line review of FBI case file 116-HQ-1255 and released information to the greatest extent possible. Information exempted from disclosure in accordance with the FOIA (5 USC 552) has been released in full or redacted in part. Redactions were applied to prevent the unwarranted invasion of personal privacy per 5 USC 552 (b)(6), to protect the identities of confidential sources per 5 USC 552 (b)(7)(D), and as specifically exempted from disclosure by statute per 5 USC 552 (b)(3) [50 USC 3024 (i)(1) Intelligence Sources and Methods]. A summary of the file, as released to you, is as follows:

FBI case file 116-HQ-1255: 155 total pages; 143 pages released in full; 12 pages released in redacted form.


You have the right to appeal our decision to restrict access, either in whole or in part, to any document over which this agency has release authority, within 60 calendar days of the date of this letter. Your appeal can either be submitted in writing and addressed to the Deputy Archivist of the United States, National Archives and Records Administration, 8601 Adelphi Road, Room 4200, College Park, MD 20740 or sent by e-mail to [foia@nara.gov](mailto:foia@nara.gov). In your appeal, please cite FOIA case number RD 42922 and "Freedom of Information Act Appeal" on either the envelope and letter heading or in the subject line of the e-mail. If you have additional questions or feel that our judgment with respect to the requested file is in error, please contact me at [mark.sgambettera@nara.gov](mailto:mark.sgambettera@nara.gov) prior to initiating an appeal.

You may view a sanitized version of 116-HQ-1255 free of charge in our research room in College Park, Maryland. If you would like to view this file on site, please contact me at [mark.sgambettera@nara.gov](mailto:mark.sgambettera@nara.gov) at least one week prior to the date of your visit so that I may make arrangements to provide you with access to the digital files. When you arrive in the reading room, we will provide you with a CD containing a copy of the file in a PDF format. You may use this CD to download the file to your personal laptop at no cost to you.

If you cannot schedule a visit to our College Park facility, the standard rate for reproduction orders is \$0.80 per page, regardless of format. For your convenience, I have attached to this letter a reproduction quote covering the cost to produce a digital version of FBI case file 116-HQ-1255. If you would like to purchase a digital copy of this case file, please fill out and sign the quote form and follow all instructions for submission of the form to NARA. Once NARA receives payment, I will deliver a digital copy of the file to you at the above address.

This completes the FOIA processing of case file 42922.
