On 7/28/64, transmissions were heard by the Bureau's radio station at Midland at scheduled times and frequencies at which time a message, NR 974 GR 409, was sent.

NEST (USSR) WITH HIS WIFE TO PARTICIPATE IN THE WORK OF VINE (International) ANTHROPOLOGISTS KEN (Conference). PREPARATORY COMMITTEE IS INTERESTED IN HIS ARRIVAL TO TAKE PART IN DISCUSSION ON HIGH (Negro) QUESTION. BUT COMMITTEE CANNOT PAY HIS EXPENSES. IF YOU ARE IN FAVOUR OF HIS VISIT TO NEST (USSR) WE ARE READY TO INCLUDE HIM AND HIS WIFE IN YOUR QUOTA. (Number) 3. WE WOULD LIKE TO REMIND THAT QUOTA IS GIVEN FOR SUN (Medical treatment or rest). GAY'S (Reshetov) COMMITTEE MAY PAY TRAVEL EXPENSES FOR FOUR PARTICIPANTS OF FULL (Youth) NERO (Forum). GAY (Reshetov) ASKS TO INCLUDE, IF POSSIBLE, IN LAND (Delegation) COUSINS (Delegates) FROM TRADE UNIONS AND HIGH (Negro) FULL (Youth). YOU MAY INCLUDE IMP [REDACTED] INTO YOUR NERO (Forum) LAND (Delegation) OR INTO YOUR QUOTA SINCE GAY'S (Reshetov) COMMITTEE CANNOT PAY FOR HIS EXPENSES OTHERWISE. (Number) 6. On 7/28/64, there was received from the Soviets a ciphered-coded radio message, the plain text of which is as follows:

"1. The CPSU Central Committee invited to the USSR for a rest in 1964, 23 CPUSA members. Until now, 4 CP members were in the Soviet Union, Jack Brooks and his wife, Ralph Green and [redacted] In accordance with your request, the USSR Embassy in Washington, D.C. was instructed to give visas to Elizabeth Gurley Flynn, Hyman Lumer, [redacted] Epstein and his wife. John Apt and Jessica Smith are not included in quota since they are invited by the USSR Friendship Society. So you still have 14 vacancies.

"2. We were informed that Herb Aptheker would like to visit USSR with his wife to participate in the work of the International Anthropologists Conference. Preparatory committee is interested in his arrival to take part in discussion on Negro question, but committee cannot pay his expenses. If you are in favor of his visit to the USSR, we are ready to include him and his wife in your quota.

"3. We would like to remind you that quota is given for rest. If you have possibility to send no il to USSR, a delegation of leading CPUSA members, including members of state or city level, to acquaint them with our life and CPSU work, we are ready to consider this question additionally.

"4. Please send 25 copies of 'The Worker' directly to Shields not to International Books.

"5. Reshetov's Committee may pay travel expenses for 4 participants of Forum. Reshetov asks to include, if possible, in delegation delegates from trade unions and Negro youth. You may include  in your Forum delegation or in your quota since Reshetov Committee cannot pay for his expenses otherwise.

"6. We heard that Elizabeth Gurley Flynn planned to arrive in USSR on August 1st. Please confirm."

It would appear that part 3 of the said message is not clear, being either garbled or incorrectly phrased. NY 694-S\* and CG 5824-S\* have been consulted with respect to the interpretation to be placed thereon. CG 5824-S\* stated the interpretation of this should be as follows:

"The CPSU will accept some CPUSA National Committee people for a rest, but the CPUSA should not try to send any people who are ill. If there are some members of the National Committee who need a rest, the Soviets are ready to consider some people additionally on a district and city level for a tour of the Soviet Union."

NY 694-S\* has agreed with this interpretation of the message.

With respect to part 5, it should be noted that in NY airtel dated 6/23/64, under the heading "Soviet Youth Activities", it is reported that RESHETOV, mentioned above, had advised NY 694-S\* in May, 1964, that the Soviets would sponsor a World Forum of Solidarity of Youth and Students in Moscow between September 16 and 23, 1964, and that they desired to invite to this conference members of American youth organizations.

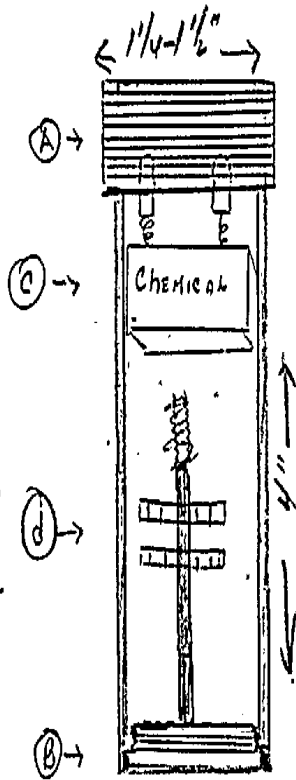

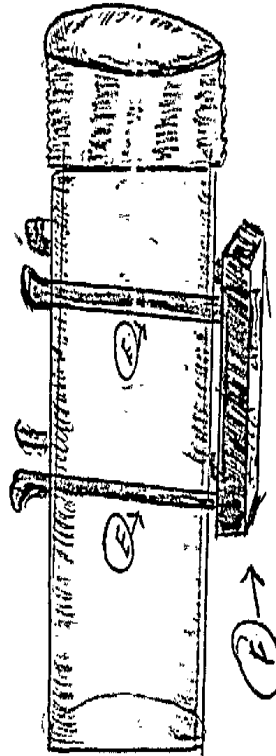
