This further responds to your Freedom of Information Act (FOIA) request of November 29, 2003 to the Federal Bureau of Investigation (FBI), for records concerning one Dr. Solomon Kullback, born April 03, 1907. On February 15, 2017, the FBI forwarded records and your request to this office, and they were received on February 21, 2017.

Coordination with another element of our command has been completed, and we have completed a mandatory declassification review in accordance with Executive Order 13526. As a result of this review, it has been determined that the records no longer warrants security classification protection and is partially releasable to you. The record is enclosed for your perusal.

Information has been sanitized from the records that would result in an unwarranted invasion of the privacy rights of the individuals concerned. This information is exempt from the public disclosure provisions of the Freedom of Information Act (FOIA), per Title 5 U.S. Code 552 (b)(6).

The withholding of the information described above is a partial denial of your request. This denial is made on behalf of Major General Christopher S. Ballard, Commanding, U.S. Army Intelligence and Security Command, who is the Initial Denial Authority for Army intelligence investigative and security records under the FOIA. You have the right to appeal this decision to the Secretary of the Army. Your appeal must be postmarked no later than 90 calendar days from the date of this letter. After the 90-day period, the case may be considered closed; however, such closure does not preclude you from filing litigation in the courts. You should state the basis of your disagreement with the response and provide justification for a reconsideration of the denial. An appeal may not serve as a request for additional or new information. An appeal may only address information denied in this response. Your appeal is to be made to this office, for forwarding, as appropriate, to the Secretary of the Army, Office of the General Counsel.

23. SYNOPSIS

Solomon KULLBACK was born on 3 April 1907, in Brooklyn, New York (19), of Russian born naturalized United States citizens (15). SUBJECT attended high school in New York City, New York (1); City College of New York, New York City (15); Columbia University (1,15); and George Washington University, Washington, D. C. (1,15).

Since 1930, SUBJECT has been employed as a school teacher in New York City (1,15), a civilian employee of the United States Army Signal Corps (1,3,15), and served with the Signal Corps during the Second World War (3,15,19). After the Second World War, KULLBACK, a mathematician (1,3,10,11), was re-employed by the United States Army Signal Corps in a civilian capacity (7,15). During the evening, SUBJECT is a professor at George Washington University, Washington, D. C. (3,7,10,11,15).

During the course of this investigation, nine acquaintances of KULLBACK could furnish no adverse information concerning SUBJECT, and recommended him for

a position of trust and confidence with the United States Government (1,5,7,8,9,10,11,12,13). One Source advised that SUBJECT, while serving in the Armed Forces, attempted to have Source's son assigned to a Signal Corps installation in Virginia; however, while at SUBJECT's home previous to this assignment, Source was advised by SUBJECT's wife that KULLBACK had been offered \$5,000 from an unnamed individual to effect the assignment of this individual's son to the Signal Corps project in Virginia. Believing this to be an indication that payment was desired for the special assignment of his son, Source said no more of the anticipated transfer. This Source further advised that KULLBACK's wife's family had a record of Communist affiliations (3). A previous investigation of KULLBACK completed on 14 November 1950, disclosed that it was alleged that SUBJECT, while a Lieutenant Colonel in the United States Army Signal Corps, had attempted to solicit a \$2,000 bribe to provide a preferred assignment for an army enlisted man. In subsequent investigation of this allegation, it was disclosed that SUBJECT had allegedly obtained employment in a sensitive position for an individual later determined to be KULLBACK's brother-in-law. The brother-in-law was alleged to have affiliated with the Communist Party. Due to the fact that investigation did not substantiate these allegations, no action was taken (14b,19). The Source of the foregoing information, in both investigations, was the same individual, who can possibly be identified with a person who joined the International Workers Order in April 1939 (4).

An investigation of KULLBACK's brother-in-law, Simon Mirin, completed in 1944, by a reliable government agency, disclosed that Mirin consorted and was in full sympathy with known Communists while at the City College of New York; participated in Communist demonstrations; and was alleged to have been a member of the Young Communist League from 1933 until 1940 (31a). This investigation further disclosed that Mirin's mother, Annie Mirin, mother-in-law of SUBJECT, was known by neighbors as a "red hot Communist", and that Annie Mirin had registered as a member of the Communist Party during 1935 and 1936, and the American Labor Party from 1937 through 1942 (31b). Isador Mirin, Simon Mirin's brother and SUBJECT's brother-in-law, was a member of the Abraham Lincoln Brigade, this investigation disclosed (31c). Simon Mirin listed one b6, a known Communist, as a character reference (31d).

Investigation disclosed that SUBJECT does not maintain a close relationship with his wife's family (5,7,8,10,11).

SUBJECT's brothers-in-law, Isador Mirin and Simon Mirin, are the operators of the Woodmoor Cleaners in Silver Spring, Maryland (7).

One character reference, listed by SUBJECT, was, in 1940, associated with groups whose interests were alleged to be inimical to the best interests of the United States Government (22). The names of other indicated character

references were checked through the indices of this office with negative, nonderogatory, or non identifiable results (2,20,21,23,24).

Indices of this office reflect no record of SUBJECT's father, brother, sister, wife, son, or cousins (25,27,28,29,30,33,34); however, information is reflected that one b6, who is possibly identifiable with SUBJECT's mother, rented a post office box in Miami, Florida, in 1951, for the use of the Southern Women for Peace, a Communist front organization (26).

Known organizations in which SUBJECT has held membership, or has been affiliated, were checked through the files of this office with negative or nonderogatory results (16).

Pertinent local and national law enforcement and other investigative agencies were examined concerning SUBJECT with negative or nonderogatory results (18).

4. REPORT OF FINDINGS

1. (Character Reference) On 23 October 1953, [b6], Technical Director of the Office of Production, National Security Agency, was interviewed in his office, 1012B, National Security Agency, Arlington Hall Station, 4000 Arlington Boulevard, Arlington, Virginia, regarding Dr. Solomon KULLBACK.

[b6] stated that he has known KULLBACK since 1923 or 1924. [b6] and KULLBACK attended the same high school in New York, and also attended Columbia University in New York and George Washington University in Washington, D. C., together. After graduation from Columbia, SUBJECT taught grammar school in the New York school system. KULLBACK and [b6] came to Washington, D. C. together and were employed by the Signal Corps at the same time. [b6] stated that SUBJECT's major interest is the field of mathematical statistics. KULLBACK is an instructor at George Washington University in Washington, D. C. According to Source, KULLBACK is a member of the American Society of Mathematical Statisticians and the Columbia Mathematical Society, which meets at George Washington University. [b6] knows of no other organizations of which SUBJECT is a member. According to [b6], neither he nor KULLBACK are very interested in politics. [b6] has never discussed politics to any great length with KULLBACK and he has never heard KULLBACK express sympathy for any form of government other than that of the United States. [b6] believes KULLBACK is a completely loyal citizen of the United States. Source does not believe SUBJECT has ever been in any trouble with the authorities. Source knows of nothing which would reflect adversely upon SUBJECT's loyalty, character, integrity, or discretion. [b6] recommended KULLBACK for a continued position of trust and confidence with the Government of the United States. (F-3)

2. (Agency) On 4 March 1954, the name files of the Assistant Chief of Staff, G-2, Military District of Washington, Washington, D. C., were reviewed regarding **b6** and it was reflected that a dossier, number DX-7158492, concerning **b6**, is on file at the Central Records Facility, Fort Holabird, Baltimore 19, Maryland.

On 31 March 1954, this dossier was reviewed and it was revealed that investigations dated 28 February 1942 and 17 November 1951, were conducted by the Assistant Chief of Staff, G-2, Military District of Washington, Washington, D.C., regarding **b6**. During the course of these investigations, birth records, two employment records, Army Service Records, ten references and acquaintances, two credit records and appropriate files of local and national investigative and law enforcement agencies were interviewed or examined. No information reflecting adversely on **b6** character, integrity, discretion or loyalty was revealed. (B-2)

4. REPORT OF FINDINGS

3. (Developed Reference) On 4 February 1954, [b6], Interior Decorator, who resides at [b6], was interviewed at [b6], Washington, D. C., and stated substantially the following pertinent information regarding Solomon KULLBACK:

[b6] and KULLBACK and the immediate members of their families were neighbors and close friends from 1933 to 1943. From 1933 until 1937, [b6] and KULLBACK occupied adjoining apartments at [b6], Washington, D. C., and from 1937 through 1941 they resided in the same neighborhood in northwest, Washington, D. C. Because of a common ethnic background and a community of interests, they were close friends and often shared personal confidences. Since 1943, Interviewee and SUBJECT have been on unfriendly terms and do not speak to each other.

From 1933 to 1943, KULLBACK was employed as a professor at George Washington University, Washington, D. C.; as a mathematician with the Signal Corps, United States Army and as an officer in the Signal Corps, United States Army.

During 1943, SUBJECT was serving on active duty as a Major in the United States Army Signal Corps at a signal installation in Arlington, Virginia. He was aware that [b6] son, [b6], was attending the Capitol Radio Engineering Institute, 3224 16th Street, N. W., Washington, D. C., and that [b6] was to be inducted into the Armed Forces upon the completion of his course at the Capitol Radio Engineering Institute. KULLBACK suggested that he, KULLBACK, be informed by [b6] when and where his son was to report for induction, whereupon KULLBACK would write to the induction center and request that [b6] be assigned to an installation named Wentel, located at Winchester, Virginia, where presumably [b6] would remain during the entire war. SUBJECT added that he was personally acquainted with the commanding officer at Wentel and was aware that the commanding officer was in need of men with [b6]'s background in radio. KULLBACK professed to believe that this assignment would be easily effected if [b6] would intentionally make poor scores on his classification battery examinations at the induction center, thus eliminating the possibility that the classification officer might desire to assign him to a school or specialized assignment. Shortly thereafter, [b6] son, [b6], was inducted in the United States Army at Camp Lee, Petersburg, Virginia. While [b6] was at Camp Lee, Interviewee visited SUBJECT and his wife. During KULLBACK's temporary absence from the room, KULLBACK's wife, [b6], confided to [b6] that SUBJECT had received an offer of \$5,000 from an unnamed individual to effect the assignment of this individual's son to Wentel, but that since this unnamed individual's son had no radio experience, it was impossible. [b6] received the impression that this was [b6] method of informing him that a payment was expected in return for KULLBACK's effort to have [b6] son

assigned to Wentel. [b6] did not pursue the conversation further and made no mention of it to SUBJECT. KULLBACK never alluded to any knowledge of this conversation and never directly or indirectly solicited [b6] for any monetary payment or gratuity in return for his effort to effect the assignment of [b6] to Wentel.

A few days later, [b6] received a letter from his son stating that he had been assigned to the Infantry. [b6] immediately contacted KULLBACK and demanded an explanation. SUBJECT stated that he had requested [b6] assignment to Wentel, but that "a sergeant had misplaced the papers". [b6] arrived at the conclusion that KULLBACK had "double-crossed" him. During the succeeding days, [b6] became highly distraught, especially when he realized that his son, [b6], who had wanted to become an officer, was unable to even apply for Officer's Candidate School because of the low scores he had intentionally made on the battery classification examinations when he was inducted. [b6] was firmly convinced that KULLBACK was to blame for the whole situation and was determined to make him pay. Therefore, [b6] went to one General Stone, who was then Chief of the Signal Corps, United States Army and related the story to him. [b6] also revealed that SUBJECT had obtained a job for Simon Mirin, SUBJECT's brother-in-law and that [b6] had a Communist background. [b6] had become aware that some of the immediate members of the family of KULLBACK's wife had a record of Communist affiliations through previous conversations with KULLBACK and his wife, both of whom had deplored the fact. When [b6] was asked by this Agent whether he, [b6], had ever alleged either verbally or in writing that KULLBACK had solicited [b6] for a bribe, [b6] replied in the negative. When this Agent stated that he had received the impression, perhaps mistakenly, that [b6] at the time of the foregoing incident had made an allegation to the effect that KULLBACK had solicited him for a bribe, [b6] reiterated that on no occasion had KULLBACK asked him for a monetary consideration or gratuity in return for attempting to effect the assignment of [b6] to Wentel; consequently, [b6] added that in his distraught condition he, [b6], may have exaggerated his charge against KULLBACK.

During the ten years that [b6] and KULLBACK were on friendly terms, [b6] found SUBJECT to be discreet and devoted to his family. KULLBACK was politically conservative and was inactive in political affairs. [b6] believes SUBJECT to be entirely loyal to the United States and its institutions, but he declined to make any recommendation as to whether KULLBACK should be considered for a position of trust and responsibility with the government because of the foregoing incident. (F-6)

AGENT'S NOTES: [b6] was extremely nervous throughout the interview and was very reluctant to discuss the incident in which he and KULLBACK were involved. It was evident throughout the interview that [b6] would have gone to any lengths to (continued)

protect his son, [b6], from the hazards of combat duty. Based on the facts at hand and the impressions received during the course of the interview conducted in this investigation, this Agent has serious doubts as to whether KULLBACK ever attempted to solicit a bribe from [b6].

4. (Agency) On 17 May 1954, pertinent files of the Assistant Chief of Staff, G-2, Military District of Washington, Washington, D. C., were examined regarding [b6], who was interviewed during the course of this investigation. It was revealed that the files of a confidential government investigative agency reflect that one [b6] [b6], who may or may not be identical to the [b6] interviewed during the course of this investigation, became a member of Lodge 528 of the International Workers Order during April 1939. The International Workers has been cited as a subversive organization by the Attorney General of the United States. (B-2)

5. (Developed Reference) On 8 February 1954, [b6] [b6] who resides at [b6], was interviewed in her residence at that address and stated the following pertinent information regarding Solomon KULLBACK:

[b6] has known SUBJECT and his wife, [b6], as neighbors and weekly social acquaintance since 1940. KULLBACK's family consists of himself, his wife and two children, a son who attends George Washington University, Washington, D. C., and a teen-age daughter who attends Coolidge High School, Washington, D. C. For the past several years, KULLBACK has been employed by the government in a capacity unknown to [b6]. He is also a professor at George Washington University, Washington, D. C. SUBJECT has no near relatives in the Washington, D. C., area, but KULLBACK's wife has two brothers, "Bill" and "Si" Mirin who operate a cleaning establishment in the Washington area, and "Annie" Mirin, SUBJECT's mother-in-law, resides in Washington, D. C. [b6] has had no opportunity to ascertain the political leanings of KULLBACK, his wife, or the immediate members of Mrs. Kullback's family, but she has never heard or seen anything which would cause her to doubt that they are all loyal Americans. The relationship between SUBJECT and his "in-laws" is not close and is confined to infrequent visits at their respective homes. [b6] doubted that KULLBACK is affiliated with any organization, other than the Parent Teachers Organization. [b6]'s organizational affiliation is confined to Hadassah, an organization of women of Jewish ethnic origin, the nature of which is primarily social. Within the limit of her acquaintance, [b6] believes SUBJECT to be loyal to the United States and she recommended KULLBACK for a position of trust and responsibility with the United States Government. (F-6)

AGENT'S NOTES: Annie Mirin and "Si" (Simon) Mirin, SUBJECT's mother-in-law and brother-in-law respectively, are referred to in Agent Report #31 as having had a previous record of Communist affiliations.

6. (Organization) On 10 December 1953, the files of the Assistant Chief of Staff, G-2, Military District of Washington, Washington, D. C., were examined concerning Hadassah and revealed the following information in substance:

Hadassah (Women's Zionist Organization of America), headquarters at 1819 Broadway, New York City, New York, was organized in 1912 to support projects in Palestine and to carry on an educational program in America. Hadassah registered with the Secretary of State for the solicitation and collection of contributions to be used for relief in belligerent countries - Palestine - on November 15, 1939. Junior Hadassah is the youth branch of Hadassah. In February 1951, it was reported that the National Board of the Women's Division of the Jewish Peoples Fraternal Order (cited by the Attorney General, 1950) had recently instructed its members to "join such organizations as Hadassah, the American Jewish Congress and parent-teacher associations clandestinely and to propagandize within those organizations for progressive ideas." In October 1953, at the 39th Annual, Haddassah Convention, speakers attacked congressional committees for "aiming their appeal principally to fear." (B-2)

Hadassah does not fall within the purview of Executive Order 10450 as designated by the Attorney General of the United States.

AGENT'S NOTES: During the conduct of this investigation, an interview with [b6], revealed that KULLBACK's wife is affiliated with Hadassah.

The Mirins are occasional guests in SUBJECT's home during the Summer months, but b6 doubts that KULLBACK maintains a close relationship with anyone in the Mirin family, other than his wife. b6 has had no acquaintance with the Mirin family other than to speak to them when they have been guests of SUBJECT, and consequently was unable to form any opinion regarding their political orientation or their loyalty to the United States.

KULLBACK is employed by the United States Army Signal Corps during the day and teaches at George Washington University, Washington, D. C., during the evening. (3) During the investigation, SUBJECT denied all the charges made by b6. He admitted that Simon Marens (identified as Simon Mirin) was his brother-in-law, but denied that he had used any influence in helping his brother-in-law obtain a position at Fort Monmouth.

(4) No further action was recommended by the investigating officer, which was concurred by the Deputy Inspector General, Department of the Army, on 15 November 1944. AGENT'S NOTES: See Agent Report #19 reviewing SUBJECT's 201 file located in The Office of the Adjutant General, wherein, substantially the same information as above is reported. The following information was obtained from SUBJECT's 201 File:

A letter, dated 20 October 1944, from [b6] to the Adjutant General's Office, War Department, Washington, D. C., accuses SUBJECT of offering to help [b6]'s son, [b6] to get a good position in the Signal Corps, at a secret broadcasting station, Wentel, located near Winchester, Virginia, but that this aid would cost [b6] \$2000.00. [b6] refused to pay and due to that his son [b6] was assigned to the Infantry. He goes on to say that "I have been informed, and I believe it to be true, that Lieutenant Colonel Kullback placed a man by the name of Simon Marens at Camp Monmouth, New Jersey. He is there supposedly as an essential employee, but he actually is there to avoid the draft. He is 24 years old and he's a New York Communist."

An investigation on these allegations was conducted and it was found that SUBJECT was acquainted with the [b6] family and that he did initiate a written request for the transfer of Pvt [b6] to the Signal Corps, but the request was disapproved. It was noted that this request was dated and forwarded after the date that [b6] contends that he refused to pay SUBJECT for his aid. Later, [b6] obtained a letter of recommendation from SUBJECT requesting his son's transfer to the Signal Corps. It was further noted that [b6] had talked with several people about SUBJECT's attempts to secure the transfer, but never made any mention of an attempted bribe until four months after the conversation regarding a bribe was alleged to have taken place. Testimony adduced shows that [b6] had been brooding over his son's assignment to the Infantry and it is considered that the allegations are figments of his imagination induced by a long period of worry and suspense. It was ruled no further action be taken against SUBJECT. (B-2)

30. (Agency) On 2 February 1954, the name files of the Assistant Chief of Staff, G-2, Military District of Washington, Washington, D. C., were reviewed regarding **b6**, SUBJECT's wife. No record concerning Minna Kullback, nee: Mirin, was revealed. (B-2)

31. (Agency) On 3 February 1954, the name files of the Assistant Chief of Staff, G-2, Military District of Washington, Washington, D. C., were reviewed regarding Simon Mirin, KULLBACK's brother-in-law, and a file, number DX 7104499, was revealed. On 4 February 1954, the above mentioned dossier was reviewed and the following pertinent information was reflected:

a. An investigation dated 7 January 1944, file number II-c7517, Subject: Mirin, Simon; Senior Engineering Aide (Radio) SP-6, Camp Evans, New Jersey, whose date of birth was indicated to be variously 24 and 25 November 1916, was conducted by the Office of the Director, Security and Intelligence Division, Second Service Command, War Department, Governors Island, New York, and it was revealed that Mirin reportedly consorted and was in full sympathy with known Communists while he was a student at City College, New York, New York; that Mirin reportedly participated in a Communist inspired anti-Fascist demonstration at City College, New York, New York, on the occasion of a visit by an Italian student delegation; and that Mirin allegedly was a member of the Young Communists' League during the period from 1933 to 1940.

b. The above mentioned investigation also indicated that Simon Mirin's mother, Annie Mirin, nee: Fishbein, was well known in her neighborhood as a "red hot Communist"; and that Annie Mirin, nee: Fishbein, was listed in the records of the Board of Elections, Borough of Bronx, New York, Tremont Avenue and Third Avenue, Bronx, New York, as a registered member of the Communist Party during the calendar years 1935 and 1936, and as a registered member of the American Labor Party during the calendar years 1937 through 1942.

c. The above mentioned investigation further reflected that Simon Mirin's brother, Isadore Mirin, who was born on 1 January 1915, in Salem, Massachusetts, reportedly fought during the Spanish Civil War as a member of the Abraham Lincoln Brigade of the Loyalist Army. Isadore Mirin, in a sworn statement to his draft board, Local Board 97, 1738 Crotona Park East, Bronx, New York, on 9 December 1941, stated, "I was in Spain during the Civil War.....I was there for a year and a half".

d. The above mentioned investigation also noted that a character reference listed by Simon Mirin, one **b6**, was listed in the files of the National Federal Bureau of Investigation as a known Communist. (B-2)

AGENT'S NOTES: The Abraham Lincoln Brigade has been cited by the Attorney General of the United States as a subversive organization (Communist).
