Dear Mr. Greenewald:

This is the final response to your enclosed Freedom of Information Act (FOIA) request dated August 2, 2013. Your request was received in this office on August 2, 2013 and assigned FOIA case number 13-F-1223.

Mr. Will Kammer, an Initial Denial Authority for the Office of Freedom of Information, has determined that certain information which has been redacted from the documents on the enclosed CD is exempt from release pursuant to 5 U.S.C. § 552(b)(5), which pertains to certain inter- or intra-agency communications protected by the deliberative process privilege and 5 U.S.C. § 552(b)(6), which pertains to information the release of which would constitute a clearly unwarranted invasion of the personal privacy of individuals.

Also included on the CD you will find the Department Level Interest list. Please note that a list did not exist prior to November 2012.


Each of the military services and various Department of Defense components are responsible for processing of their own FOIA requests, and the agencies on the list provided have cognizance over the records listed. We have provided a list of those agencies at Enclosure 1.

As this office processes FOIA requests for the Office of the Secretary of Defense and the Joint Staff (OSD/JS), we will only respond for the OSD/JS portion of the request. With this list, please let us know the specific information of interest by citing the FOIA request number. This should help narrow the focus to provide a more timely response. We believe that a significant amount of time can be saved by eliminating the search and review of records that are of no interest, and process the specific documents of most interest to you. If we do not hear from you by October 17, 2014, we will deem that you are no longer interested, and your request will be administratively closed.

If you are not satisfied with this action, you may petition the Appellate Authority, the Director of Administration, Office of the Secretary of Defense, by writing directly to the OSD/Joint Staff Freedom of Information, ATTN: Appeals Office, 1155 Defense Pentagon, Washington, D.C. 20301-1155; you may also submit your appeal electronically at the following link: <http://pal.whs.mil/palMain.aspx>. Your appeal should be postmarked within 60 calendar days of the date of this mail, should cite case number 13-F-1223, and should be clearly marked

"Freedom of Information Act Appeal." Your request is now closed in this Office. There are no fees associated with this response.
