Dear Mr. Greenewald:

I am writing in response to your Freedom of Information Act request for a copy of the USCENTCOM FOIA Case Log for the fiscal year 2008.

We conducted a thorough search for records and found two responsive documents. After a thorough review of the information, I have determined that portions of the documents are exempt from release. The information withheld protects names of personnel overseas in deployable units, and personal privacy information pursuant to 5 U.S.C. § 552 (b)(3), as it relates to 10 U.S.C. § 130b, and (b)(6).

Accordingly, in my capacity as the Initial Denial Authority, by withholding this information, I am partially denying your request. All fees are waived for this request. If you are not satisfied with this action, you may appeal to the appellate authority, the Director of Administration and Management, Office of the Secretary of Defense. To submit your appeal, you should write directly to the Defense Freedom if Information Policy Office, Attn: Mr. James Hogan, 1155 Defense Pentagon, Washington, D.C. 20301-1155. Your appeal should be postmarked within 60 calendar days of the date of this letter, should cite to case number 09-0147, and should be clearly marked "Freedom of Information Act Appeal."
