This refers to your September 13, 2012, Freedom of Information Act (FOIA)/Privacy Act (PA) request, by which you seek a copy of the FOIA case logs for the calendar years 2010 and 2011. This Headquarters received your request on September 13, 2012.

In an effort to assist you, we initiated a search of the Headquarters Marine Corps FOIA database. As a result, this search revealed 56 pages of records that are responsive to your request. Our review of those pages revealed that they contain personal information about others that, if disclosed, would constitute a clearly unwarranted invasion of their personal privacy. Because the FOIA precludes the disclosure of this type of information [5 U.S.C. § 552(b)(6) as amended], the applicable personal information has been redacted and is denied. A copy of the 56 responsive pages, disclosing all releasable portions, is attached at the enclosure.

Thank you for your patience throughout this process as the Headquarters Marine Corps FOIA office has been working through a back-log of 300+ cases due to being reduced to less than 50 percent staffing. As a result of the ending of the Federal Government hiring freeze, staffing is back to 100 percent and the back-log is back to manageable levels and such case congestion will not be a problem for future requests.

In view of the above, you may consider this to be an adverse determination that may be appealed to the Judge Advocate General (Code 14), 1322 Patterson Avenue SE, Suite 3000, Washington Navy Yard, DC 20374-5066. Your appeal, if any, must be postmarked within 60 calendar days from the date of this letter to be considered and should include a copy of your initial request, a copy of this response, and a statement indicating why you believe your appeal should be granted. I recommend that your appeal and the envelope both bear the notation "Freedom of Information Act Appeal."

Be advised that we have categorized you as an "Other Requester" for the purpose of assessing FOIA processing fees. As such, you are entitled to two hours of search and 100 pages of duplication free of charge. In this instance, your request did not exceed your free entitlement.
