Dear Mr. Greenewald:

This is in response to your January 1, 2017 Freedom of Information Act (FOIA) request seeking access to records maintained by the Treasury Inspector General for Tax Administration (TIGTA). Specifically, you are requesting "a copy of records, electronic or otherwise, of the FOIA Case Log for Calendar year 2016." TIGTA's Disclosure Branch received your request on January 3, 2017.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. § 552(c) (2006 & Supp. IV 2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

The Calendar Year 2016 FOIA Log consists of thirteen (13) pages, and we are releasing it in full.

Since the cost incurred to process your FOIA request was less than \$25.00, the threshold set by Treasury's FOIA regulation, no fees were assessed.
