Dear Mr. Greenwalde:

This is the final response to your January 1, 2017 Freedom of Information Act (FOIA) request to the U.S. Department of Agriculture (USDA) Department FOIA Office (DFO). You requested a copy of records, electronic or otherwise, of the FOIA Case Log for calendar year 2016. Your request was received in this office on January 3, 2017.

Your request has been processed under the FOIA, 5 U.S.C. § 552.

A search was conducted in USDA's Enterprise-Wide FOIA Tracking Database for records responsive to your request. The search yielded a total of twenty-two (22) pages. After review, the DFO has determined that nineteen (19) pages are being released in full. Portions of three (3) pages were withheld pursuant to FOIA Exemption (b)(6) as described below.

**Personal Privacy Interests**  
**Exemption 5 U.S.C. §552(b)(6)**

Exemption (b)(6) of the FOIA permits the government to withhold information regarding individuals in "personnel and medical files and similar files" when the disclosure of such information "would constitute a clearly unwarranted invasion of personal privacy" and where such privacy interests outweigh any public interest which would be advanced by the disclosure of their names.

As for "similar files," as per the information located at  
[http://www.justice.gov/sites/default/files/oip/legacy/2014/07/23/exemption6\\_0.pdf](http://www.justice.gov/sites/default/files/oip/legacy/2014/07/23/exemption6_0.pdf),

"In *United States Department of State v. Washington Post Co.*, 456 U.S. 595 (1982), the United States Supreme Court held, based upon a review of the legislative history of the FOIA, that Congress intended the term "similar files" to be interpreted broadly, rather than narrowly. *Id.* at 599-603 (citing H.R. Rep. No. 89-1497, at 11 (1966); S. Rep. No. 89-813, at 9 (1965); S. Rep. No. 88-1219, at 14 (1964)). The Court stated that the protection of an individual's privacy "surely was not intended to turn upon the label of the file which contains the damaging information." *Id.* at 601 (citing H.R. Rep. No. 89-1497, at 11 (1966)); see *Judicial Watch, Inc. v. FDA*, 449 F.3d 141, 152 (D.C. Cir. 2006) ("The Supreme Court has read Exemption 6 broadly, concluding the propriety of an agency's decision to withhold information does not 'turn upon the label of the file which contains the damaging information.'" (quoting *Wash. Post*, 456 U.S. at 601)). Rather, the Court made clear that all information that "applies to a particular individual" meets the threshold requirement for Exemption 6 protection."

In order to determine whether Exemption (b)(6) applies to responsive information to prevent a clearly unwarranted invasion of personal privacy, the privacy interests of affected individuals are balanced against the public interest in disclosure. For the purposes of the FOIA, the public interest is advanced when disclosure of the requested information educates the public about the activities of the government. The DFO has determined that the aforementioned individuals have privacy interests in allegations and/or events related to employment that are more than *de minimis*.

You have the right to appeal this determination. Should you wish to do so, you must send your appeal, within 90 days from the date of this letter, to: Assistant Secretary for Administration, USDA, 1400 Independence Avenue, S.W., Whitten Building 209-A, Washington, D.C. 20250-0103. Your envelope and letter should be marked "FOIA Appeal." Copies of the FOIA and USDA regulations are available at [www.dm.usda.gov/foia](http://www.dm.usda.gov/foia).

The Office of Government Information Services (OGIS) also mediates disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to litigation.
