Under authority of the Freedom of Information Act at 5 U.S.C. 552(b)(6) and the Department's implementing regulation at 45 CFR 5.67, names and other information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, were deleted from these documents.

You have the right to appeal this decision to deny you full access to agency records. Send your appeal, within 30 days from the date you receive this letter, to the Deputy Assistant Secretary for Public Affairs (Media), U.S. Department of Health and Human Services, Room 17-66, 5600 Fishers Lane, Rockville, Maryland 20857. Please mark both your appeal letter and envelope "FOIA Appeal."
