Dear Mr. Greenewald:

This is in response to your Freedom of Information Act (FOIA) request for a copy of the "FOIA Case Log for calendar year 2016." We received your request on January 1, 2017 and assigned it case number DODOIG-2017-000194.

The attached documents are responsive to your request. I determined that the redacted portions are exempt from release pursuant to 5 U.S.C. 552 (b)(6), the release of which would constitute a clearly unwarranted invasion of personal privacy.

In view of the above, you may consider this to be an adverse determination that may be appealed. Since you have created an account in FOIAonline, you may submit an appeal directly within the web-based system. To do this, you would log in to your account, retrieve your original request, and then click on the "Create Appeal" tab in the left-hand column. The basic information from your request will be duplicated for you, and then you can type in the basis of your appeal. If you prefer to use regular mail, you may submit an appeal to Department of Defense, Office of Inspector General, ATTN: FOIA Appellate Authority, Suite 10B24, 4800 Mark Center Drive, Alexandria, VA 22350-1500. Your appeal, if any, must be postmarked within 90 days of the date of this letter and should reference the file number above. I recommend that your appeal and its envelope both bear the notation "Freedom of Information Act Appeal."

You may seek dispute resolution services and assistance with your request from the DoD OIG FOIA Public Liaison Officer at 703-604-9785, or the Office of Government Information Services (OGIS) at 877-684-6448, <u>ogis@nara.gov</u>, or <u>https://ogis.archives.gov/</u>. Please note that OGIS mediates disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to litigation. However, OGIS does not have the authority to mediate requests made under the Privacy Act of 1974 (request to access one's own records.)
