This is an interim response to your Freedom of Information Act (FOIA) request dated October 17, 2013, and received in this Office on October 17, 2013, for "a copy of the first 200 pages of emails received by Melanie Ann Pustay, Director of the Office of Information Policy, that contain the word "FOIA" between July 2012 and November 1, 2012." This response is being made on behalf of the Office of Information Policy.

Please be advised that a search has been conducted in the Office of Information Policy (OIP) and approximately 200 pages of emails were located that are responsive to your request. Director Pustay was on leave for the beginning of July 2012, therefore we considered emails that Ms. Pustay responded to beginning on July 16, 2012, the first day Director Pustay was back in the office, as responsive and went forward from that date. Nonetheless, many of the email chains contain prior emails that were received during the period she was out of the office. I have determined that thirty-eight pages are appropriate for release without excision and copies are attached. I have also determined that seventy-eight pages are appropriate for release with excisions made pursuant to Exemption (b)(5) of the FOIA, 5 U.S.C. § 552(b)(5), which pertains to certain inter- and intra-agency communications protected by the deliberative process privilege and the attorney work-product privilege. Information is also being withheld under Exemption (b)(6) of the FOIA, 5 U.S.C. § 552(b)(6), which pertains to information the release of which would constitute a clearly unwarranted invasion of the personal privacy of third parties. Additionally, twenty-eight pages of emails are being withheld in full pursuant to Exemptions (b)(5) and (b)(6) of the FOIA. For your information, the withheld materials consist of the contact information for non OIP employees and third parties, deliberative discussions and attorney work-product material.

Finally, since five pages of emails originated with the Justice Management Division (JMD), the Environmental Protection Agency (EPA), and the Internal Revenue Service (IRS), we referred that material to those entities for processing and direct response to you. Contact information may be located at www.FOIA.gov should you wish to contact JMD, EPA, or IRS.

Please be advised that we are continuing our processing of the remaining pages and will make a final response once our consultations are completed. I apologize for the delay.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. 552(c) (2012). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

If you are not satisfied with my response on behalf of OIP, you may administratively appeal by writing to the Director, Office of Information Policy, United States Department of Justice, Suite 11050, 1425 New York Avenue, NW, Washington, DC 20530-0001, or you may submit an appeal through this Office's eFOIA portal at http://www.justice.gov/oip/efoia-portal.html. Your appeal must be postmarked or transmitted electronically within sixty days from the date of this letter. If you submit your appeal by mail, both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."





Thank you for the opportunity to comment on the Draft Assessment of Federal Departments and Agencies 2012 Chief FOIA Officer Reports. The Department of the Interior takes its FOIA responsibilities very seriously, and it is in that spirit that we would like to address our comment.

We are gratified to note that you have marked the Department's goals as green, or "achieved," in all but one area of the report. As to that area, which deals with increases in full disclosures, we were rather surprised to see that this goal had been marked red, or "not achieved." While we fully recognize that our number of full grants went down this year (albeit by less than 1%), we do not believe that this shows a lack of progress by the Department. As we stated in our Departmental narrative on this point (pages 14-15 of our Report), the Department deals with a great number of large and complex requests. Withholding (often, quite small) portions of the materials responsive to these requests unfortunately is sometimes necessary to prevent a foreseeable harm to one or more the interests protected by FOIA's exemptions. The Department endeavors to ensure that these withholdings are carefully considered and appropriate. We therefore do not believe that our release of a slightly smaller number of requests in FY 2011 than FY 2010 means we did not make progress towards our goals of increased transparency and openness.



The program contains a discussion of both the procedural requirements of the FOIA and its nine exemptions. This program is designed as an introduction to the law for FOIA professionals.

Dear Ms. Melanie Pustay,

I am the Public Policy fellow at Project On Government Oversight, and I have a few questions regarding simple FOIA processing that I hope you could answer. In reviewing the Department of Justice's recently published Summary of Agency Chief FOIA Officer Reports for 2012, POGO noticed the extraordinarily high number of average days it takes both USAID and the Department of State to respond to simple FOIA requests--147.66 days for USAID and 155 days for State.

I contacted both agencies to inquire about what may be causing these processing delays. In the responses I received, both agencies pointed to the extra time it takes for them to obtain records from around the world. Isn't it true that a "simple" FOIA request would, by definition, **not** require this kind of worldwide search? Why would an agency classify a request as "simple" if processing entails obtaining international records? And finally, does the definition of a simple FOIA request vary across agencies?



Guys -- let's go ahead now and be ready to update the FOIA Reference Guide on our OIP website to more completely describe the FOIA's exclusions. This is part of what our upcoming exclusion guidance will ask all agencies to do so I would like to have our website ready to go next week when the guidance comes out. Under the heading "Initial Request Determinations" we list the FOIA's nine exemptions and mention the three exclusions in the final sentence. Let's delete that final sentence and add something like the following language instead:

"Congress also provided special protection in the FOIA for three narrow categories of law enforcement and national security records. The provisions protecting those records are known as "exclusions." The first exclusion protects the existence of an ongoing criminal law enforcement investigation when the subject of the investigation is unaware that it is pending and disclosure could reasonably be expected to interfere with enforcement proceedings. The second exclusion is limited to criminal law enforcement agencies and protects the existence of informant records when the informant's status has not been officially confirmed. The third

exclusion is limited to the FBI and protects the existence of foreign intelligence or counterintelligence, or international terrorism records when the existence of such records is classified. Records falling within an exclusion are not subject to the requirements of the FOIA. So, when a component responds to your request it will limit its response to those records that are subject to the FOIA. "

We should also include this language on FOIA.gov, wherever we discuss exemptions.

Let's do the coding so we are ready to go next week.





Federal Agencies Lagging on FOIA Processing-What's the Hold Up?

When the Office of Information Policy (OIP) at the Justice Department released its Summary of Agency Chief FOIA Officer Reports for 2012 and subsequently published its Summary of Annual FOIA Reports for FY 2011 a couple weeks later, POGO reviewed both assessments closely. We applaud the nine federal agencies (out of the 99 subject to the Freedom of Information Act in FY 2011) that earned top marks on their FOIA program, meeting all seventeen milestones included in the Chief FOIA Officer Reports Summary. However, POGO was disappointed to see some particularly sluggish FOIA processing performances from others.

Here's a little background: In 1996, Congress passed the e-FOIA amendments (H.R. 3802), strengthening requirements for agencies to ensure timely responses to requests. To avoid prolonged delays for simple requests, Sec. 7 authorized multi-track processing. This means agencies can (and should) process simple and complex requests at the same time on separate tracks based on the amount of work or time involved—instead of on a "first-in, first-out" basis.



provided statistics on the average number of days it takes each agency to process a simple request—one that does not involve unusual or exceptional circumstances. OIP clarified for POGO that they are tracking when an agency has provided a substantive response to the requester, not just a response, such as an acknowledgement letter. So these stats represent how long it takes (simple) requesters to actually get the information they are seeking. Sixty agencies in the OIP assessment processed the requests within an average of 20 working days or less. But twenty-seven agencies had a simple track and still failed to meet that requirement. While many of those agencies' averages hovered just above 20 days, a few were shockingly high.

The Chief FOIA Officer Reports Summary indicated that it takes the Department of State and U.S. Agency for International Development (USAID) on average seven times longer to process a simple FOIA request than the 20-day legal limit for simple requests.

It takes State, for example, an astounding average of 155 days to process a simple request. When POGO asked why, a State Department spokesperson told us:

Unlike many other agencies that operate only domestically, the Department of State maintains records both domestically and at hundreds of posts (embassies and consulates) located throughout the world. FOIA requests made to the Department vary in size from very narrow requests for a single document to requests that are voluminous in size and complex in scope, requiring the review of thousands of documents, frequently retrieved both domestically and at posts overseas. Many of the Department's records contain sensitive national security information. The review of responsive records is undertaken by subject matter experts, often including coordination with multiple offices within the Department, as well as with other Federal agencies and foreign governments. In recent years, the Department also experienced an influx in new FOIA referrals, which tripled the number of cases received and added to the workload.

Traditionally, the Department of State has responded to FOIA requests incrementally, with interim responses made to requesters as segments are completed instead of at the conclusion of processing; this results in requesters' receiving responses much faster than the total average processing time would indicate.

And when we reached out to a USAID official to inquire about why it takes them an average of **147.66** days to process a simple request, we got this response:

The United States Agency for International Development (USAID) is a global agency with missions in over 80 countries and therefore requires us to seek documents from around the world, not just from our Washington headquarters. In addition, the average number is high due to a small number of long outstanding requests. USAID continues to aggressively work on the backlog and to improve its response time and has made this a priority. USAID is very committed to the principles embodied in the FOIA and employs a strategy to improve overall FOIA administration. New targeted goals were established during FY2011 and new staff were added which led to a 51% reduction of the prior years' backlog.

State and USAID say they have to gather records from "hundreds of posts throughout the world" and "missions in over 80 countries." But the kinds of worldwide searches they describe are, by definition, not "simple" FOIA requests. We reached out to Director of OIP Melanie Pustay for more clarification, and she affirmed our understanding about the clear distinction between simple and complex requests.

Pustay stated that these agencies should not be using the simple track for requests that require worldwide searches:

The FOIA allows agencies to establish multiple tracks for processing requests so requests can be processed as efficiently as possible. In guidance issued to all agencies for use in preparing their Annual FOIA Reports, the Department of Justice defines the three most common tracks. One of those tracks is the "simple" track. A "simple" request is one that is placed in the fastest, non-expedited track "based on the low volume and/or simplicity of the records requested." The Office of Information Policy will reach out to the State Department and to USAID to discuss the criteria they are using to place requests in their "simple" track to ensure that they are properly characterizing those requests. [Emphasis added]

We are glad that Pustay pledged to take action, but we know the problem doesn't end with proper categorization of requests.

Even if these agencies start properly characterizing the complex requests as such, that won't do anything to speed up their processing time. According to OIP's Summary of Annual FOIA Reports, the average processing times for simple track requests across all departments and agencies was 23.65 days in FY 2011, and for complex track requests it was 103.74 days.

In the Summary of Annual FOIA Reports, OIP provided some additional data on how long it takes agencies and departments to process expedited FOIA requests. (FOIA processing should be expedited when an individual's life or safety would be jeopardized or if substantial due process rights of the requester would be impaired by the failure to process a request immediately.) According to OIP, expedited requests "can be either simple or complex in their scope, which causes comparisons to be necessarily imperfect."

OIP's summary indicated that in addition to winning the Razzie for highest average processing time for simple requests among the departments, the State Department reported the highest average processing time for expedited requests—an average of **926 days**. We have reached out to State for comment on the reasons behind these delays, and we will update you as soon as we receive a response.

926 days is more than two years of wait time—and that's for requests that constitute exceptional need or urgency. State clearly needs to fix the problem to ensure that requests don't end up in a black hole and the public has prompt access to critical information. We heard unofficially from an inside source that the State Department is working diligently to get their FOIA processing under control. We hope so!

Too often it takes far too long for requesters to receive the information they are seeking. Several months ago, POGO did our own (smaller-scale) <u>analysis</u>, leading us to conclude that some agencies are failing to even acknowledge receipt of FOIA requests within 20 days, as required by law. There is certainly room for improvement across the federal government, not only at the agencies with the highest averages according to OIP.

We'll keep you posted on the progress.

This is the final response to your Freedom of Information Act (FOIA) request dated October 17, 2013, and received in this Office on the same date, for "a copy of the first 200 pages of emails received by Melanie Ann Pustay, Director of the Office of Information Policy, that contain the word "FOIA" between July 2012 and November 1, 2012." This response is being made on behalf of the Office of Information Policy (OIP).

By letter dated December 10, 2015, we provided you with an interim response on 149 pages responsive to your request, and advised that we were continuing to process the remaining material responsive to your request. Our processing of these records is now complete, and I have determined that an additional fifty-two pages of emails are appropriate for release with excisions made pursuant to Exemption 5 of the FOIA, 5 U.S.C. § 552(b)(5), which pertains to certain inter- and intra-agency communications protected by the deliberative process attorney work-product privileges. Information is also being withheld under Exemption 6 of the FOIA, 5 U.S.C. § 552(b)(6), which pertains to information the release of which would constitute a clearly unwarranted invasion of the personal privacy of third parties. For your information, the withheld materials consist of the contact information for non-OIP employees and third parties, deliberative discussions and attorney work-product material. Although additional portions of the enclosed records could be withheld pursuant to Exemption 5, I have determined in some instances that such material may be disclosed as a matter of agency discretion.

Please be advised that the yellow highlighting on certain pages was present on the original documents.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. *See* 5 U.S.C. 552(c) (2012). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

Thanks so much for chatting with me. I am sending along three documents: the FOIA request that identifies a number of OLC opinions, our summary statistics comparing OLC opinions from the DOJ and website and FOIA document, and a list of OLC opinions excluded from the FOIA website (including whether we were able to find the opinion elsewhere on the Internet.)

As you know, the DOJ has instituted a presumption that opinions be fully and promptly available to the public. As a start, we'd like to see all of the opinions that have been publicly named to be available on the DOJ's website. Many of of them are available elsewhere online. In addition, it's likely that more have been released than we found in our initial review, so it would be great if the DOJ would check to see if other opinions have been identified by name and/or released to the public, and to list those reports and (except when impossible) publish them online.

We are going to continue digging to see if we can find other reports online, or identify other reports whose names have been released but aren't identified in the FOIA report. We know that there's 510 opinions from the FOIA report time period, so there's a lot more to find.

We're hoping to publish something on July 9th, so it would be great if we can report on any updates. I'm looking forward to hearing about your progress. Thanks again for your help.

Attached is a BETA application to do FOIA Submission Validation based upon the provided business rules. Please verify the application is processing the rules correctly and is what you are looking for. I tested the application against the attached spreadsheet (which I believe covers all the validation scenarios).

You will need to do the following:

- 1) Unzip the publish.zip file to your "Documents" folder
- 2) Double-click the "FOIAValidationApplication.application" under the "publish" folder
- 3) Accept the installation warning screen
- 4) Select the file to validate
- 5) Set start and end row (default is a start row of 4 which is the first row of data after the header and an end row of empty which will process the entire file)
- 6) Choose the output format (currently the MS Word format has some issues, so for now leave it as "Text"

The application will change the text of incorrect Excel cells to red (in the case of a missing entry the cell background is set to red). The application adds a new column (AB) which lists the issues for the row. The application also creates an output file in text or MSWord format (as previously denoted, the MSWord format has some issues).

When you test, please keep in mind that the validation rules will flag items such as '0' if it is valid entry (i.e. days), a 'space ' ' where a date should be, the string "NULL" where an automated output should be ". The system does not interpret incorrect input data.

Tracking Agency Progress to Implement the FOIA Guidelines

As a part of his 2009 FOIA Guidelines, Attorney General Holder directed the Chief FOIA Officers at each agency to review "all aspects of their agencies' FOIA administration" and to report annually to the Justice Department on the steps taken "improve FOIA operations and facilitate information disclosure." These "Chief FOIA Officer Reports" provide descriptions of the steps agencies have taken to improve FOIA administration and serve as a complement to the agencies' Annual FOIA Reports, which contain detailed statistics on the numbers of requests received and processed during the preceding fiscal year.

Last year, the Office of Information Policy (OIP) conducted an assessment of the progress made in FOIA administration by the fifteen executive departments. OIP identified metrics for assessment, such as improvements to efficiency and reduction in backlogs, and then used data from both agency Annual FOIA Reports and Chief FOIA Officer Reports to score the agencies on their progress in those areas.

For 2012, we have expanded the assessment to include all ninety-nine agencies subject to the FOIA in fiscal year 2011. We also have changed several of the metrics, taking into account the progress that has already been made in implementing the FOIA Guidelines to make the assessment progressively more challenging.

For 2012, we have also prepared a narrative to accompany the assessment. The narrative provides a wealth of examples from large and small agencies of the improvements that have been made to help improve the FOIA process. Lastly, OIP has included guidance to agencies to assist them in making additional improvements in the years ahead.

The 2012 assessment provides a "visual snapshot" of agency activities in five key areas, including:

- applying the presumption of openness,
- increasing efficiencies,
- making information available proactively,
- using technology, and
- reducing backlogs and improving timeliness.

The assessment is meant to "readily [illustrate] the many areas where agencies have made real progress and also serves to highlight the areas where further improvement can be made." Notably, our review found that:

Agencies continue to make concrete progress in implementing the President's FOIA Memorandum and the Attorney General's FOIA Guidelines. The 2012 assessment shows that agencies are applying the presumption of openness, are taking steps to ensure that they have effective systems in place for responding to requests, are increasing both the content on their websites and its usability, and are offering requesters the opportunity to submit requests electronically.

By assessing agencies on a wide variety of factors that all contribute to improving information disclosure, the public, as well as the agencies themselves, can readily see where agencies have excelled, and where further work can still be done, in improving the administration of the FOIA.
