Dear Mr. Greenewald:

On January 15, 2010, the Federal Communications Commission ("Commission" or "FCC") received your Freedom of Information Act ("FOIA") request, which we designated as FOIA Control No.: 2010-172.¹ In your correspondence, you requested "a copy of the FOIA case log for the calendar year 2009."² Enclosed is a copy of the Commission's FOIA log for calendar year 2009.

We are required by both the Freedom of Information Act and the Commission's own rules to charge requesters certain fees associated with the costs of searching for, reviewing, and duplicating the sought after information. See 5 U.S.C. § 552(a)(4)(A), 47 C.F.R. § 0.470. To calculate the appropriate fee, requesters are classified as one of: (1) commercial use requesters; (2) educational requesters, non-commercial scientific organizations, or representatives of the news media; or (3) all other requesters. 47 C.F.R. § 0.470. Under 47 C.F.R. § 0.470(a)(3), you have been classified for fee purposes as category (2), that is, "representative of the news media," and as such you must pay for duplication cost only, and will not be charged for duplication of the first 100 pages. The information that you requested totals 93 pages of material. Less than 100 pages are being provided to you, and therefore no fees will be charged for processing your request.
