Dear Mr. Greenewald:

This letter is a response to your Freedom of Information request for a copy of the 2009 FOIA log for the Defense Information Systems Agency.

There were twenty-seven pages responsive to your request. All information pertaining to privacy requests have been redacted pursuant to 5 U.S.C. § 552 b(6). Those numbers are: 09-04, 09-05, 09-09, 09-15, 09-26, 09-28, 09-31, 09-53, 09-58, 09-59, 09-73, 09-95, 09-96, 09-100, 09-105, 09-121 and 09-150.

Due to the national emergency declared by the President in the aftermath of the terrorist attacks of September 11, 2001, the Department of Defense (DoD) has reviewed its policy regarding the release of names and identifying information of personnel not assigned to units protected from release by statute (10 USC § 130b). As a result of this review, it has been determined that release of lists of names of personnel would constitute a clearly unwarranted invasion of the personal privacy of those individuals. Accordingly, the information you requested is exempt from release pursuant to 5 USC § 552 b(6).

Exemption 6 - Applies to information, which if released, could reasonably be expected to constitute a clearly unwarranted invasion of personal privacy of an individual.

You may appeal this partial denial by writing to the Director, Defense Information Systems Agency, 701 South Courthouse Road, Arlington, VA 22204, within 60 days of your receipt this letter. Both the letter and envelope should be clearly marked "Freedom of Information Act Appeal."
