From August 1955 to November 1955 I was a member of about 30 military and 3 civilians involved in performing a hearability test/site survey in northern Pakistan; i.e., Rawalpindi, Abbottabad, and Peshawar. The officers, civilians, and equipment came from Germany, picked up us operators and analysts at Wheelus AB, Tripoli, Libya and flew us via C-124 aircraft to Pakistan. We then convoyed within the countryside as we performed our task. I am wondering if there was ever a report of findings on this survey, and, if so, is it available to me. I am curious to see how the survey was reported; of course, we know that the Air Force established a station (6937th CG, now defunct) a few years later.
