Dear Mr. Greenwald:

This is a final response to your Freedom of Information Act (FOIA) request dated February 18, 2017 in which you seek access to Postal Service records. Specifically you requested:

Copy of records, electronic or otherwise, of the FOIA Case Log and FOIA Appeal Log for calendar years (fiscal year is ok, if that is the only available) 2010-2016

On June 28, 2017 a partial response was sent to you or the FOIA case log. Regarding the FOIA Appeal log, a search of our files disclosed 83 pages of record material responsive to your request for FOIA Appeal Case Log; we are releasing 9 pages in their entirety; however, some of the information on 74 pages are being withheld under FOIA Exemptions 6. Please find the information in the enclosed CD.

Exemption 6 permits withholding documents where release of personnel and similar files would constitute a clearly unwarranted invasion of personal privacy. Any records which contain information concerning particular individuals, may qualify for the exemption's protection. Therefore, records that relate to first-party requests or to requests for records about certain named individuals are "files" within the meaning of the exemption.

In determining whether to release records that may be protected by Exemption 6, the agency must balance the privacy interests of the individuals involved against the public interest, if any, that would be served by disclosure. We do not consider that there is a public interest in the disclosure of the withheld information sufficient to outweigh the privacy interests of the individuals involved. For the purposes of FOIA Exemption 6, the only public interest to be weighed is the extent to which disclosure would service the "core purpose" of the FOIA, which is to contribute significantly to public understanding of the operations or activities of the government, or, in other words, to shed light on the conduct of government agencies.

If you are not satisfied with the response to this request, you may file an administrative appeal within 90 days of the date of this response letter by writing to the General Counsel U.S. Postal Service 475 L'Enfant Plaza SW Washington, DC 20260 or via email at FOIAAppeal@usps.gov. Your appeal must be postmarked or electronically transmitted within 90 days of the date of the response to your request. The letter of appeal should include, as applicable:

- (1) A copy of the request, of any notification of denial or other action, and of any other related correspondence;
- (2) The FOIA tracking number assigned to the request;
- (3) A statement of the action, or failure to act, from which the appeal is taken;

- (4) A statement identifying the specific redactions to responsive records that the requester is challenging;
- (5) A statement of the relief sought; and
- (6) A statement of the reasons why the requester believes the action or failure to act is erroneous.
