- (b)(7): protects records or information complied for law enforecements purposes, the release of which would disclose techniques and procedures for law enforcement investigations or procedures.

## **FOIA Exemptions**

- (b)(2): protects from disclosure documents that are "related solely to the internal personnel rules and practices of an agency."
- (b)(3): exempts from disclosure records that are made confidential by statute.
- (b)(4): protects from disclosure "trade secrets and commercial or financial information obtained from a person that is privileged or confidential."
- (b)(5): allows for the withholding of inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency."
- (b)(6): protects from disclosure information about individuals, the release of which would constitute a clearly unwarranted invasion of personal privacy.
- (b)(7): protects records or information complied for law enforcements purposes, the release of which would disclose techniques and procedures for law enforcement investigations or procedures.
