

Your appeal must include a copy of the original request, the response to your request, and a statement of why the denial of the records was in error. Also, the appeal letter, the envelope, the email subject line, and the fax cover sheet should be clearly marked "**Freedom of Information Act Appeal.**"

The email, fax machine, and Office of the General Counsel mailbox are monitored **only** on working days during the normal business hours (7:30 a.m. to 3:30 p.m., Eastern Time, Monday through Friday). FOIA appeals posted to the email box, fax machine, or delivered to the Office of the General Counsel after business hours will be deemed received on the next normal business day.
