This our first interim release in response to your January 3, 2017, FOIA request for a copy of the U.S. Marine Corps' FOIA request log for calendar (CY) 2016. Your request was assigned file number **DON-USMC-2017-002270**.

We initiated a search of our files and identified 113 pages of records as responsive to your request. Due to the large volume of records and the detailed research involved in processing them, we will be releasing them to you on a rolling basis. The enclosed interim release includes pages 1 – 30 of the CY 2016 FOIA log. You will see that some portions have been redacted. Specifically, we routinely withhold third-party names and any information that may tend to identify personnel pursuant to FOIA exemptions (b)(6) and (b)(7)(C), which prohibit disclosure of personal information when an individual's privacy interest in it outweighs any public interest. Additionally, several requests were identified as first-party "Privacy Act" requests, which are not subject to disclosure under the Act and were also outside of the scope of your request.

Because some information has been removed from these records, you may consider this to be an adverse determination that may be appealed to the Judge Advocate General (Code 14), 1322 Patterson Avenue SE, Suite 3000, Washington Navy Yard, DC 20374-5066. Your appeal, if any, must be postmarked within 90 calendar days from the date of this letter and should include a copy of your initial request, a copy of this letter, and a statement indicating why you believe it should be granted. We recommend that your appeal and its envelope both bear the notation "Freedom of Information Act Appeal." Please be assured that you will still retain the right to appeal our final determination and, when we provide our final response, you will be afforded another 90 calendar days in which to appeal.


