This responds to your January 22 Freedom of Information Act (FOIA) request to the U.S. Postal Service Office of Inspector General (OIG) for a copy of the calendar year 2012 FOIA case log.

Enclosed is a copy of the 13 page OIG FOIA case log for calendar year 2012. I determined one page is appropriate for release without excision; copy enclosed. Also enclosed are 12 pages that are appropriate for release with excisions made pursuant to FOIA Exemptions (b)(5), (b)(6), and (b)(7)(C).

FOIA Exemption (b)(5), 5 U.S.C. § 552(b)(5), permits the withholding of inter or intra-agency memorandums or letters which reflect the predecisional, deliberative processes of the agency, and/or consist of attorney work product prepared in anticipation of litigation.

FOIA Exemption (b)(6), 5 U.S.C § 552(b)(6), which permits the withholding of information the release of which would constitute a clearly unwarranted invasion of the personal privacy of third parties. The withheld material includes names, titles, and identifying information of private citizens. This information is not appropriate for discretionary release.

FOIA Exemption (b)(7)(C), 5 U.S.C. § 552(b)(7)(C), which permits the withholding of records or information compiled for law enforcement purposes, the release of which could constitute an unwarranted invasion of the personal privacy of third parties.
