COLBY AND AMBASSADOR HELMS FROM CARY

1. THOUGHT YOU WOULD BE INTERESTED IN A RUNDOWN OF THAT PORTION OF SENATOR BAKER'S APPEARANCE ON "FACE THE NATION" TODAY THAT PERTAINED TO THE AGENCY. HIS GENERAL STATEMENT WAS: ... I GET THE FLAVOR OF AN ALLEGATION THAT'S MADE SOMETIMES THAT THIS INQUIRY INTO CIA IS TO DIVERT ATTENTION OR TO PLACE BLAME OTHER THAN ON THE WHITE HOUSE--IT IS NOT. AS A MATTER OF FACT, IN WEIGHING THE EQUITIES I THINK IT WOULD BE DIFFICULT FOR ONE TO SAY THAT YOU PROBABLY WOULDN'T FIND THAT THE CIA MAY HAVE BEEN DOING WHATEVER THE WHITE HOUSE TOLD THEM TO DO. AND THAT THERE MAY BE A CHAIN OF COMMAND THERE THAT WOULD BEAR FURTHER EXAMINATION. I'VE NEVER SUGGESTED AND I DON'T NOW SUGGEST THAT SEVEN DAYS IN MAY SCENARIO WHERE THE CIA or the military was trying to take over the country. I don't BELIEVE THAT AND I DON'T SUGGEST THAT. BUT I DO SAY THERE ARE ASPECTS OF THE INVOLVEMENT OF THE CIA POST-VATERGATE, POST JUNE 17, 1972, THAT REQUIRE FURTHER INQUIRY. NOW WHEN WE HAD AMBASSADOR HELMS BACK THAT WAS NOT THE POCUS OF OUR ATTENTION. FRANKLY, THE REASON HE WAS BACK WAS TO INCUIRE INTO THE TAPES. JUST AS WE FOUND A GENERAL TAPING CAPABILITY AT THE WHITE HOUSE THROUGH ALEX BUTTERFIELD, WE FOUND THAT THERE WAS A GENERAL TAPING CAPABILITY AT THE CIA--WHICH WE DISCOVERED SERENDIPITOUSLY. WE DID NOT KNOW TO AND WE STUMBERD INTO IT. THE QUESTION WAS PUT BY GEORGE MURPHY WER WAS ON LIGAN TO US FROM THE JOINT COMMITTEE ON ATOMIC ENERGY.
