Dear Mr. Greenwald:

Amtrak's Office of the Inspector General (OIG) received your December 27, 2014 request for information made under the Freedom of Information Act (FOIA) seeking a list of "all closed investigations by [the OIG] during calendar year 2016." In response, the OIG generated the enclosed printout from an existing database, redacting certain information.

The names of suspects or targets of investigation, and other individuals, whose names appear in the case title field, have been redacted and are being withheld pursuant to Exemption 7(C) which recognizes that law enforcement records are inherently more invasive of privacy than other types of personnel files. An individual whose name is disclosed in connection with an investigation may become the subject of rumor and innuendo. Named individuals have substantial interests in nondisclosure of their identities and connection to particular investigations.

You have the right to file an administrative appeal within 90 days of the date of this letter. By filing an appeal, you preserve your rights under FOIA and give the OIG a chance to review and reconsider your request and the decision. A copy of your initial request, a copy of this letter, and your statement of circumstances, reasons, and arguments should accompany your letter of appeal. Please address your letter of appeal to:
