Dear Mr. Greenwald:

This is in response to your December 27, 2016, Freedom of Information Act (FOIA) request for a list of closed investigations for the calendar year 2016. We received your request on the same date and assigned it case number DODOIG-2017-000185.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. 552(c) (2006 & Supp. IV 2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

The Defense Criminal Investigative Service, Department of Defense Hotline and the Office of the Deputy Inspector General for Administrative Investigations conducted a search and found documents responsive to your request. I determined that the redacted portions are exempt from release pursuant to 5 U.S.C. § 552 (b)(4), which pertains to commercial or financial information obtained from a person that is privileged or confidential, (b)(6), when the disclosure of such information would constitute a clearly unwarranted invasion of personal privacy, and (b)(7)(C), which protects personal information in law enforcement records.

Please note that we will be sending the documents to you via the secure system **Safe Access File Exchange (SAFE)** website that is maintained by the United States Army. You should receive notification from the email address: **No-Reply@amrdec.army.mil**, with the subject line: **AMRDEC Safe Access File Exchange Delivery Notice**. Please do not delete the email. This e-mail contains the download link and password for access that may only be used once. This access also has a time limit before the password expires. Follow the instructions provided in the email to download the responsive documents. If you do not receive an email from AMRDEC in your regular email **inbox**, within 30 minutes of receiving our email, please check your **spam** and/or **junk** folder. Additionally, if you are using an operating system other than Microsoft Windows, and a web browser other than Internet Explorer, you may have problems opening the document. If any of the above occurs, please contact us, and we can send via a different method.

In view of the above, you may consider this to be an adverse determination that may be appealed. Since you have created an account in FOIAonline, you may submit an appeal directly within the web-based system. To do this, you would log in to your account, retrieve your original request, and then click on the "Create Appeal" tab in the left-hand column. The basic information from your request will be duplicated for you, and then you can type in the basis of your appeal. If you prefer to use regular mail, you may submit an appeal to the Department of Defense, Office of Inspector General, ATTN: FOIA Appellate Authority, Suite 10B24, 4800 Mark Center Drive, Alexandria, VA 22350-1500. Your appeal, if any, must be postmarked within 90 days of the date of this letter and should reference the file number above. I recommend that your appeal and its envelope both bear the notation "Freedom of Information Act Appeal."

You may seek dispute resolution services and assistance with your request from the DoD OIG FOIA Public Liaison Officer at 703-604-9785, or the Office of Government Information Services (OGIS) at 877-684-6448, ogis@nara.gov, or <https://ogis.archives.gov/>. Please note that OGIS mediates disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to litigation. However, OGIS does not have the authority to mediate requests made under the Privacy Act of 1974 (request to access one's own records.)
