The OIG received your request on June 24, 2016 from GAO's program office that received your access request and is responsible for processing requests for GAO records. In order to preserve the independence of GAO's Inspector General, the OIG, not GAO's program office, processes access requests seeking OIG documents. Accordingly, I am responding to your request directly (rather than submitting responsive OIG documents to the GAO program office that forwarded your June 24th request to me). Pursuant to 4 C.F.R. 81.4(a), we sent an acknowledgement of your access request on July 13, 2016.

We have processed your request under the procedures set forth in 4 C.F.R. Part 81, Public Availability of Government Accountability Office Records.
