This is the final response to your May 24, 2018 Freedom of Information Act (FOIA) request to the National Security Agency (NSA), a copy of which is enclosed for your convenience. Your request was received on March 13, 2019 and assigned FOIA case number 19-F-0676. We ask that you use this number when referring to your request.

The National Security Agency (NSA), conducted a search of their record systems and located six pages determined to be responsive to your request. Mr. John R. Chapman, an Initial Denial Authority for NSA, determined that some of the information is exempt from release pursuant to FOIA exemption (b)(3), specifically Section 6, Public Law 86-36 (50 U.S.C. 3605), to protect the names of non-NSA affiliates.

Any person denied access to information may file an appeal to the NSA/CSS Freedom of Information Act Appeal Authority. The appeal must be postmarked no later than 90 calendar days after the date of the initial denial. Decisions appealed after the 90 days will not be addressed. The appeal request shall be in writing to the NSA/CSS FOIA Appeal Authority (P132), National Security Agency, 9800 Savage Road Suite 6932, Ft. George G. Meade, MD, 20755-6932. Requests may also be submitted via facsimile at 443-479-3612 or email at FOIARSC@nsa.gov. The appeal shall reference the initial denial of access and shall contain, in sufficient detail and particularity, the grounds under which the requester believes release of information is required. The NSA/CSS FOIA Appeal Authority will endeavor to respond to the appeal within 20 working days after receipt, absent unusual circumstances.
