1. ON 27 MAR, AMT<sup>1</sup>AUP-2 HELD CONVERSATION WITH CARLOS (ZARRAGA) MARTINEZ, JURE CHIEF SUPPORT, AND SERGIO SANCHEZ, CHIEF ENGINEER JURE BOAT VENUS. ZARRAGA SAID AMBANG<sup>2</sup>-1 PLANS FORM SEVERAL GUERRILLA BANDS, NINE MEN EACH, WHEN A<sup>2</sup>-1 ENTERS CUSA. A<sup>2</sup>-1 WILL DIRECT FIGHT AGAINST CASTRO FROM SAFE HOUSES ALREADY PREPARED FOR HIM IN HAVA.

2. ZARRAGA ALSO SAID JURE NATIONAL EXECUTIVE SOON WILL CALL MEETING DISCUSS DENUNCIATION AGAINST ROGELIO (CISNEROS) DIAZ WHO ACCUSED EXERCISING ABSOLUTE CONTROL JURE. ZARRAGA, SANCHEZ, ARMANDO (ALANIS) ANGULO, ERNESTO (ALANIS) ANGULO, HIGINIO (DIAZ) ANE, DUNNEY (PEREZ) ALAMO AND OSORIO (DAVILA) SANTANA, BRINGING ACCUSATIONS AGAINST CISNEROS.
