SWIRL-1 RECEIVED THE FOLLOWING INFORMATION FROM JUAN ESPINOSA.

ON 10 JUNE 64. PROTECT SOURCE.

1. EDEL (MONTIEL), SANTIAGO (RIOS) AND VICENTE (LNU), MEMBER OF JURE AND REPORTED TO HAVE SEEN THE ADVANCE GROUP INTO CUBA FOR MANUEL (RAY), RECEIVING SPECIAL TRAINING AT A RANCH IN PUERTO RICO FOR THE PAST TWO OR THREE MONTHS. THE THREE HAVE NOW LEFT THE SPECIAL TRAINING SITE, AND WERE STAYING IN THE GARAGE OF MANUEL (RAY'S) HOUSE IN SAN JUAN, PUERTO RICO.

2. SUBJECT WAS TOLD BY RAMON (CUBENAS) THAT IN NOV OR DEC OF 63 A 110-FOOT VESSEL BELONGING TO JURE (NAME UNKNOWN) OPERATING OUT OF SAN JUAN, PUERTO RICO MADE A TRIP TO CARACAS, VENEZUELA, WHERE IT PICKED UP APPROX 753 FAL RIFLES AND RETURNED TO SAN JUAN. SOME OF THESE RIFLES ARE NOW BEING SMUGGLED INTO THE U.S. BUT
