1. TERESITA GONZALEZ DID NOT ASSUME THAT SHE COULD CONTACT GORDON M. BINIARIS THROUGH THE MUTUAL LOCAL PAYMENT OFFICE BUT MADE THE ATTEMPT BECAUSE SHE WISHED TO PASS INFORMATION THAT SHE HAD RECENTLY LEARNED ABOUT HER HUSBAND. SHE HAD NO MEANS OF REACHING BINIARIS AND AFTER TRYING SEVERAL OTHER POSSIBILITIES INCLUDING THE PHONE COMPANY, SHE INCLUDED A NOTE WITH HER PAYMENT RECEIPT IN THE HOPE THAT IT WOULD REACH BINIARIS.
2. BINIARIS WAS HER HUSBAND'S HANDLER IN CUBA AND SHE WAS WITTING OF THE OPERATIONAL RELATIONSHIP. SUBSEQUENTLY, BINIARIS MADE THE LOCAL AMSPECIAL PAYMENTS TO HER BEFORE THE MHMUTUAL SYSTEM WAS STARTED.
3. FYI: AT LEAST SOME AMSPECIAL RECIPIENTS ASSUME SOME SORT OF WOFIRM RELATIONSHIP WITH MHMUTUAL. A FEW RECIPIENTS WHO DID NOT RECEIVE TIMELY PAYMENTS HAVE CONTACTED AMOTS THEY KNOW TO HAVE WOFIRM CONNECTIONS TO SEEK RESOLUTION OF THEIR PROBLEM.
