"On Sunday, November 24, 1963, CLARA FRASER said she had sent into both the Seattle papers a statement regarding the Fair Play for Cuba Committee (FPCC) in its accused connection with the assassination of the President. She said that the P.I. printed her full release on page 2, and the Times printer parts on an inside page. She said the Times headed the article 'Committee Doesn't Condone Violence'.
