1. Michael Henry Beaumont EDDOWES is known to you as the British solicitor involved in the celebrated PROFUMO/KEELER/IVANOV scandal of 1963. EDDOWES was interviewed more than once by your New York field office in that year. It appears that EDDOWES is currently researching a book on the assassination of the late President Kennedy. He is being assisted in this task by James Michael MARLER, a private investigator who accompanied EDDOWES on his visit to the United States in June 1963 and who was also interviewed by your New York field office during that visit. *ENG.*

2. I am enclosing a copy of a report from a reliable source which indicates the nature and extent of EDDOWES' researches and the line he intends taking in the book.
