SA THOMAS J. RYAN made the pretext telephone call to DE 2-6155 on 3/10/64. The pretext used was that of a friend of the subject.

PERCY ELLIS SUTTON, Attorney, is the subject of NY file 100-113507 and is affiliated with the National Association for the Advancement of Colored People in the NYC area. This file does not reflect any information concerning subversive activities on behalf of SUTTON and his name is neither included on the SI or the RI.

On 6/4/63, NY 2353-S* advised that one VICKIE (LNU), not further identified, was one of several individuals making arrangements for a picket line at 30 Church Street, NYC, on 6/7/63 to protest hearings being conducted by the Subversive Activities Control Board. These individuals made arrangements for the manufacture of several witches costumes to be worn on the picket line.

On 6/5/63, NY 2353-S* advised that the date of the picket line had been changed from 6/7/63 to 6/10/63.

In view of the absence of identifying information, the above information was not included in attached report.

This case has been placed in a closed status as subject's appeal from her 8/28/63 conviction is still pending and will not be determined at this term of court. This case will be reopened in September for verification of residence and employment and at that time the Criminal Court Docket will be reviewed to determine the status of subject's appeal.
