"The meeting was called to order by EDDIE GIVENS at apprx. 4:30. The first item to be discussed was the Death of President KENNEDY. Various opinions were voiced on the matter but the only one outstanding was by TOM WARNER whose opinion of KENNEDY was contrary to all others in that he thought that KENNEDY was not a particularly good president
