Date of Report: 12/10/63

*On 12/10/63, BOB SIMMER visited VERA and FLORENCE HENRIE. VERA and FLORENCE engaged BOB in conversation regarding the assassination of President KENNEDY and told him that they thought that he had been killed due to a plot by the right. BOB said that he thought that it had happened pretty much the way it had been reported in the papers. They said that one could never take the word of the papers, the FBI, or of the Dallas police. BOB said that they should try to be realistic when talking among themselves. VERA then agreed with BOB that the answer to the killings probably never would be known. He said that the FBI was continually chasing communists and the workers and that the communists should use the same weapons, that it would be good propaganda
