NY THREE NINE ZERO THREE DASH ⁷ ADVISED THIS DATE SHE APPEARED AT CPUSA HEADQUARTERS THIS DATE, AT APPROXIMATELY TEN AM. AT THAT TIME SHE WAS IN CONVERSATION WITH JACK STACHEL AND PHIL BART WHO ADVISED HER THAT SHE SHOULD HAVE BEEN CALLED EARLIER TO THE EFFECT THAT NO BUSINESS WOULD BE TRANSACTED AT THE OFFICE THIS DATE AND THAT THE OFFICE WOULD BE CLOSED. INFORMANT TOLD STACHEL THAT SINCE SHE WAS PRESENT, SHE WOULD BE AVAILABLE FOR ANY ASSIGNMENT NEEDED. SHE WAS ADVISED THAT SHE WOULD NOT BE NEEDED. INFORMANT THEN INQUIRED AS TO THE WHEREABOUTS OF GUS HALL AS SHE HAD NUMEROUS THINGS TO TALK TO HIM ABOUT. STACHEL TOLD HER TO FORGET ABOUT SEEING HALL AS HALL WAS COMPLETELY TIED UP IN VIEW OF THE RECENT EVENTS SURROUNDING PRESIDENT KENNEDY'S ASSASSINATION. INFORMANT SHORTLY THEREAFTER LEFT PARTY HEADQUARTERS.
