DALLAS, TEXAS

On 11/23/63 spot check observation by SA RUFUS H. POWELL revealed automobiles that are listed to PETER GUMPERT and NICHOLAS BATESON, both at BATESON's residence, 118 Longview St., Chapel Hill, N. C.

Telephonic contact to residence MALCOLM PHELPS, Roxboro, N. C., to determine whereabouts of LARRY PHELPS developed that MALCOLM is hunting and unavailable for contact today. MALCOLM PHELPS as a source should be protected.

Attempts to locate NATALIE HARBIN, 213 W. Franklin St., Chapel Hill, N. C., confidential neighborhood source on JOHN SALTER and DOROTHY DENTON, were unsuccessful. Pretext call to SALTER telephone failed to bring an answer. Sources available to Chapel Hill PD contacted and advised neither DENTON or SALTER had been observed in Chapel Hill for about one week.

CE 1883-S advised that KENNETH 3X, NOI, and other members of NOI present at NOI meeting last Sunday and no indication given anyone planned to leave town. He expects to determine the attitude of this group concerning President's assassination on meeting of 11/24/63 and will advise.

CE 1768-S has no pertinent information indicating any racial extremists has connection with Dallas, Texas, assassination.

The following investigation was conducted by SA CHARLES S. MILLER:

On 11/23/63 CONRAD O. PEARSON, Council for NAACP, Durham, N. C., advised no information had come to his attention indicating any agitation among racial extremists as the result of death of President. PEARSON noted Attorney
