Re New York airtel to Bureau, 9/15/61, Bulet to Miami, 9/11/61, and New York airtel to Bureau, 9/7/61, captioned, "VENEZUELAN REVOLUTIONARY ACTIVITIES IN THE UNITED STATES; IS - VENEZUELA", Bufile 105-101555.

As indicated in referenced New York airtels, FRANK NELSON, 240 Central Park South, New York City, on 9/7/61, advised that LOUIS MARTINEZ is presently staying with a friend "on the Beach" at Miami, and is in the process of selling a freighter to certain unidentified Venezuelan individuals. It is reported that NELSON was reluctant to furnish additional information regarding LOUIS MARTINEZ. He stated he would telephone his friend, who is also in Miami, but whose name was not known, who is in contact with MARTINEZ, and have MARTINEZ appear at the Miami Office for interview.

It was indicated further that the New York Office would maintain contact with FRANK NELSON in the event that investigation in Miami regarding LOUIS MARTINEZ was negative.

On 10/9/61, ^(C)MM [717]-S, as well as ^(C)MM [729]-S, ^(X) exiled Venezuelans who are acquainted with the activities of exiled Venezuelans residing in the Miami area, advised they were not acquainted with LOUIS MARTINEZ, and possessed no information that any Venezuelans in the Miami area were endeavoring to purchase a ship.

A review of Miami Office indices failed to reflect an identifiable reference to LOUIS MARTINEZ, which would indicate he has endeavored to contact the Miami Office. The Miami Office indices contained information concerning LOUIS MARTINEZ, already in the possession of the New York Office, the Washington Field Office and the Cleveland Office.

On 10/9/61, IC CLIFFORD M. WERNER contacted the following sources of the Miami Office, and records of these sources failed to reflect an identifiable reference to the subject:
