Re Dallas letter July 20, 1957. Inquiries conducted by Dallas do not explain the correspondence between Glover and Nestor nor the nature of any relationship between these two individuals. San Francisco should be alert to any additional contacts of Nestor and Glover. In addition, San Francisco should consider having additional investigation conducted of Glover or an interview of him at an appropriate time depending on the developments in this case and in the Pancase.
