MM 492-S advised on 9/16/63 that he had no information re captioned group other than what he read in newspapers.

Since activities apparently centered in Miami, it is suggested Bureau designate Miami as office of origin.

Review 9/12

Miami suggests that, as this operation appears to be in the initial stages of formation and may be a fund raising attempt rather than a legitimate effort to assist the anti-CASTRO movement, the activities and developments be followed through informants, including MM 639-S, until such time as the nature of its objectives have been determined.
