Subject denied knowing any jewel thieves or fences in the United States. He concluded the interview by emphatically denying that he had any knowledge of stolen jewelry in the United States, and that he would furnish any such information to the FBI, should same come to his attention.

Pertinent information obtained from subject's associates is set forth in the details of this report. No information was developed to substantiate the original allegation received from MM 676-PC, and the case was closed on July 1, 1959.

It should be noted that contained in this report is an FD-302 reflecting interview of Mr. VINCENT D'AMATO re subject's activities, as well as those of "Cuba Libre." This interview is contained in this report, and also appears in the report under the caption of "CUBA LIBRE" (Post Office Box 2235, Miami 1, Florida, RA-CUBA." (Miami file 97-309.
