LABARTA is a Cuban national, an industrial engineer presently employed by the Fiberglass Corporation in Philadelphia, Pennsylvania. LABARTA resides at 38 Beachfern Lane, Levittown, New Jersey. (u)

WFO indices contain no derogatory information concerning LABARTA but reflect that he formerly was a representative in Havana, Cuba, of Aircar Engineering, Incorporated, a Washington, D.C., firm.

For the information of the Miami Office, instant organization is identical with the one described in Miami airtel to Bureau dated 4/21/62 and entitled, "Movimento Revolucionario Del Pueblo (MRP), IS-CUBA," Miami file 105-3107.
